## Judge orders Justice Department to verify its filings in Flynn case

The federal judge presiding over the criminal case against former national security adviser Michael Flynn has ordered the Justice Department to conduct an unusual review of its filings in the case and certify by Monday whether any have been manipulated.

The order is a signal of intense distrust between the judge, Emmet Sullivan, and the department, whose filings are typically accepted at face value. In this case, DOJ [has already acknowledged](#) that two documents it previously filed — handwritten notes taken by former FBI counterintelligence agent Peter Strzok and former FBI Deputy Director Andrew McCabe — were altered "inadvertently" to include inaccurate dates.

Sullivan's demand will force the Justice Department to confront tricky interpretations of handwritten notes that DOJ and Flynn's legal team have relied on to seek the dismissal of the prosecution.

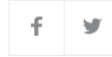
Flynn pleaded guilty in December 2017 to making false statements about his interactions with Russia's then-ambassador to the United States in the weeks before President Donald Trump's inauguration. Flynn encouraged the Russian envoy, Sergey Kislyak, to resist escalating a sanctions battle with the outgoing Obama administration, which sought to punish Russia for interfering in the 2016 election. But Flynn told FBI agents in a Jan. 24, 2017 interview — as well as other Trump administration officials — that sanctions were not raised on the calls.

## Pennsylvania can not reject mail-in ballots due to signature discrepancy -state court

(Reuters) - Pennsylvania's Supreme Court ruled on Friday that mail-in ballots cannot be refused because a voter's signature does not appear to match the one on file, a decision that could help Democratic presidential candidate Joe Biden.

Pennsylvania is a battleground state whose 20 Electoral College votes are key to victory for both Republican President Donald Trump and Biden.

“(We) hold that county boards of elections are prohibited from rejecting absentee or mail-in ballots based on signature comparison conducted by county election officials or employees, or as the result of third-party challenges based on signature analysis and comparisons,” Pennsylvania’s top court ruled.

Democrats hailed the move while Republicans were critical.

“What if there’s no signature at all? Or someone just draws a line? Sounds pretty stupid,” the digital director for Trump’s 2020 campaign, Gary Coby, wrote on Twitter.

Many states have expanded early voting and the use of mail-in ballots ahead of the Nov. 3 election, as some Americans try to avoid crowded polls during the coronavirus pandemic.

# Trump campaign sets online fundraising record, plans 'heavy' ad buy in Minn.

President Trump's campaign had its best-ever online fundraising day and plans to invest heavily on the airwaves in Minnesota in the closing days before the election.

Trump campaign manager Bill Stepien said the online haul on Thursday, when Trump and Democratic nominee Joe Biden squared off for the final presidential debate, was better than any online fundraising day in the 2016 or 2020 presidential cycles.

The campaign said it raised \$26 million in the hours around the presidential debate, pulling in 30 percent more digitally than in any prior 24-hour period and "reactivating" 20 percent more of its past donors than in any previous debate.

The campaign said October is already its largest online fundraising month ever.

The Trump campaign faces a massive cash deficit against Biden with just more than a week to go before Nov. 3. Biden's campaign entered October with a cash-on-hand advantage of \$114 million, a stunning reversal of fortunes after the Trump campaign entered the year with \$90 million more in the bank.

The Trump campaign says it will plow some of its new resources into a large ad buy in Minnesota, which has not gone for the Republican presidential nominee since 1972.

"The new buy is going to be a heavy buy. I emphasize heavy," Stepien said. "You won't be able to turn on the TV without seeing a Trump ad."

# Italy vetoes 5G deal between Fastweb and China's Huawei: sources

ROME (Reuters) - Italy has prevented telecoms group Fastweb from signing a deal for Huawei [HWT.UL] to supply equipment for its 5G core network, three sources close to the matter said, the clearest sign yet Rome is adopting a tougher stance against the Chinese group.

The decision, made at a cabinet meeting late on Thursday, marks the first time Italy has vetoed a supply deal over 5G core networks with Huawei.

Visiting Italy in September, U.S. Secretary of State Mike Pompeo described Chinese mobile telecoms technology as a threat to Italy's national security.

Huawei strongly rejects the charges, and its Italian unit said it was ready to undergo any scrutiny to show that its technology was safe.

However at Thursday's meeting, the government used its special vetting powers to block Fastweb, the Italian unit of Swisscom, from implementing a supply deal with the firm in the most sensitive part of its fifth generation mobile network, the sources said.

"The government has vetoed the operation, asking Fastweb to diversify its suppliers," a senior government source told Reuters.

Fastweb had picked Huawei as the sole supplier for its 5G core network, sources said. Huawei and Fastweb both declined to comment.

## U.S. housing market heats up ahead of election

(Reuters) - The housing market has been one of the few bright spots since the coronavirus pandemic slammed the U.S. economy, a boom that at a glance would appear to be aiding the financial wellbeing of American homeowners and ought to offer a tailwind to President Donald Trump heading into the homestretch of the election.

The National Association of Realtors this week reported U.S. existing home sales surged in September to levels not seen in more than 14 years. With so much of Americans' wealth tied up in the home they live in, that offers a welcome financial buffer in a decidedly uncertain economic moment.

It has also been a boon for builders, who are as confident as they've ever been, the National Association of Home Builders reported this week, as they rush to meet the demands of a severely under-supplied housing market. Indeed, single-family housing starts are proceeding at the fastest clip in 13 years.

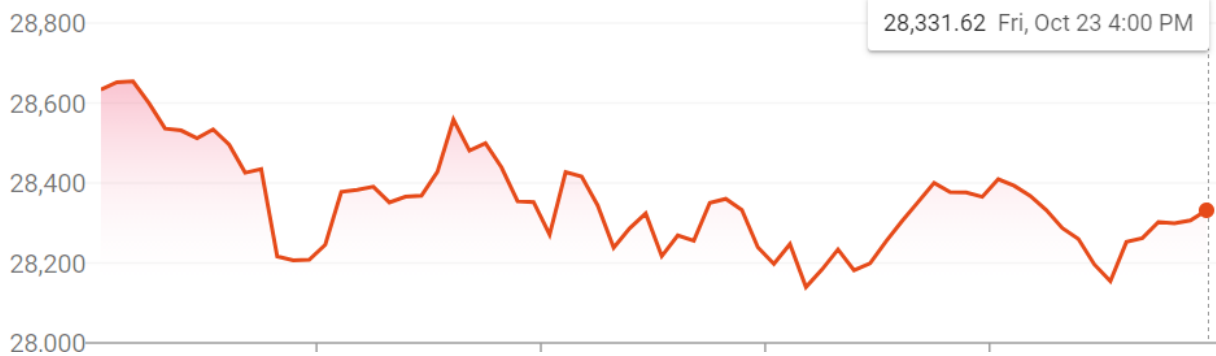
