Minnesota Lawmakers File Lawsuit to Stop Certification of Election Results

Lawmakers in [Minnesota](#) on Monday [filed a lawsuit](#) to halt the certification of [election](#) results, alleging wrongdoing by Secretary of State Steve Simon.

Simon, a Democrat, “illegally altered Minnesota’s election laws,” state Republican Reps. Steve Drazkowski, Tim Miller, and Jeremy Munson said in a joint statement.

“His office issued unlawful consent decrees that greatly affected the rules that govern absentee ballots and who can assist people at the polls. To circumvent the Minnesota Legislature and unilaterally change election law is entirely unconstitutional. This abuse of power must be addressed,” they added.

The lawmakers are part of the New House Republican Caucus.

Jose Jimenez, co-founder of the MN Election Integrity Team, joined in the filing of the suit with the Minnesota Supreme Court, requesting a temporary restraining order be issued to stop the certification.

Jimenez said in a statement obtained by The Epoch Times that his team found that Dominion Voting Systems were used in at least 6 of 87 counties. They also determined that “many irregularities were witnessed at the polls and with the management of Absentee ballots by the Secretary of State at various county locations.”

Attached to the lawsuit were six affidavits from ballot-counting observers who said they witnessed irregularities.

Kathleen Hagen, one of the observers, said Denise Anderson, the director of elections for Rice County, told her that signatures were no longer required by orders from Simon. Anderson refused to answer further questions. Another, Nora Felton, said she saw in Dakota County a woman pulling a large pile of ballots from her purse.

County spokespersons didn’t respond to requests for comment.

Group Files Emergency Petition in Wisconsin After Identifying 150,000 Potentially Fraudulent Ballots

A group on Tuesday filed an emergency petition with the [Wisconsin Supreme Court](#), challenging the state's unofficial [election](#) results.

The Thomas More Society's Amistad Project said it found tens of thousands of [ballots](#) that may be fraudulent.

"We have identified over 150,000 potentially fraudulent ballots in Wisconsin, more than enough to call into question the validity of the state's reported election results," said Phill Kline, director of the project, in a statement.

"Moreover, these discrepancies were a direct result of Wisconsin election officials' willful violation of state law," he added.

According to unofficial results in the state, Democratic presidential nominee Joe Biden beat President Donald Trump by about 20,000 votes.

The group said it found that more than 10,000 Republican ballots weren't counted; more than 10,000 GOP voters who had their ballots requested and filled in by another person; and around 100,000 illegal ballots that were counted anyway.

The [45-page filing](#) asks the Wisconsin Supreme Court to block the certification of election results because of the alleged irregularities.

The Wisconsin Elections Commission didn't respond to a request for comment.

Subpoena in Georgia Election Lawsuit Seeks Video Footage From State Farm Arena

The plaintiff in an [election lawsuit](#) in [Georgia](#) on Monday served a [subpoena](#) on State Farm Arena seeking video footage filmed on the premises during and after Election Day.

The [subpoena](#) names the Atlanta Hawks, State Farm Arena, and Scott Wilkinson, the executive vice president and chief legal officer of both entities. Wilkinson did not respond to a message left on his voicemail.

The subpoena seeks all recordings taken between midnight Nov. 3 and midnight Nov. 5. The request specifically calls for recordings taken in and around “Room 604,” all elevators that provide access to the floor where that room is located, and all loading docks in the arena.

The plaintiff in the lawsuit, attorney Lin Wood, sent a [public Twitter message](#) on Nov. 23 to the defendant, Georgia Secretary of State Brad Raffensperger, citing the subpoena.

“Would someone ask my never-to-be friend Brad Raffensperger @GaSecofState if he has seen this tape of election fraud at State Farm Arena,” Wood wrote. “Several people have seen it. Many more will see it soon. Video camera eye does not lie. How do you spell Election Fraud?”

Wood did not respond to an emailed request for more details.

Raffensperger’s office did not respond to an email seeking comment.

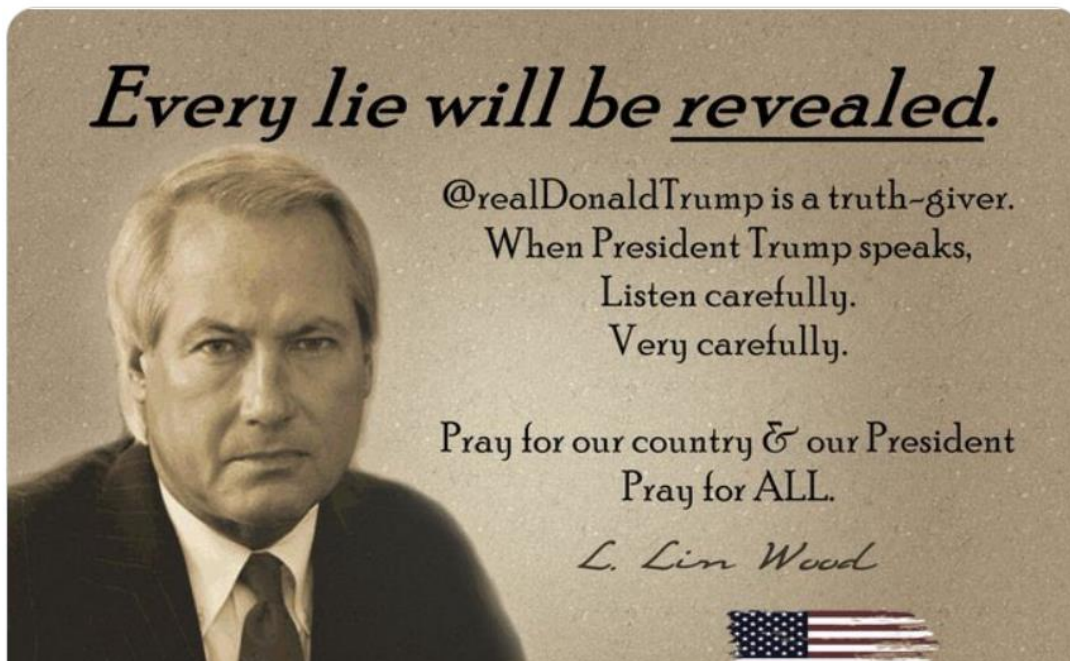

Michigan Supreme Court Urges Lower Court to Quickly Assess Claims of Election Fraud

Two [Michigan Supreme Court](#) Justices urged a lower court to move quickly and “meaningfully assess” allegations of voter fraud, according to a Monday order that also denied an appeal by two Wayne County voters who sought to halt certification so that an audit could be carried out.

While the state’s highest court ruled to deny the appeal and disagreed with the lawsuit’s premise that an audit should take place before certification, it acknowledged in an order ([pdf](#)) the presence of “troubling and serious allegations of fraud and irregularities.” It also noted that the plaintiffs presented evidence to substantiate their allegations, including in support of claims that ballots were counted from voters whose names were not on poll books and that instructions were given by elections officials to “disobey election laws and regulations.”

The above claims were initially laid out in a lawsuit filed on Nov. 8 by Republican poll watchers, Cheryl Costantino and Edward McCall, against Detroit and Wayne County officials. Their complaint ([pdf](#)) claimed election workers counted ballots from voters not listed on the qualified voter file and that, when a voter's name could not be confirmed, random names were picked from the list. They also alleged election workers removed Republican vote challengers from Detroit's TCF Center when they raised objections and that poll workers were told by election officials to not verify signatures on absentee ballots and to process them even if they were invalid.

That lawsuit was rejected by a state judge, prompting them to appeal to the Michigan Court of Appeals, which denied the appeal. Costantino and McCall then filed an appeal with the Michigan Supreme Court on Nov. 17, seeking an audit of election results.

While denying Costantino and McCall's calls to halt the audit, the Michigan Supreme Court said its decision does not preclude plaintiffs from seeking a future "results audit" and that the high court would retain its appellate and superintending authority over the case to allow the case to be expedited ahead of the tight deadline for Michigan to certify electors.

"Federal law imposes tight time restrictions on Michigan's certification of our electors," the judges wrote. "Plaintiffs should not have to file appeals following our standards processes and procedures to obtain a final answer from this Court on such weighty issues."

On Monday, the Michigan State Board of Canvassers voted to certify the election results.

Pennsylvania Certifies Result of Nov. 3 Election, Governor Announces

Pennsylvania's Department of State on Tuesday certified the results of the Nov. 3 election, according to Democratic Gov. [Tom Wolf](#).

"As required by federal law, I've signed the Certificate of Ascertainment for the slate of electors for [Joe Biden](#) and Kamala Harris," he wrote in a [statement](#). "Again, I want to thank the election officials who have administered a fair and free election during an incredibly challenging time in our commonwealth and country's history."

The Epoch Times has not called the race for Democratic presidential candidate Biden and vice-presidential candidate Harris pending the outcome of ongoing legal challenges. The Electoral College will vote in December to decide the outcome of the race, and then, the votes are counted during the Jan. 6 Joint Session of Congress in Washington.

President Donald Trump's campaign has not responded to a request for comment after Wolf's announcement.

The Trump legal team is still working on lawsuits in Pennsylvania. After Pennsylvania Judge Matthew Brann, an Obama appointee, tossed their case, the U.S. Third Court of Appeals [said Monday](#) that the team's "motion for emergency expedited review is granted at the direction of the court."

One of the president's lawyers, Jenna Ellis, said in a [statement](#) on Monday evening that "certification by state officials is simply a procedural step." It came after Michigan's Board of Canvassers voted to certify the election, and days after Georgia Gov. Brian Kemp and Secretary of State Brad Raffensberger announced the state's results were certified.

Current legal challenges in Pennsylvania:

Pennsylvania

The Trump campaign and Republicans have nine active lawsuits in the Keystone State, more than all the other states combined. The campaign's flagship case in the commonwealth—Trump v. Boockvar—was dismissed by a federal judge on Nov. 21 and the campaign swiftly appealed to the 3rd Circuit Court of Appeals. Giuliani said in a statement that the prompt dismissal helped speed the case along to the Supreme Court.

Days earlier, Republicans asked the Supreme Court to review another lawsuit, Bognet v. Boockvar. The 3rd Circuit on Nov. 13 sided with the defendants in that case in an opinion that forced the Trump campaign to significantly revise its original complaint in Trump v. Boockvar, narrowing the number of counts to two from seven and later acknowledging that only one of the two remaining counts was included for the purposes of subsequent appeal.

A new lawsuit filed by a Republican lawmaker and several GOP congressional candidates over the weekend, Kelly v. Pennsylvania, seeks to either block the certification of election results or to exclude mail ballots from the count. The plaintiffs allege that Pennsylvania's vote-by-mail statute violates the commonwealth's constitution.

In a handful of other cases, Republicans are challenging small batches of votes. On Nov. 23, the Pennsylvania Supreme Court dismissed six such appeals—five from the Trump campaign and one from a Republican candidate, which challenged a total of **10,684** mail and absentee ballots due to the voters failing to write in their name, address, date or a combination of the three on the outer ballot envelopes. Earlier the same day, a judge in Westmoreland County ruled in favor of a Republican and ordered the county's Board of Elections to not count 213 provisional ballots.

Nevada Supreme Court Approves State's Canvass of 2020 Election Results

The [Nevada](#) Supreme Court approved the state's canvass of the 2020 general election during a virtual meeting on Tuesday.

The seven-judge panel [voted to sign and certify](#) the results, which would be sent to Democratic Gov. Steve Sisolak for confirmation. The move delegates Democratic presidential candidate Joe Biden as the winner of the western U.S. battleground state, despite several ongoing lawsuits challenging the outcome of the election.

Election officials [in the state have declared](#) that Biden had won the state by 33,596 votes following the canvass in the state's 17 counties.

The Epoch Times has not called the race for Biden and vice-presidential candidate Sen. Kamala Harris pending the outcome of ongoing legal challenges. The Electoral College will vote in December to decide the outcome of the race, and then, the votes are counted during the Jan. 6 Joint Session of Congress in Washington.

There are four active cases in the Silver State brought by state Republicans. One of the challenges is a Trump campaign-backed election contest, cited as *Law v. Whitmer*, brought by electors for Trump against the electors for Biden. The [lawsuit](#) alleges widespread voter fraud, including a claim that [15,000](#) people who voted in Nevada also voted in other states.

Meanwhile, the other three lawsuits are brought by Republican candidates for office. Two of those candidates are challenging the use of ballot machines.

The Trump campaign did not immediately respond to a request for comment from The Epoch Times over the Nevada Supreme Court's vote.

Nevada Secretary of State Barbara Cegavske presented the results to the court during Tuesday's meeting, which were held simultaneously in two locations. In a statement following the meeting, Cegavske said "I'd like to thank Nevada's election officials for their dedication to providing a transparent and fair election."

The Donald J.
