

Q May 20, 2022



This update covers the messages posted by @q account on Truth Social. I can't say with certainty that this is the same person or group that posted on 4chan, 8chan and 8kun, but there is evidence to suggest that it is.

On May 13th, @q retruthed a post by Maria Bartiromo who linked to a Tweet by Elon Musk.



Musk tweeted about his decision to pause his purchase of Twitter over concern that the company may have incorrectly report the number of spam and fake accounts on the platform.

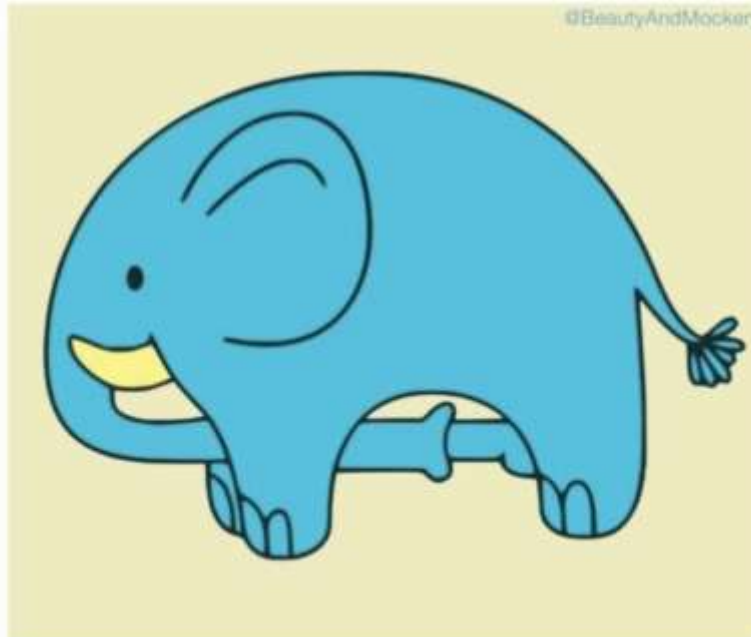

Almost half of President Biden's Twitter followers are FAKE, audit reveals as Elon Musk puts deal to buy Big Tech giant on hold over bots

- Just over 49% of Twitter followers of the official @POTUS account are fake
- The same analysis found that more than 14 million accounts who follow Biden's personal @JoeBiden handle are also either fake or insufficiently active
- An audit of ex-President Donald Trump's archived presidential account, @POTUS45, shows that 42.4 percent of his followers are fake
- It comes as Elon Musk took shots at Biden and Twitter at a Miami conference
- The Tesla billionaire accused Twitter's CEO of lying about the company's claim that less than 5% of its more than 200 million accounts are fake
- He also said he would be voting for a Republican president in 2024, not Biden
- Late last month Musk agreed to buy Twitter for a staggering \$44 billion

Nearly half of President **Joe Biden's** 22.3 million **Twitter** followers are fake, a new analysis revealed on Wednesday.

The report comes as **Tesla** founder **Elon Musk** pumped the breaks on his \$44 billion purchase of the social media platform over concerns about the amount of bots active on the site.

Inauthentic Twitter accounts, known colloquially as bots, operate to mimic human interaction on the platform in order to achieve a specific goal.

Some were designed to give people immediate data on things like the stock market and traffic updates, while others were used for more sinister applications such as spreading misinformation online or scamming people out of money.

Roughly 11 million followers of the US president's official Twitter handle, @POTUS, are either bots or inactive accounts, according to an analysis by Spark Toro.

That's 49.3 percent of Biden's total followers on his White House account.

Spark Toro's metric takes into account 'accounts that are unreachable and will not see the account's tweets (either because they're spam, bots, propaganda, etc. or because they're no longer active on Twitter).'

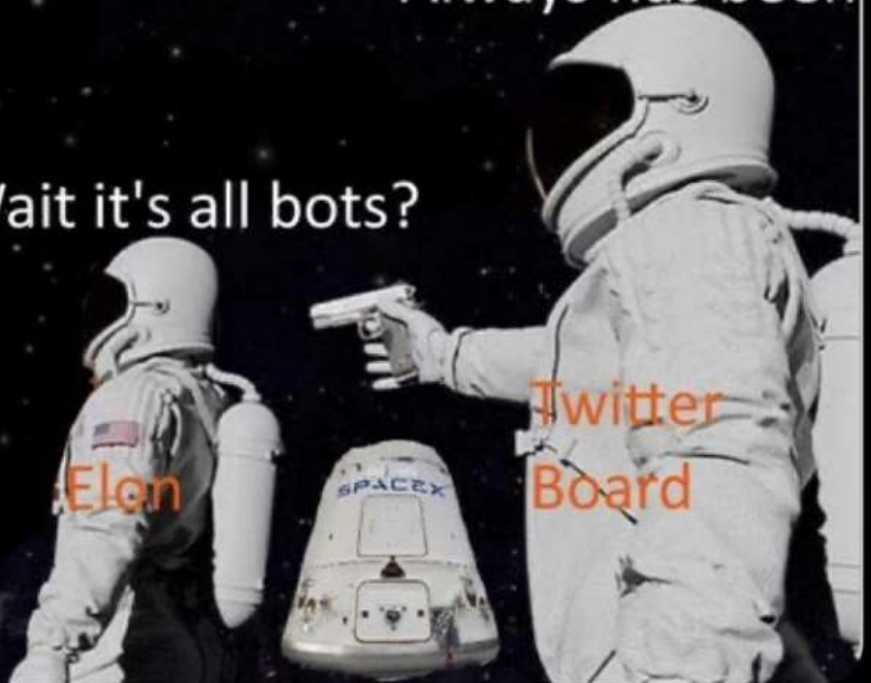

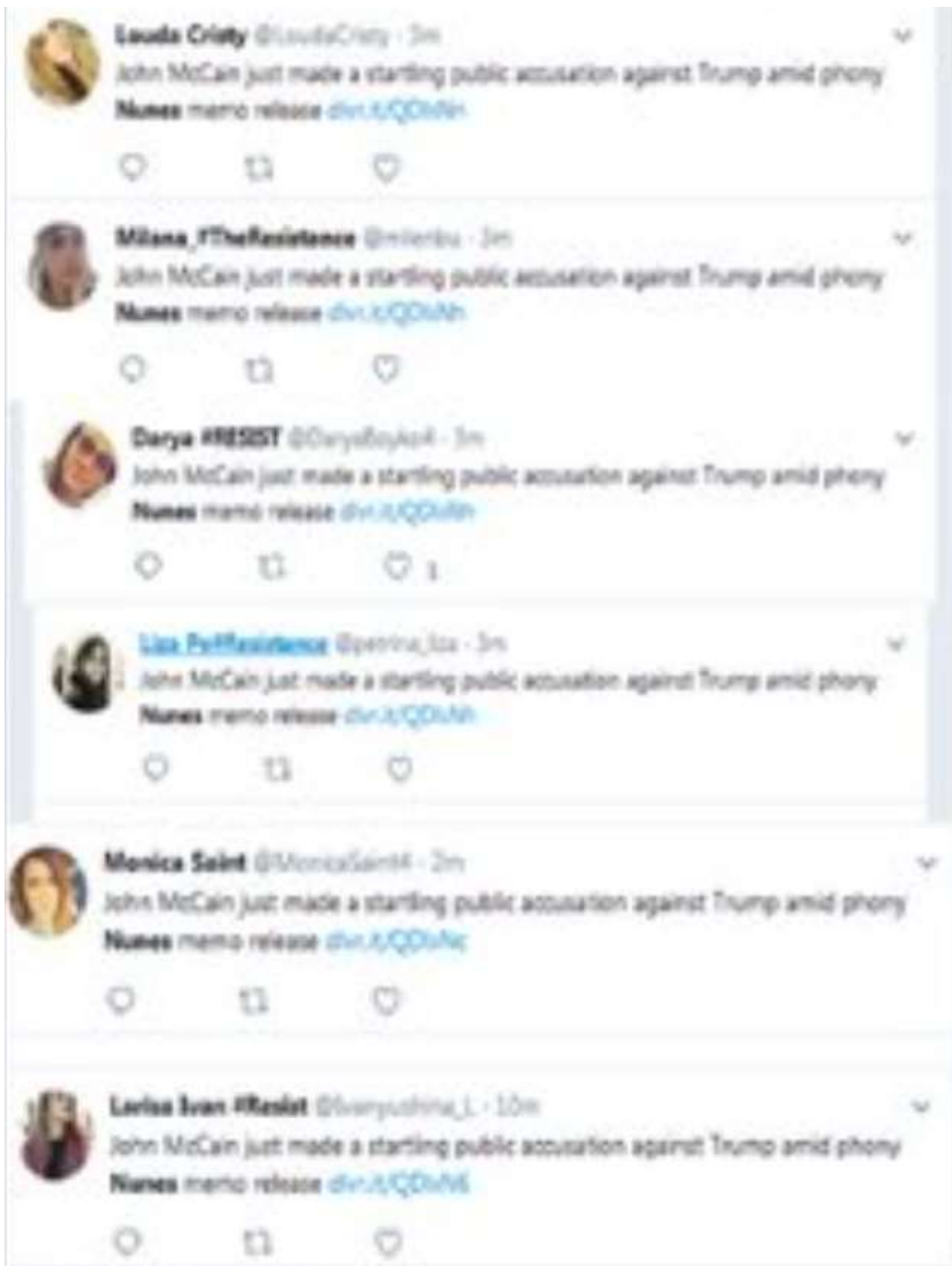

Dear Mr. Chairman:

On January 29, 2018, the House Permanent Select Committee on Intelligence (hereinafter “the Committee”) voted to disclose publicly a memorandum containing classified information provided to the Committee in connection with its oversight activities (the “Memorandum,” which is attached to this letter). As provided by clause 11(g) of Rule X of the House of Representatives, the Committee has forwarded this Memorandum to the President based on its determination that the release of the Memorandum would serve the public interest.

The Constitution vests the President with the authority to protect national security secrets from disclosure. As the Supreme Court has recognized, it is the President’s responsibility to classify, declassify, and control access to information bearing on our intelligence sources and methods and national defense. *See, e.g., Dep’t of Navy v. Egan*, 484 U.S. 518, 527 (1988). In order to facilitate appropriate congressional oversight, the Executive Branch may entrust classified information to the appropriate committees of Congress, as it has done in connection with the Committee’s oversight activities here. The Executive Branch does so on the assumption that the Committee will responsibly protect such classified information, consistent with the laws of the United States.

The Committee has now determined that the release of the Memorandum would be appropriate. The Executive Branch, across Administrations of both parties, has worked to accommodate congressional requests to declassify specific materials in the public interest.¹ However, public release of classified information by unilateral action of the Legislative Branch is extremely rare and raises significant separation of powers concerns. Accordingly, the Committee’s request to release the Memorandum is interpreted as a request for declassification pursuant to the President’s authority.

The President understands that the protection of our national security represents his highest obligation. Accordingly, he has directed lawyers and national security staff to assess the

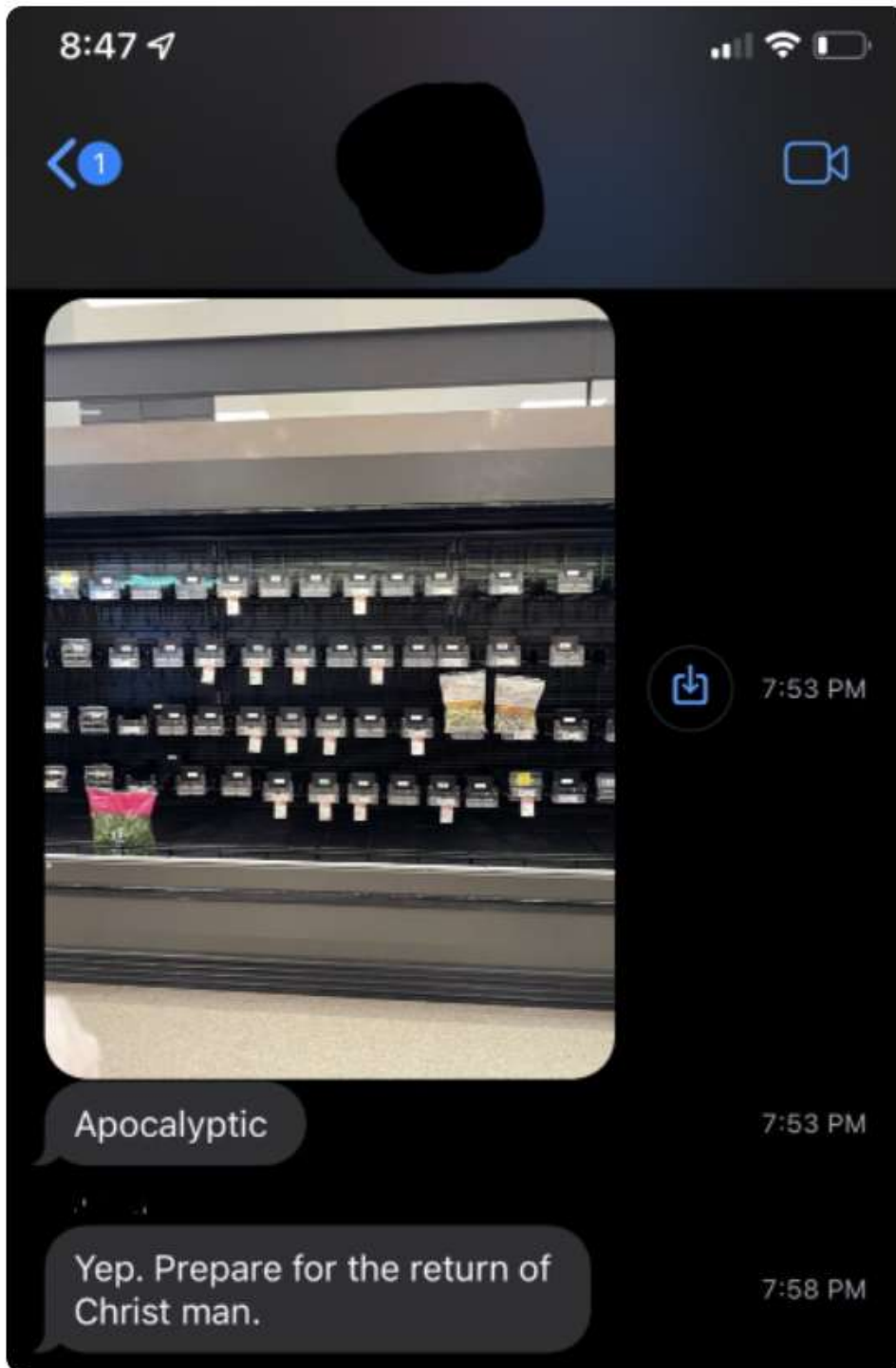

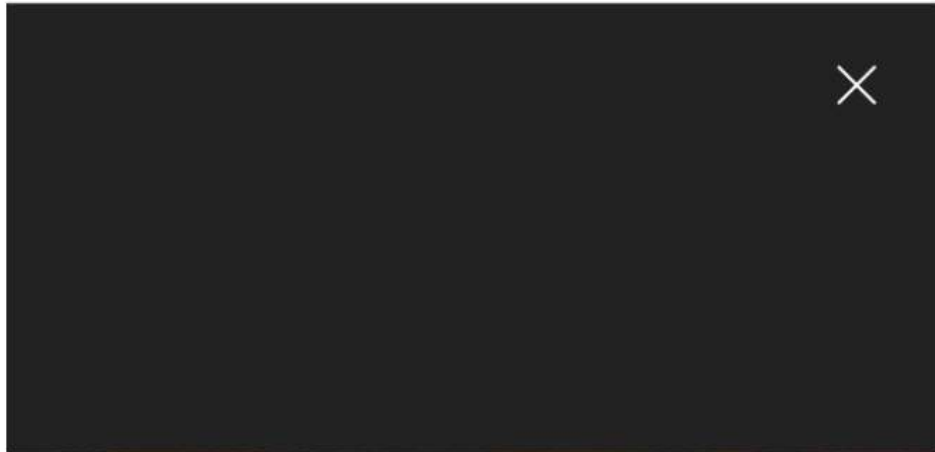
