In a win for President Trump, a Pennsylvania judge ruled today that Secretary of State Boockvar lacked statutory authority to extend the date for voters to provide proof of identification.



Boockvar issued guidance allowing proof of ID to be shown up until November 12th. A court had previously ruled that all ballots where voters provided proof of identification between November 10th and 12th should be segregated until a ruling was issued. Today's ruling means those ballots will not be counted.

Accordingly, the Court hereby ORDERS that Respondents County Boards of Elections are enjoined from counting any ballots that have been segregated pursuant to paragraph 1 of this Court's order dated November 5, 2020, granting a special injunction.
