Treason, Sedition and Subversive Activities

- 2) Many people are wringing their hands today over the news that Andrew McCabe will not be prosecuted for leaking to the media and lying.
- 3) I was surprised how many people (who normally read the tea leaves pretty well) took the announcement as proof that the DOJ is under corrupt leadership and that nothing has changed.
- 4) DOJ policy is to prosecute the most serious and the most readily provable charges. Leaking and lying are neither serious nor readily provable.
- 5) James Comey wasn't prosecuted for leaking his memos because to do so successfully, prosecutors would need to establish motive—the mindset of the accused—and that is incredibly hard to do, especially in a venue like Washington D.C, where jurors see FBI brass as gods.
- 6) It's no surprise that McCabe isn't going to be prosecuted for leaking and lying. The same rationale applies. They are neither serious nor readily provable charges.

And would you be satisfied if those were the most serious crimes they were charged with?

7) The FBI conspired with foreign governments to prevent the election of, and then overthrow, a duly elected President.

Crimes of this nature are found under 18 US Code chapter 115, which describes Treason, Sedition, and Subversive Activities.

8) I would draw your attention to section 2384, which describes seditious conspiracy.

When two or more people conspire to overthrow the government, they are guilty of this crime, which is punishable by 20 years in prison.

That is slightly more serious than leaking to the press.

## 18 U.S. Code § 2384. Seditious conspiracy

If two or more [persons](#) in any [State](#) or Territory, or in any place subject to the jurisdiction of the [United States](#), conspire to overthrow, put down, or to destroy by force the Government of the [United States](#), or to levy war against them, or to oppose by force the authority thereof, or by force to prevent, hinder, or delay the execution of any law of the [United States](#), or by force to seize, take, or possess any property of the [United States](#) contrary to the authority thereof, they shall each be fined under this title or imprisoned not more than twenty years, or both.

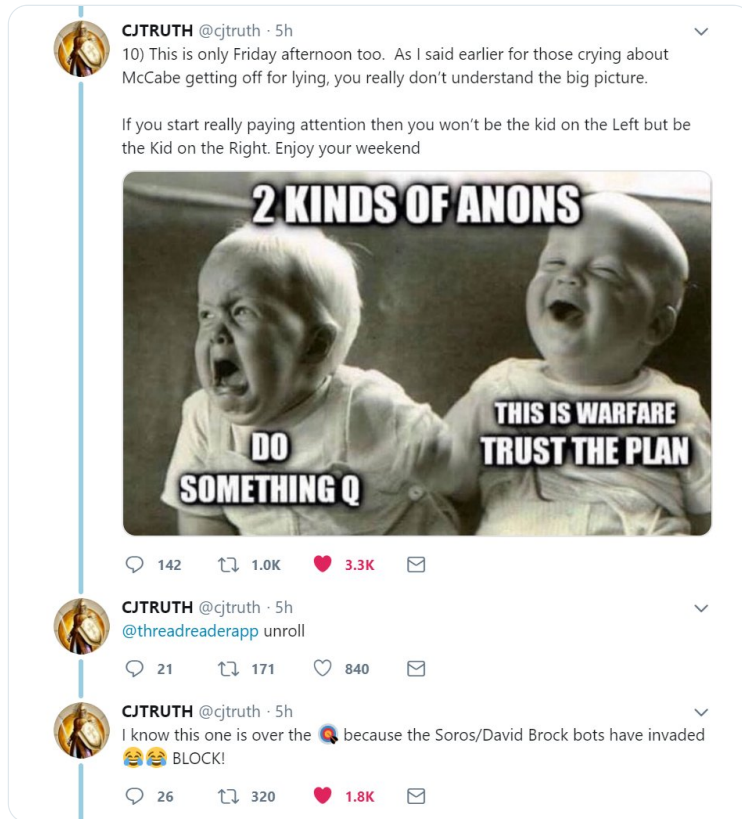

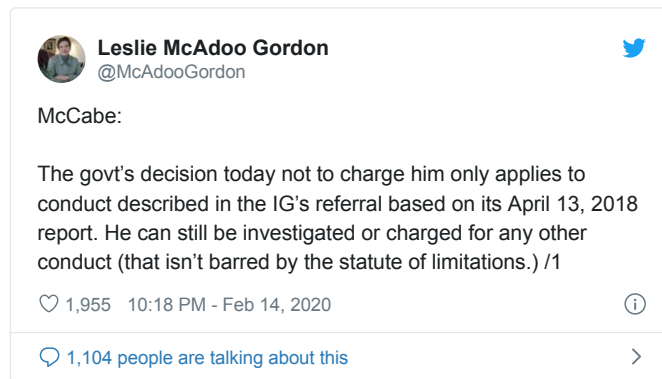

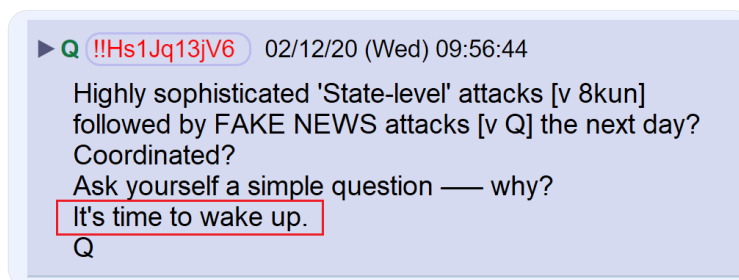

"It's time to wake up."



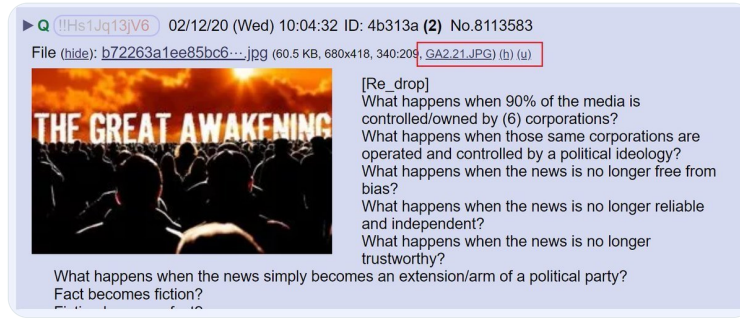
22) Here's Q's next post.

The filename prefix GA = Great Awakening.

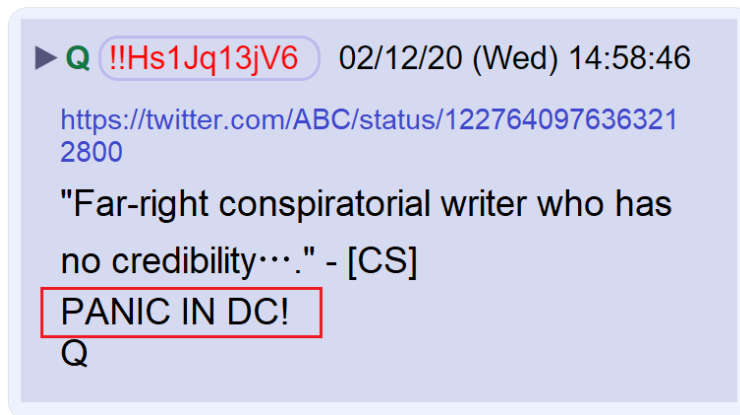


23) The Great Awakening is a metaphor for the public becoming aware of corruption & its prosecution.

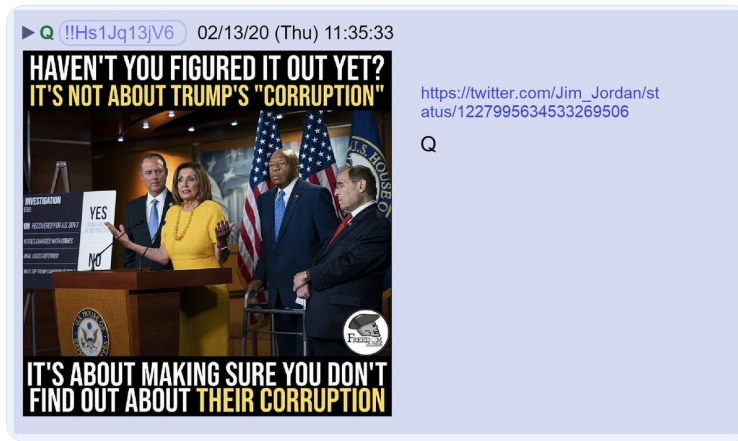
I hate predictions of dates for big events. They rarely come to pass.

24) Q's next post seems to suggest that this event will cause panic in DC.

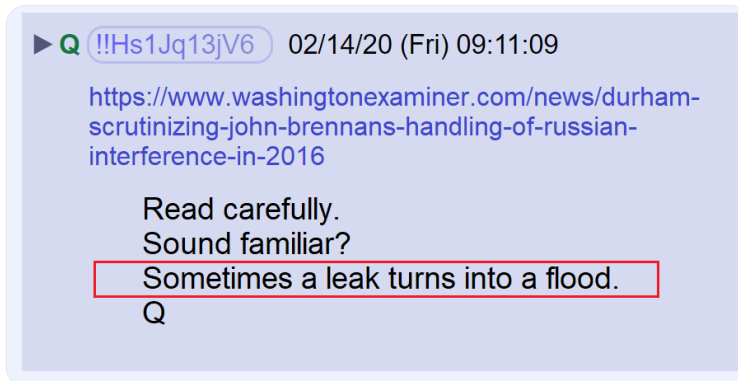


25) Q's next post appears to narrow down the subject to political corruption.



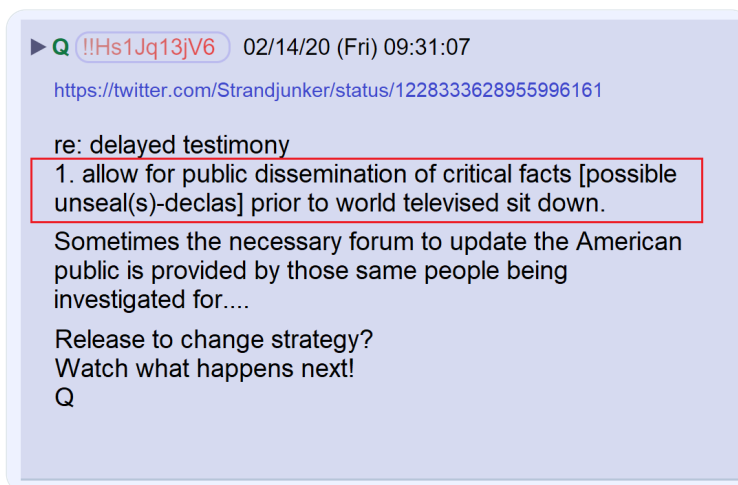
26) Q's next post suggests that the trickle of information we've received about corruption is about to become a flood of information.

27) Q's next post hints that we might soon see declassification of documents that expose corruption (and suggests indictments may be unsealed).

AG Barr's testimony to Congress was delayed to give the DOJ a chance to make the public aware of corruption through declassification.

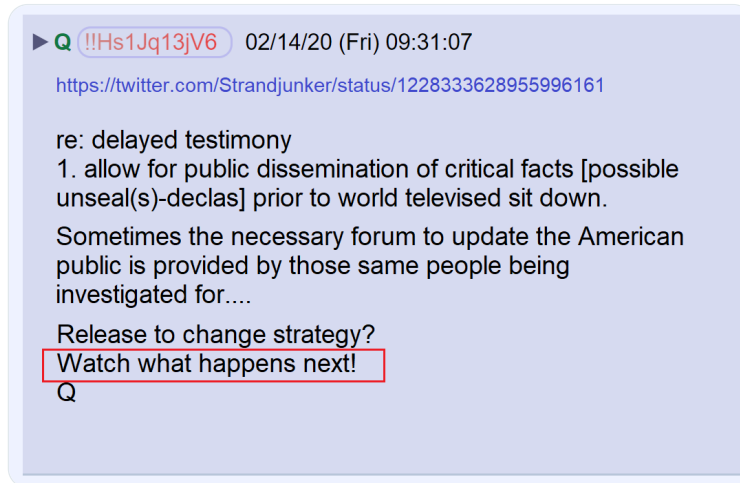


28) That post closes with the phrase "Watch what happens next."

The word "Watch" has several meanings, including "wristwatch."

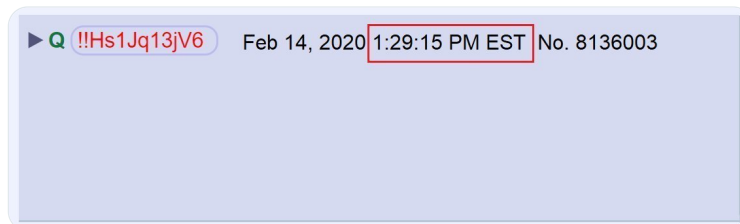
The phrase "Watch what happens next" may have a double meaning.

It may be pointing to Q's next post.



29) The next post by Q had no text and no image.

Note the timestamp of 1:29.



30) That's the same time showing on the watch that Q posted on December 2nd.

It's the same time the DOJ IG report was made public on December 9th.

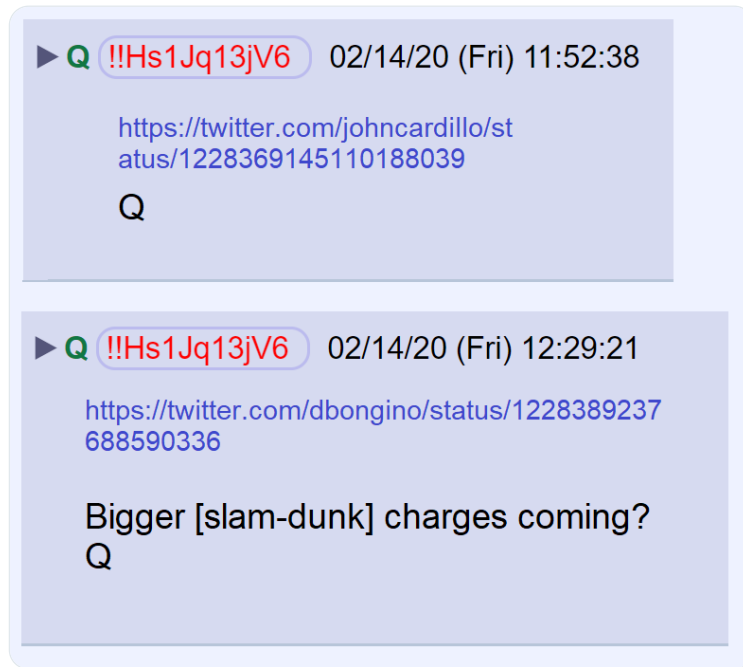
And the same time AG Barr and US Attorney Durham posted their replies to the IG report on the 9th.



31) I may be wrong, but if I had to speculate, I would guess a watch proof is coming

that is connected to declass or indictments, and the date of February 21st. If that event happened at 1:29, it would be an impressive proof.

32) The next 2 posts were about more serious charges coming against Andrew McCabe. I don't know if these posts are related to the "Great Awakening" event, but they could be.
