





2) Many people are wringing their hands today over the news that Andrew McCabe will not be prosecuted for leaking to the media and lying.

3) I was surprised how many people (who normally read the tea leaves pretty well) took the announcement as proof that the DOJ is under corrupt leadership and that nothing has changed.

4) DOJ policy is to prosecute the most serious and the most readily provable charges. Leaking and lying are neither serious nor readily provable.


5) James Comey wasn't prosecuted for leaking his memos because to do so successfully, prosecutors would need to establish motive—the mindset of the accused —and that is incredibly hard to do, especially in a venue like Washington D.C, where jurors see FBI brass as gods.

6) It's no surprise that McCabe isn't going to be prosecuted for leaking and lying. The same rationale applies. They are neither serious nor readily provable charges.

And would you be satisfied if those were the most serious crimes they were charged with?

7) The FBI conspired with foreign governments to prevent the election of, and then overthrow, a duly elected President.

Crimes of this nature are found under 18 US Code chapter 115, which describes Treason, Sedition, and Subversive Activities.



8) I would draw your attention to section 2384, which describes seditious conspiracy.

When two or more people conspire to overthrow the government, they are guilty of this crime, which is punishable by 20 years in prison.

That is slightly more serious than leaking to the press.

If two or more <u>persons</u> in any <u>State</u> or Territory, or in any place subject to the jurisdiction of the <u>United States</u> , conspire to overthrow, put down, or to destroy by force the Government of the <u>United States</u> , or to levy war against them, or to oppose by force the authority thereof, or by force to prevent, hinder, or delay the execution of any law of the <u>United States</u> , or by force to seize, take, or possess any property of the <u>United States</u> contrary to the authority thereof, they shall each be fined under this title or imprisoned not more than twenty years, or both.







The date (2/21) is less than a week away.


The filename prefix GA = Great Awakening.


It's the same time the DOJ IG report was made public on December 9th. And the same time AG Barr and US Attorney Durham posted their replies to the IG report on the 9th.
