We uploaded a 59 minute video today "**From Bare Dirt To Abundance**" 7th March 2016 <https://www.youtube.com/watch?v=SH9i8ZStzWI> to this YouTube Channel <http://www.youtube.com/ArthurLoveForLife> but Youtube blocked it saying it was too long. We already have many other videos uploaded going up to 3 hours.

We looked into our YouTube Channel and found another community guideline flagging placed against a video which already received a flagging back in the 2nd February 2015 (see below) to which we corresponded 3rd February 2015 (see below) and the YouTube Community removed that flag 14th February 2015 and restored our good standing.

Why has the same untouched/unchanged/non-edited/non-tampered video been given another flag which gave us another Bad Standing? Until today, we were not

aware of this latest flag put up 10th December 2015. We must have overlooked the email received back then or did not receive one.

We refuse to press the I Acknowledge button of this flag or two because this video/s is NOT hate based etc....
