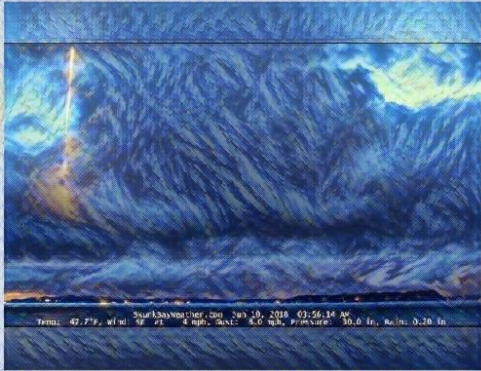

EXECUTIVE ORDER

Continuing Temporary Suspension and Modification of Laws Relating to the Disaster Emergency

WHEREAS, on March 7, 2020, I issued Executive Order Number 202, declaring a State disaster emergency for the entire State of New York; and

WHEREAS, both travel-related cases and community contact transmission of COVID-19 have been documented in New York State and are expected to continue;

NOW, THEREFORE, I, ANDREW M. CUOMO, Governor of the State of New York, by virtue of the authority vested in me by the Constitution and the Laws of the State of New York, do hereby find

that a disaster continues to exist for which affected state agencies and local governments are unable to respond adequately. Therefore, pursuant to the authority vested in me by the Constitution of the State of New York and Section 23 of Article 2-B of the Executive Law, I hereby continue the declaration of the State Disaster Emergency effective March 7, 2020, as set forth in Executive Order 202. This Executive order shall remain in effect until November 3, 2020.

IN ADDITION, I, Andrew M. Cuomo, Governor of the State of New York, by virtue of the authority vested in me by Section 29-a of Article 2-B of the Executive Law to temporarily suspend or modify any statute, local law, ordinance, order, rule, or regulation, or parts thereof, of any agency during a State disaster emergency, if compliance with such statute, local law, ordinance, order, rule, or regulation would prevent, hinder, or delay action necessary to cope with the disaster emergency or if necessary to assist or aid in coping with such disaster, or to provide any directive necessary to respond to the disaster, do hereby continue the suspensions and modifications of law, and any directives not superseded by a subsequent directive contained in Executive Orders 202 up to and including 202.21, and 202.27, 202.28, 202.29, 202.30, 202.38, 202.39, 202.40, 202.48, 202.49, 202.50, 202.55 and 202.55.1, as extended, and Executive Order 202.60 for another thirty days through November 3, 2020, except:

Background:

While looking through photos taken by a weather camera on the Kitsap Peninsula, Greg Johnson of Skunk Bay Weather spotted a photo with a mysterious object. The picture—taken at 3:56 a.m. on June 10th—showed a bright orange vertical streak in the early morning sky over Whidbey Island. Close inspection of the photo reveals the unmistakable shape of a missile. A few news outlets attributed it to lens flare or claimed it was a photo of a helicopter. The most likely explanation of the photo would be that the camera captured the vertical launch of a missile from a submarine. Although the Navy denied any knowledge of a missile launch, Bangor Submarine base is nearby. It's home to submarines that carry vertically launched missiles.

Some people have mistakenly reported that the missile launch was an attempt to hit Air Force One while in flight. The President left from the G7 meeting in Quebec, Canada for his trip to Singapore on June 9th, traveling eastward across the Atlantic. A missile launched from the Puget Sound on June 10th could not hit an airplane traveling eastward across the Atlantic Ocean when the aircraft had departed the previous day.

Later posts by Q suggested the missile launch may have been a deep state operation intended to start a war while the President met with Kim in Singapore.

WASHINGTON—The U.S. national security adviser warned [China](#) on Wednesday against any attempt to take [Taiwan](#) by force, saying amphibious landings were notoriously difficult and there was a lot of ambiguity about how the United States would respond.

Robert O'Brien told an event at the University of Nevada in Las Vegas that China was engaged in a massive naval buildup probably not seen since Germany's attempt to compete with Britain's Royal Navy prior to World War One.

"Part of that is to give them the ability to push us back out of the Western Pacific, and allow them to engage in an amphibious landing in Taiwan," he said.

"The problem with that is that amphibious landings are notoriously difficult," O'Brien added, pointing to the 100-mile (160-kilometer) distance between China and Taiwan and the paucity of landing beaches on the island.

"It's not an easy task, and there's also a lot of ambiguity about what the United States would do in response to an attack by China on Taiwan," he added, when asked what U.S. options would be if China moved to try to absorb Taiwan.

O'Brien was referring to a long-standing U.S. policy of "strategic ambiguity" on the question of whether it would intervene to protect Taiwan, which China considers its province and has vowed to bring under its control, by force if necessary.

The United States is required by law to provide Taiwan with the means to defend itself, but it has not made clear whether it would intervene militarily in the event of a Chinese attack, something that would likely lead to a much broader conflict with Beijing.
