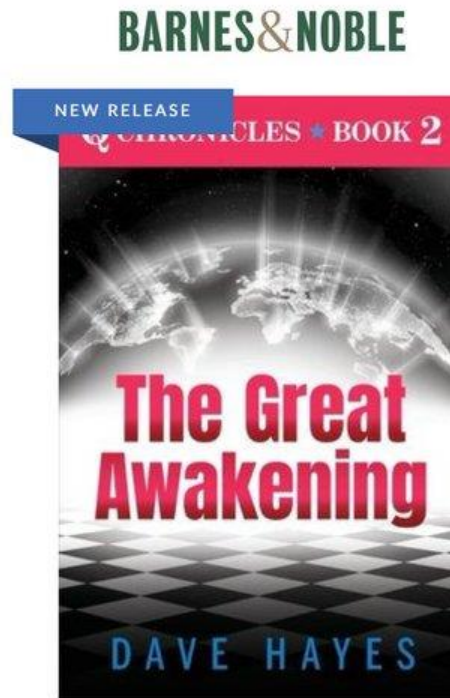

In sum, we conclude the Board did not act contrary to law in fashioning its regulations governing the positioning of candidate representatives during the pre-canvassing and canvassing process, as the Election Code does not specify minimum distance parameters for the location of such representatives. Critically, we find the Board's regulations as applied herein were reasonable in that they allowed candidate representatives to observe the Board conducting its activities as prescribed under the Election Code. Accordingly, we determine the Commonwealth Court's order was erroneous. Thus, we vacate that order, and reinstate the trial court's order.

Jurisdiction relinquished.

Justices Baer, Donohue, Dougherty and Wecht join the opinion.

- precincts in
- vote share of each candidate at that time

Arizona is simple:

There are two major areas to focus on in Arizona based on review of this NYT Database.

- **72% of the total precincts were dumped into the system in the first 10 minutes after 8pm on election night.** Highlighted in **Green** in the spreadsheet
 - 2.3 million of the total 3.3 million votes were entered in those first 10 minutes.
 - Biden had an immediate 9.5% lead that allowed the Decision Desks to call the state not long after
 - How did Arizona count 2.3 million votes in 10 minutes, and then take 2 weeks to count the rest?
- **Arizona stopped reporting for 75 minutes between 9:38PM and 10:53PM.**
 - Many people have denied this occurred, but there it is in black and white. **Purple** in the spreadsheet

Arizona is completely different than the other 4 states I've looked at thus far. It's not remotely close. Not sure what to make of these two major areas. We know Arizona was the fulcrum by which election night began to turn. Their ability to report on 70% of their total ballots by 8:10pm AST, followed by the early controversial call for Arizona by the Decision Desks, followed by reporting stopping altogether at between 11:38 and 1 in the morning on the East Coast.

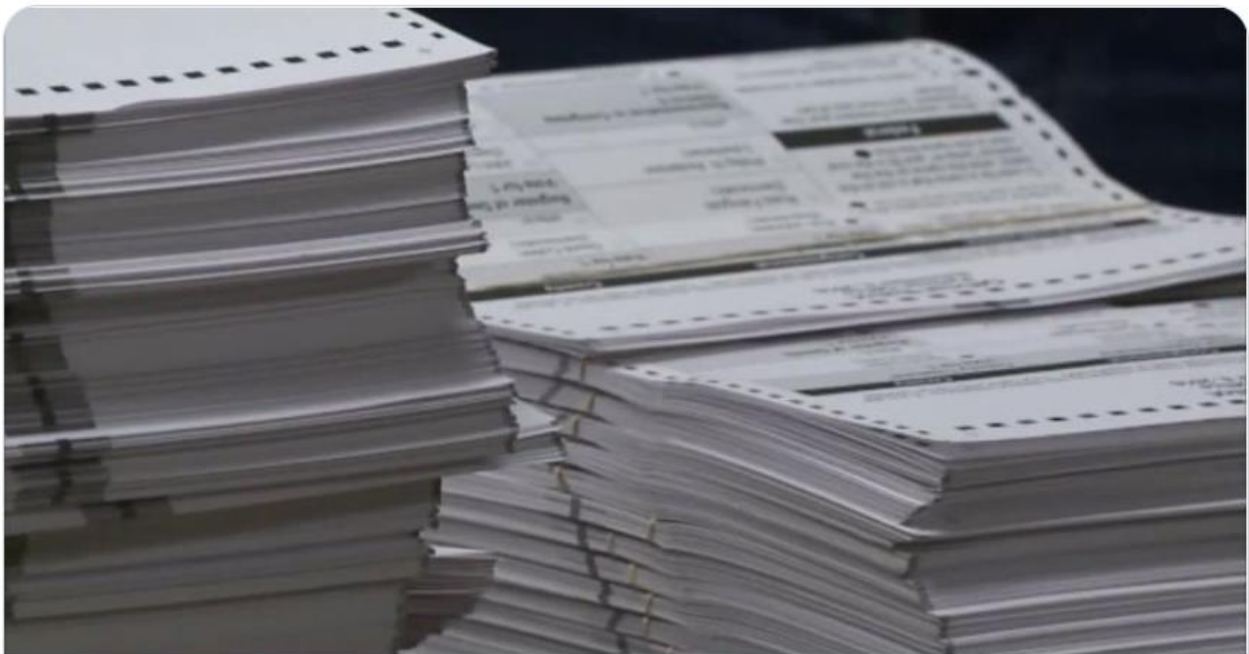

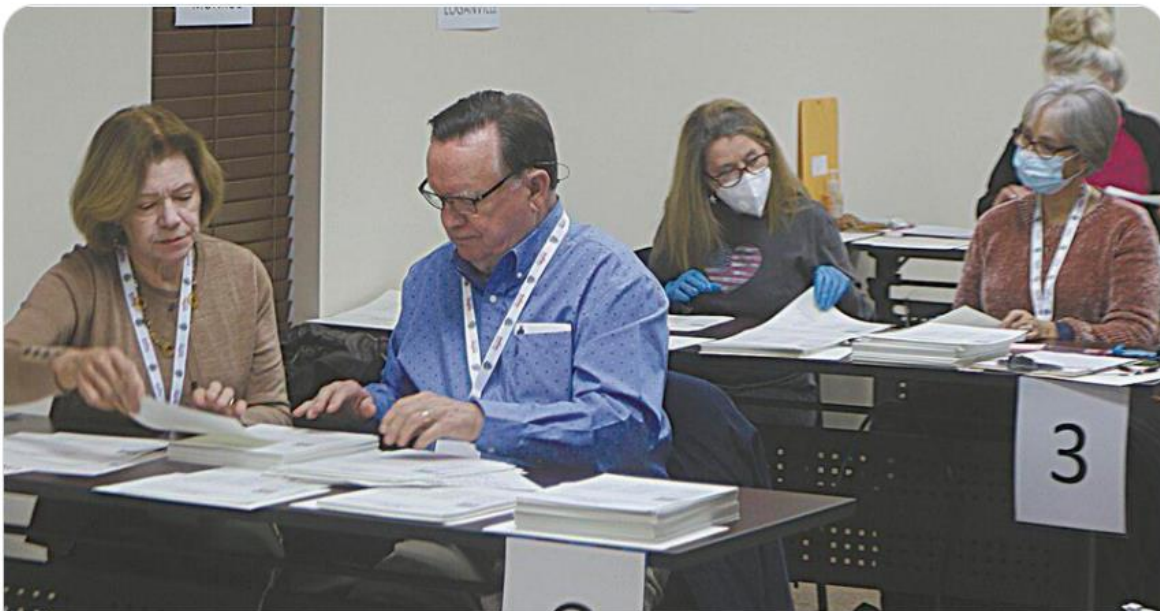

15. These different ballots included a single depressed pile that they came out easily folded and unfolded for use in the scanning machines. There were no markings on the ballots to show where they had come from, or where they had been processed. These stood out.

16. In my 20 years' of experience of handling ballots, I observed that the markings for the candidates on these ballots were unusually uniform, perhaps even with a ballot-marking device. By my estimate in observing these ballots, approximately 98% constituted votes for Joseph Biden. I only observed two of these ballots as votes for President Donald J. Trump.

7. I watched them pull out a pile of what I observed to be absentee ballots and noticed two very distinct characteristics that these ballots had. One, I noticed that they all had a perfect black bubble and were all Biden select. I was able to observe the perfect bubble for a few minutes before they made me move away from the table. At no time did I speak to the poll workers or obstruct them in any way. I heard them go through the stack and call out Biden's name over 500 times in a row.

8. On the following day, on November 16, 2020, I presented myself to Cobb County Poll Precinct located at 2245 Callaway Road SW, Marietta, GA. At first, I was standing next to the panel reviewers in Room B, where I observed absentee ballots being reviewed with the same perfect bubble that I had seen the night before at Dekalb County. All of these ballots had the same two characteristics: they were all for Biden and had the same perfect black bubble.

3. There were no creases in the mail in ballots giving the impression that they were never folded into an envelope and mailed. Most importantly, these ballots appeared to be pre-printed with the selections already made. The bubbles that one would select to choose their candidate appeared to have the exact same markings, with no different color inks, and no markings outside of the bubble as if they were all done perfectly. Hundreds of ballots at a time were counted for Biden only.
