# Facebook will ban ads that seek to delegitimize US election

<u>Facebook</u> on Wednesday announced that it will not allow any ads on its service that seek to delegitimize the outcome of an election, including the upcoming U.S. election on Nov. 3.

"Last week we said we'd prohibit ads that make premature declarations of victory. We also won't allow ads with content that seeks to delegitimize the outcome of an election," <u>tweeted</u> Rob Leathern, Facebook director of product management.

This policy will prohibit any ads that call specific methods of voting, such as voting by mail, as being inherently fraudulent or corrupt, Leathern said. It will also prohibit the use of isolated incidents of voter fraud to delegitimize the result of an election, he added.

Facebook's policy change comes as President Donald Trump has used social media to make false claims that voting by mail leads to election fraud. Trump has refused to commit to a peaceful transfer of power should he lose.

The new policy will apply to ads on Facebook and Instagram effective immediately, Leathern said.

## Man charged in brazen ambush of 2 L.A. County deputies in their squad car

LOS ANGELES — Prosecutors charged a 36-year-old man Wednesday with a brazen ambush of two Los Angeles County sheriff's deputies earlier this month, an apparently unprovoked shooting as they sat in a squad car outside a rail station.

The deputies suffered head wounds in the Sept. 12 attack and have since been released from the hospital. Sheriff Alex Villanueva said their recoveries will be a long process and include further reconstructive surgeries.

The suspect, Deonte Lee Murray, pleaded not guilty to attempted murder and other charges Wednesday during his arraignment. He faces life in state prison if he is convicted.

Murray's attorney, Jack Keenan, declined to comment and said he has not yet seen prosecutors' evidence. Murray is being held in jail on \$6.15 million bail and is due back in court in November.

The sheriff's department arrested Murray two weeks ago in connection with a separate carjacking. But officials at the time said it was not related to the ambush case.

Murray has a criminal history including convictions for sales and possession of narcotics, firearm possession, receiving stolen property, burglary and terrorist threats, authorities said. Wednesday's criminal complaint includes allegations that he associates with gangs.

Investigators on Wednesday did not provide a specific motive for the attack, "other than the fact that he obviously hates policemen and he wants them dead," said Capt. Kent Wegener, the head of the sheriff's homicide bureau.

A minimum \$5,000 would go to each person who filed a claim for unseen injuries and did not seek medical attention or therapy.





## U.S. Agency for Global Media unrecognizable under Trump ally

It was, in essence, an oversight hearing of a relatively small government agency, but what it amounted to was yet another indictment of a bureau taken over by a Trump ally and made unrecognizable to the members of Congress — from both parties — who fund and monitor it.

Democrats and Republicans joined in expressing anger and dismay at what has happened to the U.S. Agency for Global Media since a supporter of President Donald Trump was confirmed as its director in early June.

The agency, with an annual budget just under \$1 billion and a staff of 4,000 employees and 1,500 stringer reporters, is home to the U.S. government's international broadcasting operations, including the Voice of America, Radio Free Europe/Radio Liberty and Radio Free Asia, which have long been respected as trustworthy sources of information for people in authoritarian countries whose news is censored, restricted and blocked.

Since being confirmed in June to his post in a partisan Senate vote, Michael Pack has fired all of the heads of the agency's news organizations, ordered the news networks to publish pro-Trump administration editorials, refused to renew the work visas of dozens of VOA-employed foreign journalists who speak the local languages of the countries to which they broadcast, and flouted congressional spending directives by essentially impounding funding for projects to combat internet censorship in repressive societies.

Pack is a longtime ally of Steve Bannon, the recently indicted Trump supporter. The two have made conservative documentaries together.

Grant Turner, a career civil servant and the former chief financial officer of USAGM, whom Pack suspended in August after he objected to some of the CEO's actions, said during a House Foreign Affairs oversight hearing on Sept. 24 that Pack even sought to have his political "operatives" sit in on the planning meetings for VOA's presidential election coverage.

"I worry about what Mr. Pack has done since his arrival," Turner said. "I'm worried about the
