Unlike in criminal law, the burden of proof in civil law is the "preponderance of evidence."

Preponderance of the Evidence

"The greater weight of the evidence" required in a civil (non-criminal) lawsuit for the trier of fact (jury or judge without a jury) to decide in favor of one side or the other. This preponderance is based on the more convincing evidence and its *probable truth or accuracy*, and not on the amount of evidence. Thus, one clearly knowledgeable witness may provide a preponderance of evidence over a dozen witnesses with hazy testimony, or a signed agreement with definite terms may outweigh opinions or speculation about what the parties intended. Preponderance of the evidence is required in a civil case and is contrasted with "beyond a reasonable doubt," which is the more severe test of evidence required to convict in a criminal trial.

One way the Trump campaign can win is to prevent Joe Biden from getting 270 electoral votes. That requires action at the state level. If the results of a state's election are invalidated, that state's electoral votes cannot go to Joe Biden.

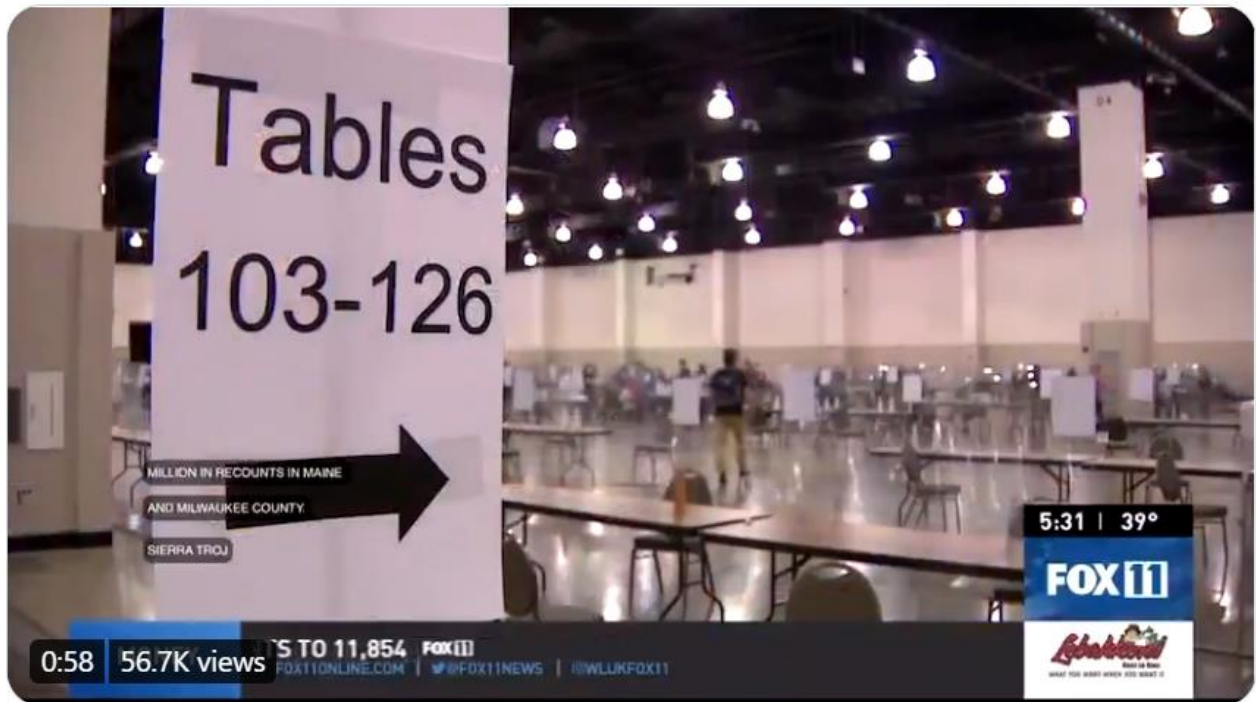

Wisconsin Recount Will Continue Past Thanksgiving: County Official

The recount taking place in [Wisconsin](#) will keep going past Thanksgiving, a county official said Sunday.

“The City of [Milwaukee](#) has started running their ballots, processing their ballots—finally,” Milwaukee County Clerk George Christenson told the [Milwaukee Journal-Sentinel](#).

The county is behind schedule, which pegged the recount as ending the day before Thanksgiving.

Officials believe they can meet the Dec. 1 deadline to finish but will be working “well past Thanksgiving,” Christenson added.

Christenson’s office didn’t return a request for more information.

Christenson told observers earlier Sunday that they shouldn’t make “unnecessary” objections, the Journal-Sentinel reported.

“Any objections on the grounds that ballots are folded should be disregarded. Any objections on the grounds that there are no initials on the ballots should be disregarded,” he said.

Stewart Karge, an attorney for President Donald Trump’s campaign, responded that the campaign can challenge all early votes cast by mail.

The Trump campaign has requested a recount in [Georgia](#) after the state certified its election results on Nov. 20, citing a lack of signature matching and “other vital safeguards” for a meaningful recount after a risk-limiting audit was completed this week.

“Today, the Trump campaign filed a petition for recount in Georgia,” the campaign said in a statement on Nov. 21. “We are focused on ensuring that every aspect of Georgia State Law and the U.S. Constitution are followed so that every legal vote is counted.

“President Trump and his campaign continue to insist on an honest recount in Georgia, which has to include signature matching and other vital safeguards. Without signature matching, this recount would be a sham and again allow for illegal votes to be counted.”

The campaign’s request has been delivered as a handwritten letter to the secretary of state’s office.

The results from the audit showed Democratic presidential nominee Joe Biden winning the state over Trump by 12,670 votes. President Donald Trump hasn’t conceded the election and has said that voter fraud and irregularities were present in Georgia as well as other key states.

According to state law, a candidate can request a recount if the margin is less than 0.5 percent. Biden’s margin in Georgia stands at 0.25 percent of the 5 million votes cast.

President Donald [Trump](#) lawyer Jordan Sekulow said an election challenge that will be filed this week contains new allegations about irregularities.

“We have got [lawsuits](#) likely to be filed in [Georgia](#) on either Monday or Tuesday; I can’t get into the details,” he said to [Newsmax](#), without providing any examples. “I can’t tell you right now, but what’s coming in Georgia will be shocking, when we file this in federal court Monday or Tuesday,” he added. “It’s nothing that we have talked [about] before. It’s not what you heard in the press conference [on Thursday] either.

Sekulow, the son of Trump personal attorney and impeachment defender Jay Sekulow, said it is “something completely separate” from the allegations contained in the press conference held by lawyers Sidney Powell, Jenna Ellis, and Rudy Giuliani.

“They’ve got to be outcome determinative, but I will tell you, the Lt. Gov. [Geoff Duncan] in Georgia, the Secretary of State in Georgia [Brad Raffensperger] in Georgia, they’re in for quite a shock on Monday and Tuesday about how poorly they run and they ran—there’s going to be a proof —of how poorly run they ran the elections in one of their major counties,” Sekulow said.

Georgia’s secretary of state’s office has not responded to a request for comment.

The Trump campaign lawsuit that was dismissed by a lower court is being appealed to the 3rd circuit court. At issue is the claim that predominantly Democrat counties were allowed to cure ballots while predominantly Republican counties were not. The complaint alleges a violation of the 14th amendment, which guarantees due process and equal protection:

No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

Trump Campaign Appeals Dismissal of Pennsylvania Lawsuit

President Donald [Trump](#)'s campaign on Nov. 22 appealed the dismissal of its election [lawsuit](#) in [Pennsylvania](#), according to a [notice](#) filed in federal court, bringing the campaign one step closer to its stated goal of getting an election challenge to the Supreme Court.

District Court Judge Matthew Brann dismissed the campaign's lawsuit on Nov. 21, saying the plaintiffs lacked standing to bring the claim, among other issues. The campaign said it has appealed the ruling to the U.S. Court of Appeals for the 3rd Circuit.

Rudy Giuliani, the lead attorney representing Trump's post-election legal effort, said on Nov. 21 that Brann's dismissal would help expedite the lawsuit's progression to the Supreme Court.

President Donald Trump on Nov. 21 foreshadowed the appeal.

"It's all a continuation of the never ending Witch Hunt," the president wrote on Twitter. "Judge Brann, who would not even allow us to present our case or evidence, is a product of Senator Pat 'No Tariffs' Toomey of Pennsylvania, no friend of mine, & Obama – No wonder. 900,000 Fraudulent Votes!" Trump was referring to Sen. Pat Toomey (R-Pa.).

In the lawsuit, brought against Pennsylvania Secretary of State Kathy Boockvar and seven Keystone State counties, the Trump campaign asked the court to block the certification of the election results in Pennsylvania, arguing that voters in Republican-controlled counties were treated unequally to those in Democrat-controlled counties. The voters in Democrat-controlled counties were given the chance to fix issues with their absentee ballots in contravention of state law, while officials in Republican counties followed the law and didn't offer such an opportunity, the lawsuit claimed.
