

# EXCLUSIVE: Senate Committee Successfully Verifies All Bobulinski Materials Reviewed To Date

The Senate Homeland Security and Governmental Affairs Committee has successfully verified all materials reviewed so far from Hunter Biden's ex-business partner Tony Bobulinski, the Daily Caller has learned.

Committee Chairman Sen. Ron Johnson will not call Bobulinski to testify before the November 3 elections, as the committee is working to review all the information provided to the committee by Bobulinski. The information has to be verified, as it is subject to the same false information to Congress laws that verbal or written testimony does. However, a Johnson spokesperson told the Caller that all the material provided by Bobulinski that has been reviewed so far has turned out to be legitimate. The committee has "also" not come across any "signs" or evidence to suggest the content is false, the spokesperson added.

Bobulinski, who said Tuesday he believes "Joe Biden and the Biden family are compromised" in an interview with Fox News host Tucker Carlson, has turned over evidence to the FBI alleging he met twice in the past with the former vice president in regards to business with his son Hunter. The Biden family has not yet disputed this information.



# Judge strikes down Michigan ban on open carry weapons at polling locations

A Michigan judge on Tuesday struck down a state ban on open carry weapons at polling locations and places where ballots are counted.

Michigan Court of Claims Judge Christopher Murray ruled that Secretary of State Jocelyn Benson (D) did not follow the appropriate protocol to institute her rule announced Oct. 16. Benson and Attorney General Dana Nessel (D) appealed Murray's decision on Wednesday morning.

"It is important to recognize that this case is not about whether it is a good idea to openly carry a firearm at a polling place, or whether the Second Amendment to the U.S. Constitution prevents the secretary of state's ... directive," he said in a written opinion.

"The secretary just didn't do this in the right way and at the right time," Murray said during the hearing, adding if she wanted this done by Election Day, "the secretary should have done this months ago."

Murray's argument was that Benson's rule should have been implemented under the Administrative Procedures Act to permit public input and legislative criticism.

The ban would have prohibited open carry weapons at polling places, clerk's offices and absent voter counting boards on Nov. 3. Benson announced the now-paused rule as reports have elevated concerns about violence, guns and voter intimidation at polling locations during a contentious election.

The judge, who was appointed by former Michigan Gov. John Engler (R), cited a current state law banning voter intimidation at voting locations, but Benson argued that that law wasn't enough.

### France to undergo second national coronavirus lockdown

France is set to go under a second national lockdown starting Friday, as coronavirus cases have skyrocketed in recent weeks and caused mass hospitalizations.

The new regulation stipulates that people are only permitted to leave their homes for essential work or medical reasons. All nonessential businesses, such as restaurants and bars, will close under the new mandate, <u>according</u> to the BBC.

Schools and churches will remain open, making this lockdown less restrictive than the earlier one this year.

Prime Minister Emmanuel Macron announced the new measures during a televised press conference Wednesday.

#### Germany to impose onemonth partial shutdown amid COVID-19 surge

Germany is imposing a one-month partial shutdown that will close bars, restaurants and gyms as it seeks to prevent a wider spread of the coronavirus.

Case counts are on the rise in the United States and in Europe, and Germany is just one of several countries reimposing at least some restrictions. The closures will mark the most severe restrictions since Germany went into a national lockdown in the spring.

The deal to impose COVID-19 measures was agreed upon by leaders of the country's 16 states and German Chancellor Angela Merkel, <u>Bloomberg reported</u>. An official announcement is slated to be made later Wednesday, a person familiar with the matter who requested anonymity told the press.

The German order won't close everything. While museums will close and sporting teams will have to play with no spectators, German soccer teams will continue to play and stores and markets will remain open.

The new restrictions, which will take effect on Monday, are aimed at providing a compromise between public health and allowing the economy to function. They are also intended to help hospitals and prevent crowding. The New York Times reported that some hospitals have seen the number of patients double in the last 10 days.

## Ex-DHS official reveals himself as 'Anonymous'

Miles Taylor, a former Department of Homeland Security (DHS) official, revealed on Wednesday that he was the anonymous author behind a New York Times op-ed and subsequent book criticizing President Trump's character from the perspective of a staffer inside the administration.

"I witnessed Trump's inability to do his job over the course of two-and-a-half years. Everyone saw it, though most were hesitant to speak up for fear of reprisals," Taylor, who left the administration last year, wrote in a Medium post.

"So when I left the Administration I wrote A Warning, a character study of the current Commander in Chief and a caution to voters that it wasn't as bad as it looked inside the Trump Administration — it was worse," he continued.

Taylor has been public about his criticism of Trump for months, and even endorsed Democratic presidential nominee Joe Biden earlier this year. He served in the Department of Homeland Security from 2017-2019, a stint that included time as chief of staff to former DHS Secretary Kirstjen Nielsen.

During his time in the administration, DHS oversaw the zero tolerance policy at the southern border that led to the separation of thousands of migrant children from their families. The practice prompted bipartisan outcry and was eventually halted, but advocates say hundreds of children still have not been reunited with their parents.

Taylor's criticisms on Wednesday largely focused on Trump's character and treatment of the country's institutions, however, and he urged other Republicans to join him in speaking out.

# Obama, Biden to campaign together in Michigan

Former President Obama and Democratic presidential nominee <u>Joe Biden</u> will campaign together in Michigan on Saturday as Democrats make a full-court press in the key swing state.


Michigan is anticipated to be a top battleground in the presidential race after Trump narrowly flipped it in 2016, marking the first time a Republican presidential ticket won the state since 1988.

A <u>New York Times-Siena College poll</u> released Wednesday showed Biden with a 49 percent to 41 percent lead over Trump among likely voters in the state, which is also hosting a competitive Senate race. The former vice president has led in most polls of the Wolverine State.
