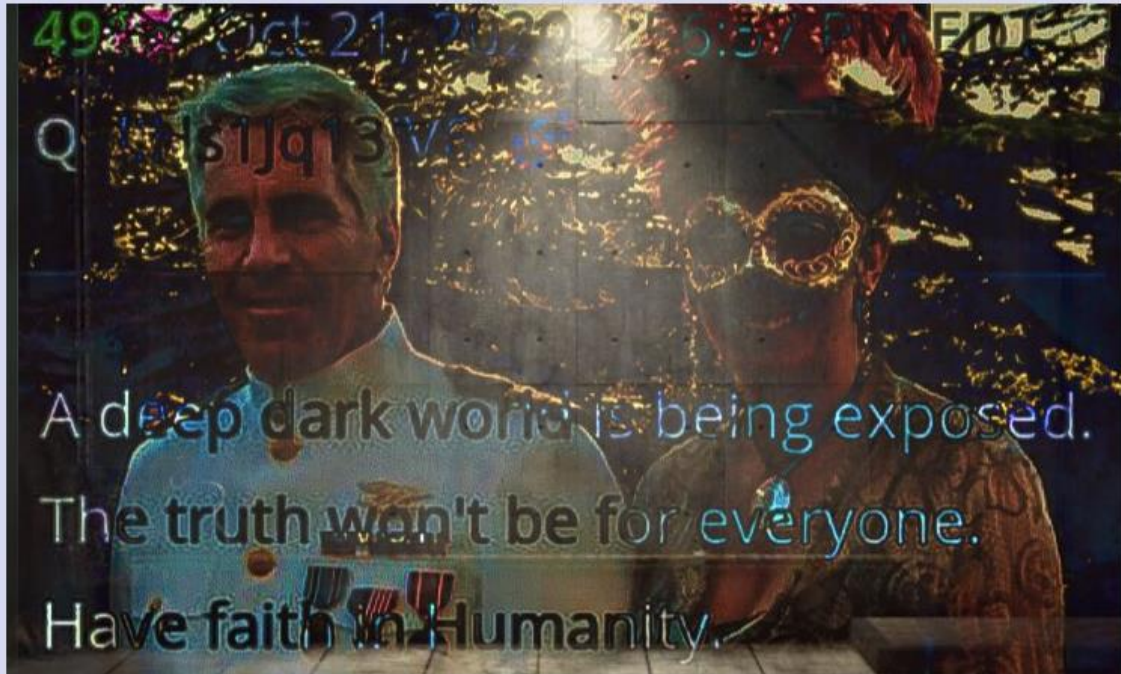

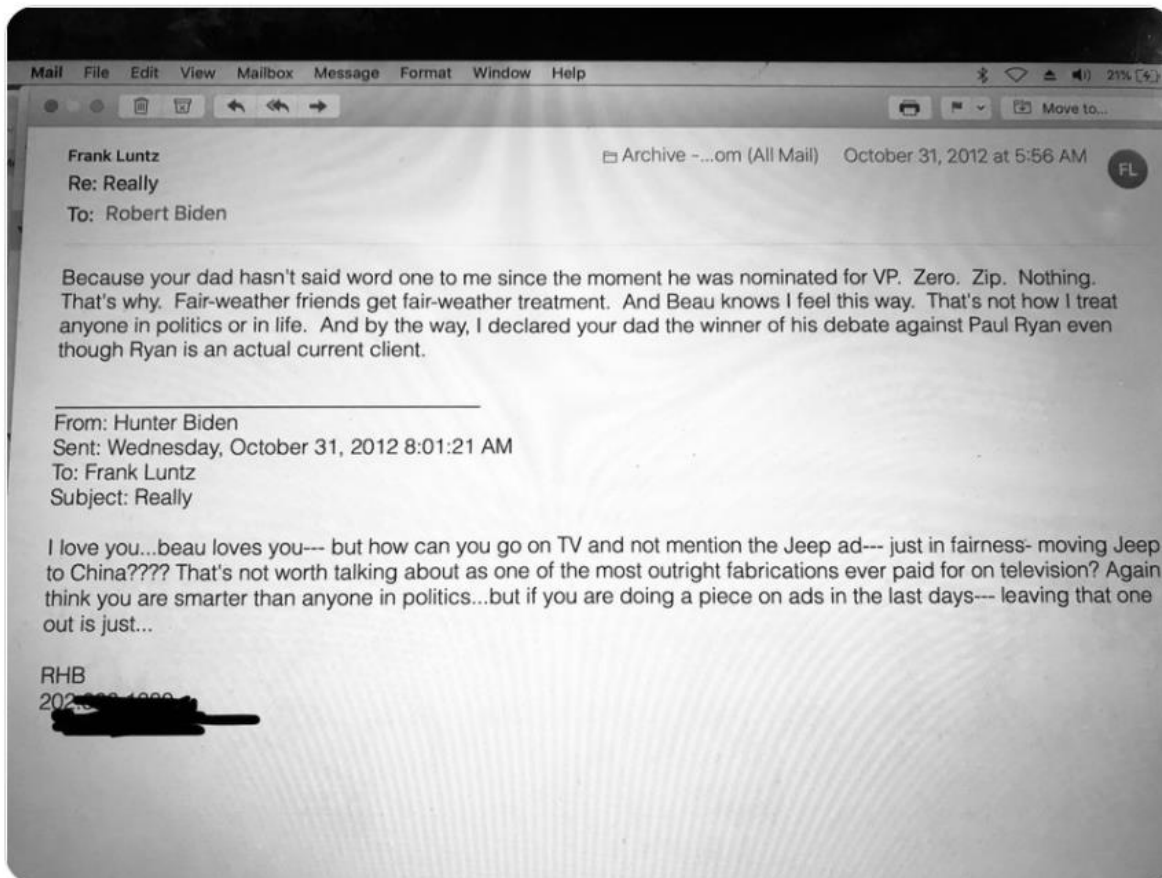

# David L. Bowdich

## Deputy Director

In March 2018, David Bowdich was appointed deputy director of the FBI. In this role, he oversees all FBI domestic and international investigative and intelligence activities.

In April 2016, Mr. Bowdich assumed the position of associate deputy director of the FBI, where he oversaw the management of all FBI personnel, budget, administration, and infrastructure. Prior to this appointment, he served as assistant director in charge of the FBI's Los Angeles Field Office from December 2014 to April 2016.

From September 2012 to December 2014, Mr. Bowdich served as the special agent in charge of the Counterterrorism Division in the Los Angeles Field Office. In that role, he led the Joint Terrorism Task Force, which was responsible for all international and domestic terrorism investigations in the Los Angeles region, surrounding counties, and the extraterritorial region of Southeast Asia. Additionally, Mr. Bowdich was responsible for all crisis management and response assets, which included the SWAT Team, Evidence Response Team, Hazardous Evidence Response Team, Underwater Search and Evidence Response Team, Rapid Deployment Team, Crisis Management Team, and special agent bomb technicians.

Mr. Bowdich began his career as an FBI special agent in 1995 in the San Diego Field Office, where he investigated violent crimes and gangs and served as a SWAT Team operator and sniper. In 2003, Mr. Bowdich was promoted to FBI Headquarters in Washington, D.C., where he served in the Criminal Investigative Division for one year and the Director's Office for one year. Mr. Bowdich returned to San Diego and supervised a multiagency gang task force for almost four years before being promoted in place to serve as the assistant special agent in charge over all non-white-collar crime criminal violations, the Imperial County Resident Agency, the SWAT Team, and the Evidence Response Team.

**Vaughn Frederick Bishop** is an American intelligence officer currently serving as the Deputy Director of the Central Intelligence Agency (CIA) since his appointment in August 2018 by President Donald Trump.<sup>[1]</sup> Bishop first joined the CIA in 1981, and retired in 2011. He returned to the CIA four years later to serve as CIA Ombudsman for Analytic Objectivity during the Agency's modernization effort.<sup>[2]</sup>

Bishop earned a bachelor's degree in political science from [Northwestern University](#) in 1968, a master's degree in 1970, and a doctorate in Political Science and African Studies in 1974. Before he joined the CIA, Bishop served as an Assistant Professor of Political Science at Emory University in Atlanta, Georgia.<sup>[2]</sup>

### CIA career [ edit ]

Bishop joined the CIA in 1981. In the early 1990s, he led the CIA's Somalia Task Force. From 1996 to 1999 he served as Chief of Station, where he focused on building key partnerships to counter terrorism. From 1999 to 2001 he was the CIA's representative to PACOM. He also lead the CIA's analytic efforts in Asia, Latin America, and Africa. From 2006 to 2009 he was responsible for forming a critical analytics partnership with a major ally. Bishop was then asked to serve as National Intelligence Officer for Africa. He rose to become the Vice Chairman of the National Intelligence Council in 2010. He retired from the CIA in 2011.<sup>[2][3]</sup>



## Jill C. Tyson

Assistant Director, Office of Congressional Affairs

Jill C. Tyson was named assistant director of the Office of Congressional Affairs in February 2019. Ms. Tyson had previously served as the acting assistant director.

Prior to joining the FBI in 2018, Ms. Tyson held a number of positions in the Department of Justice. She served as deputy assistant attorney general in the Office of Legislative Affairs, as the chief public information officer at the Federal Bureau of Prisons, and as a special assistant U.S. attorney prosecuting criminal matters in Washington, D.C.

Ms. Tyson previously worked on Capitol Hill for a former chairman of the House Judiciary Committee.

As the assistant director of the Office of Congressional Affairs, Ms. Tyson leads a team of special agents, attorneys, and professional staff, and manages all FBI interactions with Congress. She advises FBI executive leadership on congressional matters and oversees responses to congressional oversight and investigations.

Ms. Tyson is also an at-large member of the FBI's Diversity Executive Council.

Ms. Tyson graduated with a bachelor's degree from the University of Wisconsin-Madison, and received her law degree from the George Mason University Antonin Scalia Law School.

## **Alan E. Kohler, Jr.**

Assistant Director, Counterintelligence Division

Alan E. Kohler, Jr. was named assistant director of the FBI's Counterintelligence Division in April 2020. Mr. Kohler had most recently served as the special agent in charge of the Washington Field Office's Counterintelligence Division.

Mr. Kohler joined the FBI as a special agent in 1996 and worked counterintelligence matters at the Washington Field Office. He also served on the Evidence Response Team and took part in the FBI's response to the 9/11 attack on the Pentagon. In 2003, he transferred to the Counterintelligence Division to manage Russian counterintelligence investigations and was promoted to unit chief in 2004.

In 2006, Mr. Kohler transferred to the New York Field Office to supervise a counterintelligence squad and then later a squad working cyber national security and criminal matters. He served as an assistant legal attaché in London beginning in 2012, acting as the FBI's liaison with British intelligence and law enforcement agencies.

Mr. Kohler moved to the Norfolk Field Office in Virginia in 2016 as the assistant special agent in charge of the counterintelligence, counterterrorism, intelligence, and crisis management programs. He returned to FBI Headquarters in 2017 as the chief of the Eurasian Section, which manages the Bureau's operations countering Russian intelligence threats. In 2018, he was promoted to deputy assistant director in the Counterintelligence Division and managed multiple portfolios.

Mr. Kohler was promoted to the special agent in charge of the Counterintelligence Division at the Washington Field Office in 2019.

Mr. Kohler is a recipient of the Attorney General's Award for Exceptional Service, the FBI Director's Award for Outstanding Counterintelligence Investigation, and the Exceptional Achievement Medal from the Director of National Intelligence.

Before joining the Bureau, Mr. Kohler managed engineering research for a private technology firm. He has a bachelor's and a master's degree in ceramic engineering from Rutgers University.

# Laptop connected to Hunter Biden linked to FBI money laundering probe

The FBI's subpoena of a laptop and hard drive purportedly belonging to Hunter Biden came in connection with a money laundering investigation in late 2019, according to documents obtained by Fox News and verified by multiple federal law enforcement officials who reviewed them.

It is unclear, at this point, whether the investigation is ongoing or if it was directly related to Hunter Biden.

Multiple federal law enforcement officials, as well as two separate government officials, confirmed the authenticity of these documents, which were signed by FBI Special Agent Joshua Wilson. Wilson did not immediately respond to Fox News' request for comment.

One of the documents, obtained by Fox News, was designated as an FBI "Receipt for Property" form, which details the bureau's interactions with John Paul Mac Isaac, the owner of "The Mac Shop" who reported the laptop's contents to authorities.

The document has a "Case ID" section, which is filled in with a hand-written number: 272D-BA-3065729.

According to multiple officials, and the FBI's website, "272" is the bureau's classification for money laundering, while "272D" refers to "Money Laundering, Unknown SUA [Specified Unlawful Activity]—White Collar Crime Program," according to FBI documents. One government official described "272D" as "transnational or blanket."

"BA" indicates the case was opened in the FBI's Baltimore field office, sources said.

# BOMBSHELL STATEMENT: BIDEN INSIDER CLAIMS HE WAS 'RECIPIENT OF THE EMAIL', SAYS HE WITNESSED JOE, HUNTER DISCUSSING DEALS

A whistleblower CEO and Biden insider, Tony Bobulinski, released a public statement on Wednesday evening backing up the reporting of the *New York Post* from last week and claiming that he personally witnessed Democrat presidential nominee former Vice President Joe Biden discussing business deals with his son, Hunter Biden.

Sources familiar with the matter told Breitbart News that Bobulinski is the person whose allegations and inside information are the centerpiece of a forthcoming investigation by the *Wall Street Journal*. That *Wall Street Journal* story has not published yet, several days after the newspaper staff indicated to some the piece would come out—it is unclear why the *Journal* has not yet published—but President Donald Trump hinted on a conference call earlier this week that such a story was coming from the newspaper.

Bobulinski's statement also seemingly authenticates at least one of the bombshell emails obtained by the *New York Post*, purportedly from Hunter Biden's laptop retrieved from a computer repair store in Delaware. The statement also contradicts claims from some Democrats that a Russian disinformation campaign is at the center of the burgeoning scandal currently engulfing the Biden campaign in the final days of the election.

Bobulinski said in a press statement he released Wednesday night:

My name is Tony Bobulinski. The facts set forth below are true and accurate; they are not any form of domestic or foreign disinformation. Any suggestion to the contrary is false and offensive. I am the recipient of the email published seven days ago by the New York Post which showed a copy to Hunter Biden and Rob Walker. That email is genuine.

According to Bobulinski, the use of the term "the Big Guy" in one such email was a direct reference to Joe Biden himself.

In that email, originally published by the *New York Post* and subsequently by several other outlets, there was a discussion of "remuneration packages" for six people involved in a business deal with the now-bankrupt CEFC China Energy Co. Fox News described the email in a report citing an anonymous source confirming that the "Big Guy" was Joe Biden:

The email includes a note that "Hunter has some office expectations he will elaborate." A proposed equity split references "20" for "H" and "10 held by H for the big guy?" with no further details.

Bobulinski's statement would be the first on-record confirmation of this from a source in the Biden universe. Bobulinski said:

What I am outlining is fact. I know it is fact because I lived it. I am the CEO of Sinohawk Holdings which was a partnership between the Chinese operating through CEFC/Chairman Ye and the Biden family. I was brought into the company to be the CEO by James Gilliar and Hunter Biden. The reference to 'the Big Guy' in the much publicized May 13, 2017 email is in fact a reference to Joe Biden. The other 'JB' referenced in that email is Jim Biden, Joe's brother.

Screenshots published by the *New York Post* indicate that Bobulinski was one of the recipients of the email in question. The email was authored by James Gilliar of the consulting firm J2cR. Now that Bobulinski is publicly confirming the authenticity of this email, which, again, he was the recipient of, that furthers the story significantly, and Joe Biden's presidential campaign does not deny their authenticity.

That email was one of many that the *New York Post* published from Hunter Biden's laptop. Others include emails where Hunter Biden described getting a meeting for Ukrainian natural gas company Burisma executives with his father during his time as Vice President.

The emails have rocked the presidential campaign in the final weeks of the race, and Biden has called them a "smear" campaign against him.

Twitter and Facebook, when the *New York Post* first published the emails, censored the content. Twitter originally—following Facebook's lead—censored links to the original *Post* stories as "unsafe," but later reversed course after backlash. The *New York Post* has been locked out of its Twitter account for several days since the story was published.

Facebook, meanwhile, said it was preemptively holding back traffic to the stories until its fact-checkers weighed in—a rare step:

## Statement by Bobulinski.

---

My name is Tony Bobulinski. The facts set forth below are true and accurate; they are not any form of domestic or foreign disinformation. Any suggestion to the contrary is false and offensive. I am the recipient of the email published seven days ago by the New York Post which showed a copy to Hunter Biden and Rob Walker. That email is genuine.

**This afternoon I received a request from the Senate Committee on Homeland Security and Government Affairs and the Senate Committee on Finance requesting all documents relating to my business affairs with the Biden family as well as various foreign entities and individuals. I have extensive relevant records and communications and I intend to produce those items to both Committees in the immediate future.**

**I am the grandson of a 37 year Army Intelligence officer, the son of a 20+ year career Naval Officer and the brother of a 28 year career Naval Flight Officer. I myself served our country for 4 years and left the Navy as LT Bobulinski. I held a high level security clearance and was an instructor and then CTO for Naval Nuclear Power Training Command. I take great pride in the time my family and I served this country. I am also not a political**

person. What few campaign contributions I have made in my life were to Democrats.

If the media and big tech companies had done their jobs over the past several weeks I would be irrelevant in this story. Given my long standing service and devotion to this great country, I could no longer allow my family's name to be associated or tied to Russian disinformation or implied lies and false narratives dominating the media right now.

After leaving the military I became an institutional investor investing extensively around the world and on every continent. I have traveled to over 50 countries. I believe, hands down, we live in the greatest country in the world.

What I am outlining is fact. I know it is fact because I lived it. I am the CEO of Sinohawk Holdings which was a partnership between the Chinese operating through CEFC/Chairman Ye and the Biden family. I was brought into the company to be the CEO by James Gilliar and Hunter Biden. The reference to "the Big Guy" in the much publicized May 13,



2017 email is in fact a reference to Joe Biden. The other "JB" referenced in that email is Jim Biden, Joe's brother.

Hunter Biden called his dad 'the Big Guy' or 'my Chairman,' and frequently referenced asking him for his sign-off or advice on various potential deals that we were discussing. I've seen Vice President Biden saying he never talked to Hunter about his business. I've seen firsthand that that's not true, because it wasn't just Hunter's business, they said they were putting the Biden family name and its legacy on the line.

I realized the Chinese were not really focused on a healthy financial ROI. They were looking at this as a political or influence investment. Once I realized that Hunter wanted to use the company as his personal piggy bank by just taking money out of it as soon as it came from the Chinese, I took steps to prevent that from happening.

The Johnson Report connected some dots in a way that shocked me — it made me realize the Bidens had gone behind my

Bobulinski said he is the CEO of Sinohawk Holdings, which he explained "was a partnership between the Chinese operating through CEFC/Chairman Ye and the Biden family." He said he was brought on as CEO by Hunter Biden and James Gilliar, who was listed as the sender of the email.

Bobulinski went on to say he does not believe Joe Biden's past claim that he and Hunter did not discuss his son Hunter's business, claiming that Hunter "frequently referenced asking him for his sign-off or advice on various potential deals."

8. HUNTER's BHR stake (purchased for \$400,000) is now likely be worth approx. \$50 million (fees and capital appreciation based on BHR's \$6.5 billion AUM).
9. HUNTER also did business with Chinese tycoons linked with the Chinese military and against the interests of US national security.
10. BIDEN's foreign policy stance towards China (formerly hawkish), has since turned positive despite China's country's rising geopolitical assertiveness.

Less than two weeks later, on August 8, 2017, \$5 million was wired from a CEFC-affiliated investment vehicle to a Delaware LLC, which spent the next year transferring nearly \$4.8 million directly to Hunter Biden's firm, according to Senate investigators.

On Aug. 4, 2017, CEFC Infrastructure Investment (US) LLC, a subsidiary of Ye Jianming's CEFC China Energy Company that listed Gongwen Dong as its director, sent Hunter Biden's law firm, Owasco, a payment for \$100,000.<sup>375</sup> This transaction was identified for potential criminal financial activity.<sup>376</sup> One of the investment entities of CEFC Infrastructure Investment is reportedly Shanghai Huaxin Group, a Chinese state-owned enterprise "engaged in petroleum products."<sup>377</sup> That company is owned by CEFC Shanghai International Group Ltd., which is controlled by Shanghai Guosheng Group, another state-owned enterprise.<sup>378</sup> According to reporting, CEFC Shanghai was a CEFC subsidiary linked to the aforementioned corruption allegations involving the head of the China Development Bank.<sup>379</sup> These examples further illustrate the deep financial connections between Biden, Owasco, and the Chinese government.

On Aug. 8, 2017, CEFC Infrastructure Investment wired \$5 million to the bank account for Hudson West III.<sup>380</sup> These funds may have originated from a loan issued from the account of a company called Northern International Capital Holdings, a Hong Kong-based investment company identified at one time as a "substantial shareholder" in CEFC International Limited along with Ye.<sup>381</sup> It is unclear whether Hunter Biden was half-owner of Hudson West III at that time. However, starting on Aug. 8, the same day the \$5 million was received, and continuing through Sept. 25, 2018, Hudson West III sent frequent payments to Owasco, Hunter Biden's firm.<sup>382</sup> These payments, which were described as consulting fees, reached \$4,790,375.25 in just over a year.<sup>383</sup>
