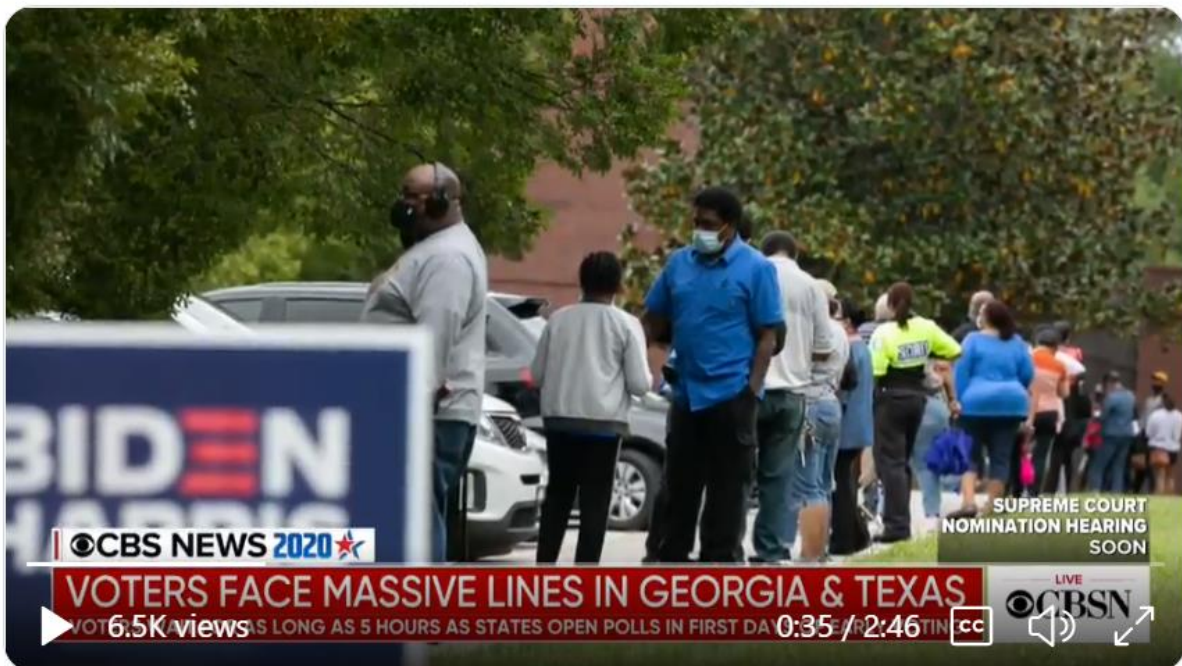

# U.S. Pushes Three Weapons Deals With Taiwan to Counter Chinese Invasion Threat

**P**resident Donald Trump's administration is pushing ahead with a raft of weapons sales to Taiwan, as the democratic island faces increasing pressure from China over its continued independence.

Multiple reports on Monday indicated that the White House has sent notifications of three of seven planned Taiwan weapons deals to Congress for approval, in a move that underscores the administration's backing for Taipei in the face of an increasingly assertive Chinese Communist Party.

Reuters was the first to report Congressional notification for the three deals. The agency said the deals are for the High Mobility Artillery Rocket System (HIMARS) from Lockheed Martin, Boeing's Standoff Land Attack Missile-Expanded Response, and external sensor pods for F-16 fighter jets.

The other weapons deals not yet sent to Congress for approval include advanced aerial drones, land-based anti-ship missiles and underwater mines. All will be intended to deter an amphibious Chinese landing. Reuters sources said notifications for the remaining four deals would be sent to lawmakers soon.

The U.S. has long supported Taiwanese independence through weapons sales, despite repeated protests from Beijing. The Chinese government has repeatedly warned that U.S. weapon sales to the island threaten regional peace and put Taiwan in a more dangerous position.

Though Washington, D.C. does not officially recognize Taiwan, it has an implicit commitment to defend the island against Chinese invasion per the 1979 Taiwan Relations Act.

Taiwan has been independent since the end of the Chinese Civil War, as the last bastion of the defeated nationalist forces. The CCP has always vowed to bring the island under its control as part of its "One China" policy, whether through diplomatic means or force of arms.

China demanded the U.S cancel it talks with Taiwan warning it would take “legitimate and necessary” action.

# China Threatens U.S. With 'Necessary Reaction' for Selling Weapons to Taiwan, Warns India and Japan Over Territory

China has warned it would take new measures in response to a planned U.S. arms sale to Taiwan, a self-ruling island claimed by Beijing, which also called out Washington partners India and Japan over territorial disputes across Asia.

Chinese Foreign Ministry spokesperson Zhao Lijian decried the sale of three advanced weapons systems to Taiwan. He called it a violation of the longstanding agreements by which Washington has foregone direct ties with Taipei in favor of Beijing.

"The United States has seriously violated the one-China principle, and the provisions of the three China-U.S. joint communiqués, especially the August 17 communique," Zhao said, "by selling arms to Taiwan, seriously interfered in China's internal affairs and seriously harmed China's sovereignty and security interests."

"China firmly opposes this," he warned, calling on the U.S. side "to fully recognize the very damaging nature of its arms sales to Taiwan, abide by the one-China principle and the provisions of the three China-U.S. joint communiqués, immediately cancel all arms sales plans to Taiwan, and stop arms sales to Taiwan and military ties between the United States and Taiwan."

Without specifying, Zhao said there would otherwise be consequences to Washington's decision.

"China will make a legitimate and necessary reaction in the light of the development of the situation," Zhao said.

News of [the approval of the three weapons systems](#) reportedly came in the way of an informal congressional notification passed on to House Foreign Relations Committee and Senate Foreign Affairs Committee leadership, as several outlets such as Reuters, *The Hill* and Defense News reported.

## Exclusive: White House advances drone and missile sales to Taiwan - sources

WASHINGTON (Reuters) - The White House is moving forward with more sales of sophisticated military equipment to Taiwan, telling Congress on Tuesday that it will seek to sell MQ-9 drones and a coastal defensive missile system, five sources familiar with the situation said.

These possible sales follow three other notifications first reported by Reuters on Monday that drew China's ire in the run-up to the Nov. 3 U.S. election.

China considers Taiwan a wayward province that it has vowed to reunite with the mainland, by force if necessary.

Reuters broke the news in September that as many as seven major weapons systems were making their way through the U.S. export process as the Trump administration ramps up pressure on China.

The pre-notification to Congress for the MQ-9 drone case is the first after President Donald Trump's administration moved ahead with its plan to sell more drones to more countries by reinterpreting an international arms control agreement called the Missile Technology Control Regime (MTCR).

Tuesday's other congressional pre-notification was for land-based Harpoon anti-ship missiles, made by Boeing Co, to serve as a coastal defense against cruise missiles.

The U.S. Senate Foreign Relations and House of Representatives Foreign Affairs committees have the right to review, and block, weapons sales under an informal review process before the State Department sends its formal notification to the legislative branch.

US envoy Marshall Billingslea said the U.S and Russia have reached an agreement in principle to extend the New START nuclear arms treaty that expires in February.

- The details of the treaty have yet to be worked out.
- The U.S. hopes the treaty can be extended to China when they're ready to come to the negotiating table.
- China has a small but quickly growing nuclear arsenal.

## US and Russia reach 'gentleman's agreement' on extending New Start nuclear pact

The United States said Tuesday it had reached an "agreement in principle" with Russia on extending New Start, the two nations' last major nuclear accord, which is due to expire in February.

President Donald Trump's administration has been insisting without success that China enter the nuclear reduction agreement but, with US elections three weeks away, signalled it was willing to keep the treaty largely as is for now.

"We are in fact willing to extend the New Start treaty for some period of time provided that they, in return, agree to a limitation – a freeze – on their nuclear arsenal," US negotiator Marshall Billingslea said.

"We believe that there is an agreement in principle at the highest levels of our two governments," he said at the Heritage Foundation think tank.

Billingslea cut short a trip to Asia last week to meet his Russian counterpart in Helsinki, saying he sensed a mood for compromise.

He said that Russia still needed to give final approval to the "gentleman's agreement" and give authority to nail down the details.

"We are ready to strike this deal. We can strike it tomorrow, in fact. But Moscow is going to have to show the political will to do so as well," he said.

Billingslea said that the United States was still insisting on the participation of China – whose nuclear programme is quickly growing but is still a fraction the size of the Russian and US arsenals.

"Everything we agree with the Russians must be framed and must be formatted in a way that allows us to extend that arrangement to the Chinese when they are finally brought to the negotiating table," Billingslea said.

# Trump administration demands think tanks disclose foreign funding

**What happened:** The Trump administration is demanding that U.S. think tanks and academic institutions publicly disclose what funding they receive from foreign governments or otherwise risk losing access to State Department officials.

The move, unveiled in a statement Tuesday by Secretary of State Mike Pompeo, comes amid growing bipartisan concern about the role outside governments, ranging from China to the United Arab Emirates, play in shaping academic and policy debates in the United States.

“To protect the integrity of civil society institutions, the [State] Department requests henceforth that think tanks and other foreign policy organizations that wish to engage with the department disclose prominently on their websites funding they receive from foreign governments, including state-owned or state-operated subsidiary entities,” Pompeo said in the statement.

“Disclosure is not a requirement for engaging with such entities,” he added. “Department staff will, however, be mindful of whether disclosure has been made and of specific funding sources that are disclosed when determining whether and how to engage.”

Today, Russia, China, Pakistan and Cuba were added to the UN Human Rights council.

# Mark Zuckerberg, Priscilla Chan donate \$100 million more to U.S. election infrastructure

(Reuters) - Facebook Inc Chief Executive Officer Mark Zuckerberg and his wife, Priscilla Chan, said on Tuesday that they will donate an additional \$100 million to support election officials and fund infrastructure for the U.S. election in November.

# Ghislaine Maxwell Urges U.S. Appeals Court to Keep Damaging Deposition Secret

NEW YORK (Reuters) - A lawyer for Ghislaine Maxwell pressed a federal appeals court on Tuesday to overturn a ruling that the longtime associate of late financier Jeffrey Epstein says jeopardizes her ability to defend against criminal charges she enabled his sexual abuse of girls.

Maxwell's lawyer Adam Mueller told the 2nd U.S. Circuit Court of Appeals in Manhattan that releasing Maxwell's sworn April 2016 deposition, which was taken in a separate civil case, threatened to undermine her trial scheduled for next July.

The British socialite has said bad publicity from disclosing "intimate, sensitive, and personal" details from the deposition would violate her right against self-incrimination, and imperil a fair trial because prospective jurors may hold it against her.

"We're concerned about preserving the status quo," Mueller told a three-judge panel in a nearly 2-1/2-hour hearing. "There's going to be a public criminal trial, and this will all be aired in open court ... We think that vindicates the public interest."

Maxwell, 58, has pleaded not guilty to charges she helped Epstein recruit and groom underage girls as young as 14 years old to engage in illegal sexual acts in the mid-1990s, and not guilty to perjury for having denied involvement under oath.

Her 418-page deposition came from a long-settled defamation lawsuit by Virginia Giuffre, who has said Epstein kept her as a "sex slave" with Maxwell's help.

U.S. District Judge Loretta Preska ordered the deposition unsealed in July, saying Maxwell did not overcome the presumption the public had a right to see it.

Mueller, however, said the deposition was filled with suggestive questions akin to "when did you stop beating your wife," and that Maxwell's denials to certain questions could be as "revealing" as her admissions.

"It certainly implies that the other side has an evidentiary basis to ask the question," he said.

David Boies, a lawyer for Giuffre, countered that there was a "substantial presumption" of public access, but drew skepticism from the panel about why his client deserved it.

"What does she care about it?" Circuit Judge Rosemary Pooler asked. "Sure she wants the whole thing out, but

# Trump personnel office weighs asking appointees to offer their resignations

The potential plan is angering officials who fear it will cause chaos in their personal lives as they plot their next moves.

The White House Presidential Personnel Office is considering asking nearly every political appointee in the Trump administration to write and tender provisional letters of resignation right before the election, according to two senior administration officials.

The personnel office would then decide which ones to accept and which to reject — giving President Donald Trump maximum flexibility in choosing his team in a possible second term.

The potential maneuver has angered some officials as appointees calculate their next career moves — weighing their loyalty to the president and his agenda against the danger that he may lose in November and leave them scrambling for gainful employment.

“It’s a rotten way to treat people who risked their own reputations and career paths to join the administration and have been working tirelessly to get the president over the finish line,” said one of the officials, who spoke on condition of anonymity so as to not publicly antagonize the White House.

The personnel office is led by Johnny McEntee, a 30-year-old former Trump body man who has sought to replace political appointees seen as unreliable allies of the president with unquestionably loyal devotees of Trump.

McEntee, who traveled frequently with Trump before the White House was struck by a coronavirus outbreak, has clashed with some top agency officials over his efforts to install loyalists throughout the executive branch. In some cases, the new appointees had not even finished college at the time of their arrival.
