But we heard over and over, gee, FBI Director Comey would never do anything but absolutely perfectly above-board.

But then this article by Patrick Howley, 10 September, came out. I was shocked. But here are some holdings. HSBC Holdings the article mentioned. "In 2013, Comey became a board member, a director, and a Financial System Vulnerabilities Committee member of the London bank HSBC Holdings. stance, HSBC Holdings has partnered with Deutsche Bank through the Clinton Foundation to 'retrofit 1,500 to 2,500 housing units, primarily in the low- to moderate-income sector' in 'New York City.'"

"When our source called the Chintown offices of D.C. law firm DLA Piper and asked for 'Peter Comey,' a receptionist immediately put him through to Comey's direct line. But Peter Comey is not featured on the DLA Piper website.

"Peter Comey serves as 'Senior Director of Real Estate Operations for the Americas' for DLA Piper.

"James Comey was not questioned about his relationship with Peter Comey in his confirmation hearing. DLA Piper is the firm that performed the independent audit of the Clinton Foundation in November during Clinton-World's first big push to put the email scandal behind them. DLA Piper's employees taken as a whole represent a major Hillary Clinton 2016 campaign donation bloc and Clinton Foundation donation base.

"DLA Piper ranks number 5 on Hillary Clinton's all-time career Top Contributors list, just ahead of Goldman Sachs. And here is another thing: Peter Comey has a mortgage on his house that is owned by his brother" James Comey, the FBI director. Peter Comey's financial records obtained by Breitbart News showed that he "bought a \$950,000 house in Vienna, Virginia, in June 2008. He needed a \$712,500 mortgage from First Savings Mortgage Corporation.

"But on January 31, 2011, James Comey and his wife stepped in to become Private Party lenders. They granted a mortgage on the house for \$711,000."

Anyway, it is just rather interesting: Who had any idea that the Comey family had such ties to the Clinton Foundation?

"Peter Comey redesigned the FBI building."

"Procon Consulting's client list includes 'FBI Headquarters, Washington, D.C.'"

"So what did Procon Consulting do for FBI headquarters? Quite a bit, apparently. According to the firm's records: Procon provided strategic project management for the consolidation of over 11,000 FBI personnel into one, high security, facility."

Then it goes on. As the article ends, it says:

"This is not going to end well."

Well, fortunately, for Hillary Clinton, the investigation with the Clinton Foundation ties to the FBI director has ended well for her.

## Next declassification could flip Russia collusion script, point to effort to hurt Trump

The Trump administration is preparing one of its biggest declassifications yet in the Russia case, a super-secret document that could flip the collusion theory on its head four years after the FBI first started its investigation.

Multiple officials familiar with the planned declassification, which could happen as early as this week, told Just the News that the new evidence will raise the specter that Russian President Vladimir Putin was actually trying to hurt President Trump, not help his election in 2016, as the Obama administration claimed.

The new evidence would complement a revelation last week that the primary source for the Christopher Steele anti-Trump dossier was known to the U.S. government to be tied to Russia intelligence, raising the possibility that the Russians were undercutting the GOP nominee.

Senate Judiciary Committee Chairman Lindsey Graham, R-S.C., hinted at the big revelation in a Sunday appearance on the Fox News show "Sunday Futures with Maria Bartiromo."

"Everything Russia-Trump was looked at. You had \$25 million, 60 agents. You had subpoenas, you had people's lives turned upside down," Graham said. "The question is, 'Did they look at Russia coming after Trump?'"

Referring to last week's revelation, Graham added: "We've got a Russian spy on the payroll of the Democratic Party putting together a document that details the FBI was not reliable."

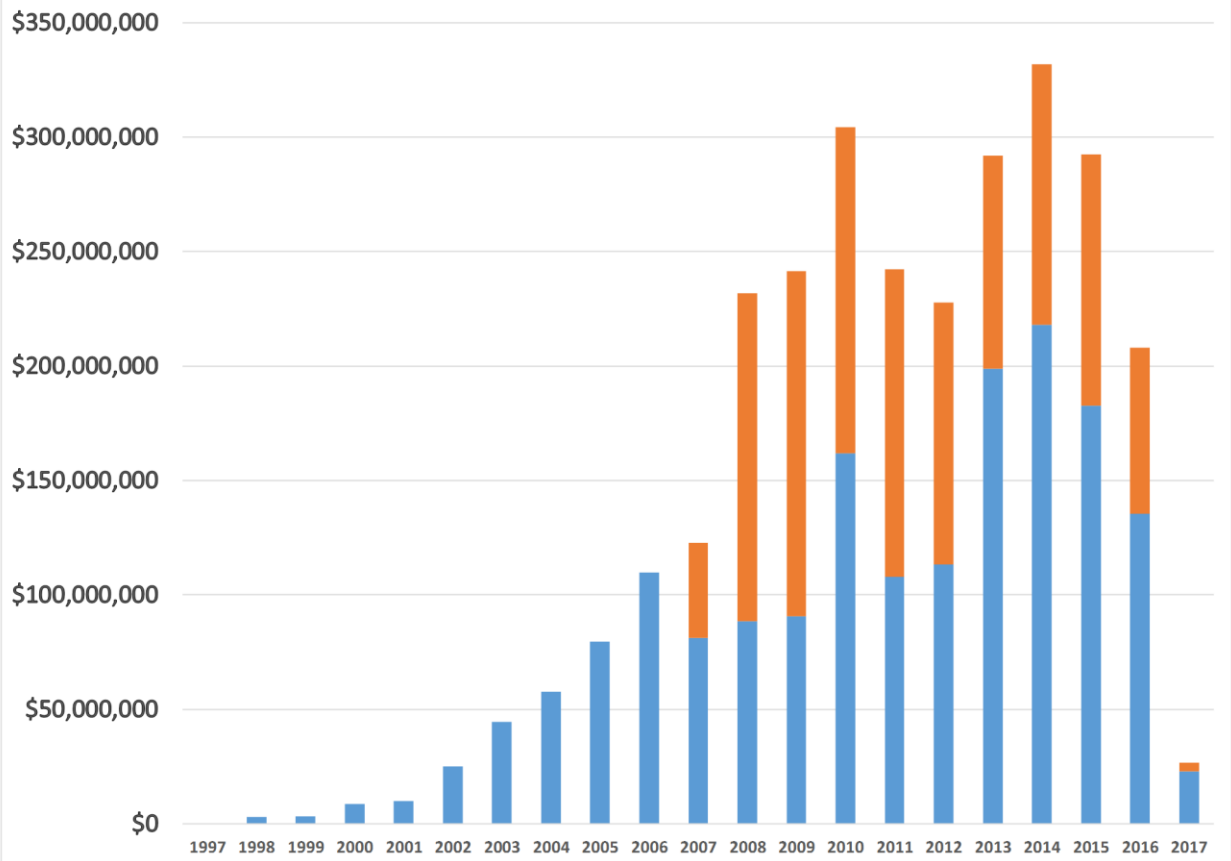

[In 2010](#), Lockheed Martin won 17 approvals for private contracts from the Hillary Clinton State Department.

### **HSBC Holdings**

In 2013, Comey [became a board member, a director, and a Financial System Vulnerabilities Committee member](#) of the London bank HSBC Holdings.

Rosenstein graduated summa cum laude from the Wharton School of Business at the University of Pennsylvania, with a B.S. in Economics. He received his J.D. degree cum laude from Harvard Law School, where he was an editor of the Harvard Law Review. After law school, he served as a law clerk to Judge Douglas H. Ginsburg, United States Court of Appeals for the D.C. Circuit.

Rich and his partner, Pincus Green, (also pardoned), were indicted in the SDNY in September 1983, for numerous charges including mail fraud, wire fraud, tax evasion, and racketeering. Shortly after Rich and Green were indicted, the pair fled to Switzerland, where they have lived in exile and have remained fugitives. Rich and Green were partners in a commodities business, and were also indicted for several counts of illegal trading for conducting business with Iran during the 1980 hostage crisis. Rich and Green were two of approximately 140 individuals who were pardoned by Clinton.

Pursuant to testimony provided at the aforementioned hearings, it appears that the required pardon standards and procedures were not followed. DOJ rules and regulations governing the issuance of pardons requires that the pardon attorney at DOJ receive a formal pardon application to commence a pardon investigation. That investigation would include contact with the respective U.S. Attorney's office and investigative agencies. Based upon the findings of that investigation, a recommendation is made by the pardon attorney to the White House for the President's review and consideration. U.S. Pardon Attorney, Roger Adams, testified before the Senate Judiciary Committee on 2/14/01 that with respect to Rich and Green, "none of the regular procedures were followed." Former Deputy Attorney General Eric Holder previously testified that he was the only person at DOJ notified of the pardon sought by Rich. Holder was contacted directly by Jack Quinn, Marc Rich's attorney, and former White House Counsel.
