**3. Meeting between Comey and Coleman on October 4**

Comey's Outlook calendar for October 4 contains an entry for "Morning Briefs" from 8:15 a.m. to 9:00 a.m. that is immediately followed by an entry for "Meeting w/EAD Coleman" from 9:00 a.m. to 9:30 a.m. Coleman told us that he could not recall this briefing with Comey. Coleman stated that staying behind to brief Comey would be consistent with normal practice, but added that he did not recall this specific instance. Coleman told us that it would be unusual to have a one-on-one meeting with Comey and told us someone else would typically be present at these briefings, such as the DD or ADD. While not remembering this meeting, Coleman speculated that this may have been a one-on-one meeting with Comey to discuss Coleman's upcoming retirement from the FBI in December 2016.

Coleman told us that he kept regularly took notes in a journal. Coleman's notes from October 4 contained the following entry:

We asked Coleman about these notes and he told us that, given their placement in his notebook, the notes would most likely represent information he was briefed on first thing in the morning by his subordinates in the Criminal Investigative Division. Coleman stated that he may have passed this information to other FBI executives after the morning briefing with the Director, but he could not remember if that occurred here.







Back in 2011, the indomitable Peter Schweizer published *Throw Them All Out*, a detailed examination of political corruption as it is actually practiced in the halls of Congress.

We saw the first results of this approach last Friday – in dealing with Andrew McCabe, this century's prime example of a "cookie full of arsenic."

Sessions melted until the FBI's Office of Professional Responsibility (which is run by Assistant Director Candice Will, who was appointed by Robert Mueller, of all people) recommended that McCabe be fired. He then had McCabe officially informed beforehand, following established procedure to the letter.

This comes under the rubric of "strategy," a concept unfortunately foreign to too many active conservatives. A large number of cons recognize only one course of action: a headlong charge against the closest target while howling at the top of their lungs. Not only do they deem it any more subtle form of action, but they often attack those engaging in it of cowardice or corruption, or of being an "Alinskyite-Obamaist commie stooge" – despite the fact that their kamikaze runs usually end up heading over the nearest cliff.

So it was with Sessions, who has been routinely dismissed as "paid off," being "asleep under his desk," or as "part of the swamp."



After college, Laybourne had various jobs. From 1969 to 1970, Laybourne worked at Wallace, Morgan, Roberts and Todd, an architecture firm in Philadelphia.<sup>[1]</sup> From 1972 to 1973, she worked as a teacher at Concord Academy in Concord, Massachusetts. Then from 1974 to 1976, Laybourne worked as a festival coordinator of the New York American Film Festival.<sup>[2]</sup>

In 1974, she co-founded the Media Center for Children, which she was involved with until 1977.<sup>[3]</sup> Laybourne said she founded the Media Center for Children because she was concerned about the media her children were watching.

From 1978 to 1980, she was a partner at Early Bird Special Company in New York.<sup>[4]</sup>

**Nickelodeon (1980-1996)** [ edit ]

In 1980, Laybourne was hired as a program manager at Nickelodeon, a year-old network, where she initiated the focus-group approach to programming. Laybourne was one of the first people to focus on television programming for kids. She spent 15 years at Nickelodeon, taking over the management of the network, and started accepting advertising for the network, in 1984.<sup>[5]</sup>

Laybourne and her team were responsible for creating and building the Nickelodeon brand, launching *Nick at Nite* and expanding the network by establishing it in other countries, developing theme parks and creating Nickelodeon magazine, movie, toy and publishing divisions.<sup>[6]</sup><sup>[7]</sup><sup>[8]</sup><sup>[9]</sup>

Under her leadership, Nickelodeon became the top-rated 24-hour cable programming service and won Emmy Awards, Peabody Awards, CobiMACE Awards and Parents' Choice Awards. The network had a 40% profit margin and explosive growth every year.<sup>[9]</sup>

Laybourne built Nickelodeon into the first global television network to profit from selling advertising targeted towards children. Her programming approach, which made a point of talking to children as equals, built the tiny cable network, which had only five employees in 1980, into an \$1 billion business.<sup>[11]</sup>

**Disney (1996-1998)** [ edit ]

Laybourne left Nickelodeon in 1996 to become president of Disney-ABC Cable Networks, guiding the growth and overseeing the programming of the Disney Channel and represented the corporate interests in Lifetime, A&E, E!, and The History Channel. She led the development two projects that did not come to fruition: ABC 24 Hour News cable channel and ABZ, an innovative education channel. Laybourne played a role in the creation and management of ABC's Saturday morning children's programming schedule, with the successful launch of One Saturday morning. She's said to have let stiffed by the corporate structure at Disney.<sup>[12]</sup>

**Oxygen Media (1996-2007)** [ edit ]

In 1998, Laybourne left Disney and partnered with Oprah Winfrey and Carney-Werner Productions to create Oxygen Media, a cable TV company dedicated to creating television and Internet programming for women.
