Donald Trump Has Promoted QAnon-Linked Twitter Accounts More Than 250 Times

President Donald Trump said he knows "nothing" about QAnon during NBC's Town Hall, despite previously describing them as "people that love our country" and frequently promoting accounts linked to the conspiracy theory on Twitter.

Trump has been criticized after he failed to denounce or even criticize the movement, which believes Trump is secretly fighting a "deep state" satanic pedophile ring involving high-profile Democrats, when pressed to do so by host Savannah Guthrie.

"Can you just once and for all state that that is completely not true and disavow QAnon in its entirety?" Guthrie asked.

"I know nothing about QAnon, I know very little," Trump said.

"Let me just tell you what I do hear about it is they are very strongly against pedophilia and I agree with that."

After Guthrie brings up the baseless suggestion of there being a "satanic pedophile cult," Trump replies: "I know nothing about it. I don't know that and neither do you know that."

Trump was also asked why he recently shared an unhinged theory with ties to QAnon which claimed Joe Biden ordered a helicopter full of NAVY Seals be shot down to cover that Osama bin Laden's body double was actually killed during the raid in 2011 under the Barack Obama regime.

"That was a retweet, that was an opinion of somebody. I'll put it out there, people can decide for themselves" Trump said.

As if to irritate the press even more, POTUS retweeted CJ Truth this morning.

[Twitter](#) on Friday reversed its controversial editorial decision to block users from sharing a New York Post story that claims to show “smoking gun” emails related to Democratic presidential nominee Joe Biden and his son.

The company and rival [Facebook](#) on Wednesday made the unprecedented decisions to block or limit the distribution of the news article. The unverified story alleges that Hunter Biden attempted to introduce an executive at the Ukrainian company he worked for to his father, who was the vice president of the United States at the time.

Twitter later said it had blocked the article because it contained images of hacked material with personal and private information. It then clarified that discussion or commentary on the hacked materials should not be banned.

Twitter CEO [Jack Dorsey described](#) the company’s initial decision to block the article without explaining its reasoning as “unacceptable.”

Former New York City Mayor [Rudy Giuliani](#) says he spent three weeks authenticating the materials on a copy of a hard drive that once allegedly belonged to [Hunter Biden](#), the son of Democratic presidential nominee [Joe Biden](#).

The contents of the drive are the subject of a series of explosive [reports](#) by the [New York Post](#) that shed further light on Hunter Biden's dealings with [China](#) and [Ukraine](#).

Giuliani, President Donald Trump's personal attorney, told The Epoch Times that he and his attorney, Robert Costello, checked some of the written notes in the drive against samples of Hunter Biden's handwriting, matched details about undisclosed meetings with confidential information they had already obtained from other sources, and verified the email addresses in the data trove, among other steps. Giuliani said the drive contains roughly 800 of Hunter Biden's personal photos, including some which Giuliani alleges show illegal acts. The Epoch Times could not independently verify the claim as Giuliani declined to provide a copy of the files.

Costello allegedly received a copy of the hard drive in August from the owner of a Mac repair shop in Wilmington, Delaware, and handed it to Giuliani three weeks ago, according to the former mayor. Trump's former chief strategist, Stephen Bannon, negotiated an exclusive deal with the Post and Giuliani handed a copy of the drive over to the newspaper on Oct. 10. The Post conducted its own authentication effort, Giuliani said.

The exclusive deal with the Post gave the newspaper a head start on covering the material but allows Giuliani to eventually begin disclosing the material to other media, the former mayor said.

Along with the copy of the drive, the owner of the Mac repair shop gave Costello a receipt dated April 12, 2019, which he allegedly

According to the *Post*, a laptop was dropped off at a Delaware computer repair shop by a man believed by the owner, John Paul Mac Isaac, to be Hunter Biden. The shop owner made a copy of the hard drive before turning it over to the FBI, which includes incriminating emails detailing alleged Biden family corruption in Ukraine and China, as well as a 'raunchy, 12-minute video that appears to show Hunter smoking crack while engaged in a sex act with an unidentified woman,' as well as 'numerous other sexually explicit images.'

FBI agent Wilson's identity was confirmed by both *Western Journal* and *Business Insider*, the latter of which compared his signature to a 2012 criminal complaint and concluded that it "clearly matches the unreversed signature on the subpoena published by the *New York Post*."

Trump reverses course, approving assistance for California wildfires

President Trump late Friday reversed course on providing assistance for California's wildfires, granting the request just hours after denying it.

California has had its most devastating wildfire season in history, currently battling 12 major fires that have burned through more than 4 million acres, according to [figures](#) released by the state yesterday.

The White House and the Federal Emergency Management Agency (FEMA) initially said California hadn't made a strong enough case for assistance with the September fires that cost the state more than \$229 million.

The White House credited House Minority Leader [Kevin McCarthy](#) (R-Calif.) along with Gov. [Gavin Newsom](#) (D) for changing the president's mind.

"The governor and Leader McCarthy spoke and presented a convincing case and additional on-the-ground perspective for reconsideration leading the president to approve the declaration," the White House said in a statement.

Earlier Friday, White House spokesman [Judd Deere](#) told The Hill that California's submission was "was not supported by the relevant data" states must provide to be considered for a disaster declaration, adding that the president's decision concurred with that of the Federal Emergency Management Agency (FEMA) administrator.

Lizzie Litzow, a spokesperson for FEMA, told The Hill that damage assessments of the early September wildfires "were not of such severity and magnitude to exceed the combined capabilities of the state, affected local governments, voluntary agencies and other responding federal agencies."

A White House disaster declaration grant is a huge help to states, allowing for reimbursement of 75 percent of firefighting, evacuation and sheltering costs.

In a Sept. 28 letter to the White House, Newsom said the funds were especially needed as the COVID-19 pandemic has already "significantly damaged" the state's economy.

(CNN) — White House national security adviser Robert O'Brien on Friday rejected Russian President Vladimir Putin's proposal to [extend New START](#), a key arms control treaty, for one year without any additional agreements, calling the offer a "non-starter."

"The United States proposed an extension of New START for one year, in exchange for Russia and the United States capping all nuclear warheads during that period. This would have been a win for both sides, and we believed the Russians were willing to accept this proposal when I met with my counterpart in Geneva," O'Brien said in a statement released on the White House's National Security Council Twitter feed.

"President Putin's response today to extend New START without freezing nuclear warheads is a non-starter," he said.

He threatened a "costly" arms race if Russia does not come back to the table with a better proposal: "The United States is serious about arms control that will keep the entire world safe. We hope that Russia will reevaluate its position before a costly arms race ensues."

Trump has been urging his national security team to secure a nuclear deal with Russia before the November election, sources familiar with the efforts tell CNN. He had initially wanted to bring China into the deal, but China has repeatedly rejected partaking in any discussions. Russia has now also rejected a number of US proposals to get it to agree to a series of additional commitments in order to renew New START.

In response to a lawsuit by BuzzFeed News, the government said that just because Trump demanded that the Russia investigation be declassified, it doesn't mean he wanted the Russia investigation to be declassified.

A federal judge Friday ordered the Justice Department to find out directly from President Donald Trump whether he really intended to declassify all Russia investigation documents without redactions when he tweeted exactly that last week.

The judge's directive was issued in response to two emergency motions filed last week by BuzzFeed News seeking the immediate release of Russia-related documents in response to Trump's tweets.

The move by the judge could be a watershed moment for those who have gone to court and sought the release of records based on the president's tweets. For nearly four years, the government's position has been that Trump's tweets should not be taken literally, while in other instances the government has argued that they're official statements.

During an extraordinary 30-minute hearing Friday morning, US District Court Judge Reggie Walton rejected a government attorney's assertion that Trump's Oct. 6 tweets were "ambiguous" and should not be interpreted as orders to declassify anything specific.

Matt Topic, an attorney representing BuzzFeed News, disagreed. He told Walton there can't be anything more clear than Trump's tweet that called for the release of every document from the Russia probe without any redactions.

Walton also disagreed with the government's stance. He said Trump's tweets in which the president stated he has "fully authorized the total Declassification of
