You are just making up claims that don't exist, just as Max did many times about us long ago, and who was routed out as an Intel Operative for these lies and slander he was peddling, and there were many.

If we are a cult, then all our ancestors not so long ago, before "The System" came along with its invasions and forced integration, were cult members living in the cults of villages, communities and tribes, all of them taking full responsibility for their lives, a natural attribute you and Max endorse as being cultish.

The Love For Life (LFL) insights we've been freely sharing since 2005, are mostly analogies and metaphors used to create simple, idiot friendly pictures into how the ocCULTS really work, and what to do to get out of

these covert systems of slavery in/as this life, pushing it all out there for anyone who is serious about getting out of this man-made hell, "The System" in/as this life.

Unlike cult leaders, we never tell people how to live their lives and who they really are; we just show people what is NOT their real lives and how they have been hoodwinked. From there, it is up to them to decide what they do, if anything.

We realised long ago that we cannot rescue anyone, just as no one can rescue us. A community of people following a leader is NOT what we are interested in. A community of people each taking full responsibility for their lives and coming together from strength and sharing freely rather than from weakness and neediness with strings attached is what we are all about.

We already live in a system of leaders and followers and look where that has got us. The fact is, most are so used to being spoon fed in just about every aspect of their lives, most of them are looking for leaders, even though they are in denial about it. This is why they are still waiting for others to fix the problem for them.

Just because we are deeply passionate about sharing truthful information freely for anyone dreaming to really wake up and get out of this distracting maze of a deep sleep rooted in lies and confusion, does not mean we are a cult.

Since 2005, we have intensely stated throughout almost all our LFL work "Do Not Believe Anything We Say, Instead Use Intense Scrutiny & Contemplation & Keep Going Where The Logic (Senses) Of Truth Takes You - Put Everything You Think And Feel Up To The Test Of Scrutiny Including All Your Belief Systems And See If They Stack Up".

When confronted, Max could not find lies amongst our vast body of insight work and was unable to back up his accusations of Arthur lying and misleading people, even though he was cordially invited to share the recordings of a phone call between him and Arthur that he claimed backed up his accusations (he had not told Arthur that he was recording the phone call at the time).

After a lot of pushing, he posted the recording, in front of an audience of thousands on Facebook and elsewhere, and many saw that his accusations were false. We also posted all the correspondence of the time because we keep everything in case of slander, fraud and lying.

This was all played out in Facebook and many people saw his true colours and commented on them. He is very intellectually clever but he dug himself into a hole with this one. His sister also got involved in the intense discussion going to and fro but backed off when it was obvious she had nothing to offer but noise and slander.

Max tried to make out that others revealed the secret of the "NAME" (Birth Certificate) which was my work and gave him copies of the 2005 emails we had sent out.

Max assumed that the exposure of the "Commonwealth Of Australia" registered as a private corporation in the UCC was done by others when in fact it was done by a few friends we were closely involved with back in 2005.

This small research group showed that all members of the Bar, the courts, all government depts, etc, etc, were registered NRG Private Corporations inside ASIC, and our little group downloaded hundreds of these NRG registrations (we still have copies of it all) before ASIC removed them all within 36 hours of us downloading as many as we could.

We used the large email network databases LFL was registered to back then to notify all members across earth of this evidence our group discovered in 2005 and we gave Max samples of these sent emails to shut him up and to stop his slander.

Rather than focus on the material in hand and debate that, Max chose to make things personal, just as you are doing, Robbie. Why not debate the information with us, instead of going down the path of character assassinations, scare mongering, controversies and fabrications?

If you can find any lies in what we are sharing, we would be delighted for you to point them out and, if you are right, we will correct anything that needs doing so, and apologise accordingly in the public domain. We are

interested in going where the truth takes us, not in hanging onto a stance to grim death just for the sake of it.

A lie is a curse and it is very important to us not to lie, which is why we will clean up if anything we are sharing is proven to be a lie. We are not interested in processing curses.

By choosing to make things personal, people like Max create only confusion and chaos, with the intent to stop others still vulnerable to trauma from waking up and going where the truth takes them because they are scared off by the arguments, scaremongering and nit picking.

There are many intelligence agents floating around, starting up or joining groups of those interested in resolving the problems of "The System" and their main tactic is to cause conflict, confusion and controversy to scare others away = "WE WILL LEAD EVERY REVOLUTION AGAINST US".

Whereas we always provide full disclosure about who we are and our intentions, intel operatives don't because they have to control the outcomes to appease their masters. Their job is to keep people in the Matrix, to stop them from really waking up = "The Greatest Lie & Liar Is The One Closest To The Truth - They Cause The Greatest Damage Of All Because The Duped Learnt To Trust Them - If They Can Get You To Dream/Think What They Want You To Think/Dream And Get You To Direct Your Life Energy (Focus) Into These Dreams/Thoughts, They Will Get You To Create That - Slaves Willing Create A World In Their Masters Image Without Realising", the basis (black-magic) of all Satanic/ocCULTic/Freemasonic practices.

Where we provide the full disclosure of the big picture we hold, Intel Operatives never go all the way because it will free up many spoon fed sheeple from being sheeple following the one in front. We are all about freeing up everyone from being spoon fed sheeple. Intel Operatives are very clever, full of guile and smarts and we rout them all out wherever we come across them.

Leaving out some of the most important information is a lie and is a curse and it staggers us that so many Intel Operatives are running controlled opposition psyops with the LFL insight work when the curse of their lies will come back upon them, their families, other loved ones and beneficences.

They are determined to desensitise anyone who might come across our insight work down-the-line and not bother going any further because they think they have heard it all before, not realising all the Kindom remedy work and other very important insights of the big picture we share have been intentionality left out.

And Intel do not provide links back to where all the LFL information is coming from. They act as if it starts and stops with them and with other Intel Operatives in simpatico with them and their cointel operation.

No one owns the truth and we never claim to do so. The LFL insight work we do is the result of many years of intense scrutiny and contemplation, leaving no stone unturned, and being willing to admit we are wrong in the public domain, clean up our act and just keep moving forward. We are always out in the open, warts and all, and we are not scared to face truth whenever it comes along.

By accusing us of being a cult, you are saying that all of the LFL insight work is also of a cult and should be ignored/rejected/written-off, even though you would have to look very hard to find any evidence of the cult. None is forthcoming.

There are no big bank accounts, no queues of followers, no devotees around us, no land, no infrastructure, etc. The LFL insight work has been provided for free without a fee from Day 1 and this will never change. If people want to send a gift, they can. If they don't want to, there is no pressure to do so.

Over the years when receiving other accusations of being a cult we have looked hard for it; we have looked under the bed, in the pantry, throughout the house, in and under the car, in the garden, front, back and sides, in all the drawers and cupboards, in the bathrooms and laundries and out into the neighbourhood, the wider regions and still further out around Australia and in all its cities.

Where is this cult???

We have looked for the bank accounts, the expensive cars and other vehicles, the real estate portfolios. We have looked around for all the followers, for the orgies, for the queues of people longing for a glimpse, a word, a touch from their cult leaders.

We have been to the police station and asked for reports or records of this cult. We have asked government agencies, but to no avail. Where are the headquarters of this cult and its registered charities?

And what about Federal Police and ASIO, do they have anything on this Cult?

No, nothing.

Only someone already in a cult would make such slanderous accusations, because "The System" is a cult full of cults protecting their cults using cultish behaviour.

Accusing us of being a cult is also to slander Fiona, suggesting that she is a poor victim under mind-control, pushed into doing all this against her will, too dumb and stupid to see that she is being used and abused, even though you don't know her, have never lived with us or had any private dealings with us. And yet, somehow you are enough of an expert to be able to comment on us.

Are you psychic?

Do you practise remote viewing?

Are you in the room with us?

Do you practice black magic?

Just how do you know Robbie?

Anyone who has been told that we are a cult should point the accusers in the direction of this document so they can read for themselves who we really are and why we do what we do.

Arthur pulled out of "The System" in 2005-2006 by dropping and stopping the re-presentation of the "name" of the "person" in law/legalese, to no longer be under another MAN'S standing, walking away from everything that would bring the living MAN, Arthur, under the power and control of another MAN anywhere across Earth, past, present or future.

As an ACT (Australian Capital Territories) Supreme Court judge, Richard Christopher Refshauge, said to Fiona on the record in 2017, during the malevolent attacks performed by David Bottril and the Ordo Templi Orientus against our family, Richard agreed with Fiona saying, "Yes, MAN is the highest power but MAN subjugates himself under the law to have order". More on this further down.

In 2005-2006, Arthur said goodbye to bank accounts, credit cards, medicare, government handouts, pensions, drivers license, passport, car registration or any other registration, bond, certificate, trust, foundation, contract, etc. Arthur also does not get involved in black-market or cash jobs on the side.

All in all, Arthur is now of a much higher standing in authority than everyone else still contracted to "The System", under limited liability and limited responsibility, one way or another. Not that he is higher than another MAN, just that, in the game of "The System", he has a higher standing than them.

Fiona remained in "The System", retaining all the contracts to keep the family going, working together one in and one out, while focused on getting a community of people serious about walking away from "The System", back to full-responsibility for everything we think, feel and do, something that very few seem interested in doing because most people like their spoon-fed system comforts too much to give them up.

So we remain commercially poor, currently vagabond gypsies as our previous secure position was undermined by our refusal to take the injection.

When LFL started, we were putting in roughly 16 hrs a day, almost everyday since March 2005, building up all the free Love For Life platforms, including social media, youtube, email databases, etc, to promote the LFL insights that were inspired by a wide range of deeply moving epiphanies and direct

sensory experiences between Jan 2006 to May 2006, and again for two weeks in June-July 2012, leading to another wide range of attacks upon our family between 2014 and 2019.

An organised crime syndicate went after us, just as, we discovered, they go after many who have done nothing wrong, never stolen anything or broken the peace, committed no crimes and injured no one.

First they tried using fraud being committed inside the Australian Tax Office to bankrupt Arthur in 2004 to 2005 and failed.

Then Macquarie Bank was used to switch contracts when we re-financed our family home in 2005-2007, admitted the problem and then did nothing about it, ending up with them stealing the house and selling it, causing us to lose not only the house, a beachfront in Jervis Bay, but also a very successful holiday rental business.

The situation also destroyed Arthur's business of 20 years, an office automation business that was providing us with a steady income. In today's inflated values, it would probably be around \$4.5 million dollars that was stolen from us.

One of our supporters, Joe Bryant, in his 70's, who went down to the beach house with John Wilson, Paul Chermac and Arthur to maintain a presence at the house when we had changed the locks back and re-possessed the house after the bank had changed the locks without warning, returned to his Sydney home only for him and his wife, both in their 70s, to be woken up in the early hours by men in Balaclavas who hog tied them, hooded them, put a bullet through his hip, tortured them for a few hours and then left them to be found, luckily, by their son, later that morning. All that was stolen were an old computer and a small, old, cheap Grandfather clock.

Joe rang us from the hospital later that morning and we spoke to the head of the large task force of police deployed to the case. The story was due to go on national, state and local TV, current affairs, radio and printed media that late afternoon, but, at the last minute, everything was pulled, the task force dismantled and nothing of the media went any further. Complete silence ever since, bar what we kept putting up in the public domain.

The corruption by the bank was what prompted the start of LFL, but it was the stories from multi-hundreds of other Australians who had also had everything stolen from them through corruption that pushed us to look for a remedy that was obviously not being provided by the law, as they all had the evidence of the corruption but were all losing in court.

Fiona was pregnant with our fourth daughter when we were going through the court battle for the house and, although we never lied, broke the peace, committed a crime or harmed anyone, we were left close to destitution and poverty, just about able to pay the rent but sometimes without food in the cupboards.

Up until around 2013, we received death threats, one of which was traced to the Surry Hills Police Headquarters by Bowral Police, as well as many nasty comments and threats on the website, which we left up for all to see as the website was a place for free speech so we never deleted comments from detractors. They are still there now.

Arthur also experienced 4 assassination attempts, there were odd knocks on the door at night, voices at night and black cars cruising up and down our quiet cul-de-sac, helicopters hovered above the house and Fiona was kidnapped (arrested) by a large posy of police, roughly 6 cars/vans, and hauled off to Bowral Police Station, but only after the main thug who was brought in to intimidate our family, injured Fiona in front of 2 year old Xanthe sitting in the back seat.

This went on for years. Anyone would think we were drug smugglers, terrorists, arms dealers or very violent, dangerous people, part of a Mafia.

They sent honey pots at us and many intel operatives came to our home. They were always welcomed in. Presumably our phones were tapped. This was all intimidation tactics to break us, our stance and our marriage.

We also decided not to pay two fines of \$25 for not voting and a fine for \$65 for not changing the address for the registration of the dog to see what happened. We did this intentionally, using our lives as guinea pigs. This turned into a farce that went on for around 4 years as the State Government and the SDR0 (State Debt Recovery Office) eventually spent around \$500,000.00 attempting to re-coup \$115.00.

We documented everything including taking heaps of photos and a few videos when large squads of sheriffs, detectives, police and tow truck drivers were sent twice to our home to steal the family car that we eventually got back from the Sheriffs at Blacktown, thanks to many supporters.

Arthur set off to steer this horseless chariot back home without vin number, rego, licence, etc, and was staked and surrounded by 8 police cars with at least 16 police coming after Arthur, who asked them if they hadn't already got a job to do protecting the community from bad people, and whether they had grievance because we had injured any of them or their families in the private. Keep in brain that we never injured anyone, never broke the peace, lied or committed a crime.

Thinking of Fiona and the children, and after a long stand off, Arthur decided not to play Ned Kelly that day and left the car at Joe's until we could get it fixed and brought it home.

We were also attacked by David Bottrill of the Ordo Templi Orientis in Canberra after a lackey posted defamatory material in the unmoderated LFL website and then went after Fiona as the owner of the website, even though the information was removed when requested. We had nothing to do with it and we had no idea at the time that it was posted in a comment section.

Fiona was taken to ACAT and was eventually ordered to pay David Bottrill \$10,130.00 damages after a legal merry-go-round from ACAT to the Supreme Court to ACAT to the Supreme Court again. This action of posting a trail of defamation for David Bottrill to pursue was repeated on multiple Facebook and other social media groups and websites that were outing paedophiles.

They tried to go after Arthur but were unable to drag him in as he has no connection to "The System" name Arthur Cristian.

Richard Christopher Refshauge's comment "MAN is the highest power but MAN subjugates himself under the law to have order" made it very clear that everything of "The System" is voluntary and this includes paying tax, voting,

parking, road tolls, census, paying private corp bills for energy, gas, internet, mobile, statute fines, etc, etc.

After many years of attacks, in June-July 2018, the LFL website was again attacked only this time by millions of bots which crippled the pair.com server in America with the 2006-2021 hosts telling us they had to move the website to a subdomain because the massive bot attacks was seriously affecting or shutting down numerous websites hosted by the company.

The LFL website is still in the subdomain. When we have the \$6,000 needed to update it from Drupal 5 to Drupal 8, we will do so and then its vast research library will be available again for free, with well over 30,000 individual documents, pdfs, research documents, facsimiles of web pages, podcasts, videos, etc, connected to over 11,400 individual posts/nodes in the Drupal 5 database.

Fiona's PayPal account was closed, even though PayPal said that she had done nothing wrong, leaving us without gifts from those inspired by the LFL insight work to keep the website up and all the other LFL projects going, her Scribid account was closed, her Centerlink parenting payments were cut as we refused to vaccinate our children and our Facebook walls were messed with, as well as scaremongering going on in the wider Southern Highlands community for years, claiming we were a dangerous cult, even though we are just a clean living family who sees life as a gift on a do no harm path.

From 2005 to 2019, we rented a house in East Bowral that at first we used as a bunker while we were fighting Macquarie Bank, and, from September 2011, we created a massive organic garden on a deep clay belt on 1/16th of an acre eventually producing roughly 2 tons of deeply enriched organic food per year.

We had very little money to work with but worked extremely long hours with close friends to make it all happen, with the intention to give all the excess away for free to the wider community, setting an example to others that regardless of our circumstances, we can all still take back full responsibility for our lives on many fronts, leading to the creation of Kindom (not Kingdom), a simple remedy that gets everyone out of supporting and causing harm doing in "The System".

In August 2018, we received a termination notice to vacate the property, giving us only 3 months after we had been there for 13 years without a blemish on Fiona's record - rent usually paid well in advance across the years.

With three old cars, including friend, Hannah Wood's car, (Hannah had been living with us since August 2011), on their last legs, we had to purchase another car using a \$10,000.00 gift from a supporter in Germany who we never met and do not know, and borrowing \$4,000 from a friend, which Fiona paid back quickly.

We knew there was no way that we could move in three months and asked for more time and even offered to pay more rent to give us more time but it was all knocked back.

We were told that the owners were under financial pressure and needed to urgently sell their 2002 investment properties, both the house we rented and the one next door that they also owned.

As it turned out, as soon as both properties were vacated and we had spent weeks dismantling and relocating the garden, both houses were re-rented out.

Unable to afford to pay the expensive Southern Highlands rents, a friend lent us money to buy a camper trailer and we have been living in that, bar three months, since we moved out of the house in March 2019, saving any money we can to purchase off grid gear for setting up a Kindom community with others.

As our black 2010 Mazda CX9 Grand Touring is still currently off the road since November 2021, needing a transfer case and auto transmission reconditioned or upgraded, and we might not get it back until late January 2022, we are currently unable to pull the 1.8 ton camper trailer with electric brakes, etc, hence we are house-sitting and staying with friends, or sleeping in the seats of the cheap, small Rav4 we purchased as a runabout to get us out of trouble, while we do what we can to get ahead.

We have chosen not to sell out and are the canaries in the cages in the mines, providing those interested with a picture of what happens when we

put our heads above the fog, in the sights of those whose intention is to keep us in the fog.

Our intention has always been to inspire others to be the wind under each others wings, inspired by the many virtues of the good heart of life, raising each other up as we walk away from "The System" together, in this life, before the planned culling and take over of the whole of earth comes swiftly and completely.

If you doubt that, look at the success of the coronavirus campaign, how easily most have complied and acquiesced to the insane demands.

The LFL website had roughly 440 million unique IP addresses hitting it until it was taken down in July 2017 and many, many, many people have contacted us thanking us for the intense work and expressing how it has helped them see more clearly.

By mid 2007, the website had broken into mainstream, sitting around position 177,000 in traffic flow of the roughly 30 million websites on the net back then.

Of many large databases containing important information about Chemtrails, HAARP, Microwaves, EMF, True (Hidden) History, Dinosaurs, Aspartame, MSG, Fluoride, Tibet, Occults, Tesla, Earth Turning or Stationary And is Earth Round or Flat, etc, etc, there was also a massive vaccination section in the LFL website, pulling together the work of many brilliant researchers into one place, possibly the largest collection of information on the subject.

The website had become a huge thorn in the side of those at the top which meant that we were also a huge thorn in their side. We were the little feisty dog biting the ankles of the big boys.

We take very seriously the full-responsibility not to lie and to be accountable for what we do because the LFL work we do supports people in healing themselves as they go where the truth takes them. Over the years, we have helped multi-thousands of people, mostly strangers, one-on-one, whether through email, phone calls, visitors, etc, and all of it for free.

On some days, Arthur could do three, three hour calls in a day, and we have both spent multiple hours with visitors who mostly came for help to work out emotional issues, even if, on the surface, they were there for something else.

The benefit for us in all of this was a continuing deepening comprehension of why, even with so many good hearted men and women dreaming for change, nothing was happening.

While the website is still stranded in its subdomain, we have a temporary home page that needs a lot of work as we have just dumped a lot of information there quickly but there are many links there to documents and articles in Docdroid that can be read and downloaded covering almost everything explained above as well as many articles. As we get time, and remember, we will pull more information off the website but it takes time.

Robbie, in answer to your post, the path we are on is very challenging but we have certainly been walking the talk, as detailed above. Had we land to co-create on, the food forest would be well on its way and the Kindom community infrastructure starting, including preparation for long-term food storage, etc.

We have been taking action since 2005, showing others again and again just what we are dealing with in terms of "The System" and also providing a simple remedy that anyone can adopt if they choose to. What we have found is that most people are too scared to do much more than talk. They prefer to sit on the fence and criticise or wait for a fairy godmother with magic wand to come along and swish all their problems and concerns away.

Now, more than ever, we should be accepting each other as we are, accepting that none of us are perfect, that all of us are compromised and we are all doing the best we can under our circumstances, even if that is currently doing nothing!

Divide and Rule is the name of "The System" game and, if we play it amongst ourselves, we are doing exactly what these slave masters want their slaves to do.

Divided, we are easy pickings. Standing strong in a community, we are unbeatable because, even if they bring in their guns and murder us all, they have not won because we have claimed back our lives and turned our backs on their brainwashing and fear porn.

There is no death; life never stops and, when we know who we are, our life continues on after the body is laid in the earth.

Even though we are still homeless, it is not our problem because it is caused by everyone around us who supports "The System". We are not the only ones going through this, but most keep it private because of pride and shame. We have chosen to make it public to bring it to attention.

Our insight work is a medicine for those who are prepared to use it to remedy the damage between the ears that we all have because everyone brought up in "The System" is severely damaged, but we cannot fix anyone, only provide them with tools to do the healing work themselves.

Collectively, we are suffering from a weakness of the heart that has us allow harm to spread amongst us while we are busy doing other things. Harm done to one is harm done to all and, until we fix the problem of harm done to those around us, we will not fix the problem of harm done to us.
