- 1. OVERVIEW/ENTRY PERIODS: The Sweepstakes starts on October 25, 2023, at 7:00 A.M. ET, and ends on January 3, 2024, at 11:59 P.M. ET (the "Sweepstakes Period"). Two (1) Grand Prize winners will be selected at the end of the Sweepstakes Period via a random drawing from among the eligible entries received by 11:59 p.m. ET. The random drawing will be conducted within 48 hours of the closing of the Sweepstakes Period. Potential Winners will be notified within one day after the drawing. Total of (2) Grand Prize Winners will be selected during the Sweepstakes Period (one parent, and one educator). Full list of winners will be announced on or before January 12, 2024.
