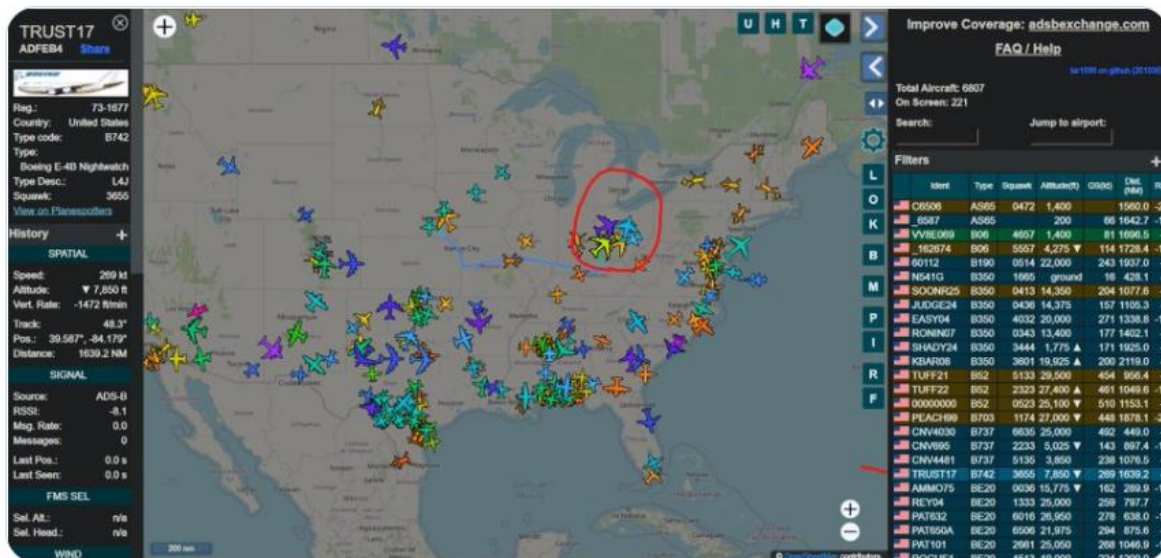

The **Boeing E-4 Advanced Airborne Command Post (AACP)**, the current "Nightwatch" aircraft,^[2] is a strategic **command and control** military aircraft operated by the **United States Air Force (USAF)**. The E-4 series are specially modified from the **Boeing 747-200B** for the **National Emergency Airborne Command Post (NEACP)** program. The E-4 serves as a survivable mobile command post for the **National Command Authority**, namely the President of the United States, the **Secretary of Defense**, and **successors**. The four E-4Bs are operated by the **1st Airborne Command and Control Squadron** of the **595th Command and Control Group** located at **Offutt Air Force Base**, near **Omaha, Nebraska**. An E-4B when in action is denoted a "National Airborne Operations Center".^[3]

‘Doomsday’ plane that follows president arrives in Spokane

But it wasn’t Air Force One. Instead, an E-4B built by Boeing checked into Fairchild Air Force Base Friday afternoon for a visit that was described as “routine.”

“They routinely come here,” said Scott King, a spokesman for Fairchild Air Force Base. “It is on Fairchild. I can’t tell you anything more.”

But the plane is anything but routine. The Boeing E-4 was built exclusively for the Air Force and also goes by another name, the National Airborne Operations Center. Soon after their introduction in 1974, the media began referring to them as the “doomsday planes” because they can act as a complete command center for war operations during a nuclear attack.

Only four were ever built.

The E-4s have three decks and are capable of carrying 112 people for both flight and mission operations. They can remain in flight for more than 35 hours, but are built to operate mid-air for a week.

The planes are stationed near Offutt Air Force Base in Omaha, Nebraska, but travel a lot. They follow around Air Force One wherever the president goes.

So is Donald Trump here? Probably not. The 44th G7 Summit is taking place this weekend in La Malbaie, Quebec, and Trump is attending. Then, on Tuesday, he’s scheduled to meet with North Korean leader, Kim Jong Un, in Singapore.

So perhaps the E-4 is preparing for that trans-Pacific journey? No one’s telling.

“Even if I knew, I couldn’t tell you,” King said.

DNI declassifies Brennan notes, CIA memo on Hillary Clinton 'stirring up' scandal between Trump, Russia

EXCLUSIVE: Director of National Intelligence John Ratcliffe on Tuesday declassified documents that revealed former CIA Director John Brennan briefed former President Obama on Hillary Clinton's purported "plan" to tie then-candidate Donald Trump to Russia as "a means of distracting the public from her use of a private email server" ahead of the 2016 presidential election, Fox News has learned.

Ratcliffe declassified Brennan's handwritten notes – which were taken after he briefed Obama on the intelligence the CIA received – and a CIA memo, which revealed that officials referred the matter to the FBI for potential investigative action.

The Office of the Director of National Intelligence transmitted the declassified documents to the House and Senate Intelligence Committees on Tuesday afternoon.

"Today, at the direction of President Trump, I declassified additional documents relevant to ongoing Congressional oversight and investigative activities," Ratcliffe said in a statement to Fox News Tuesday.

A source familiar with the documents explained that Brennan's handwritten notes were taken after briefing Obama on the matter.

"We're getting additional insight into Russian activities from [REDACTED]," Brennan notes read. "CITE [summarizing] alleged approved by Hillary Clinton a proposal from one of her foreign policy advisers to vilify Donald Trump by stirring up a scandal claiming interference by the Russian security service," Brennan's notes read.

Declassified memos: CIA feared Clinton was 'stirring up' false Russia collusion narrative

Director of National Intelligence John Ratcliffe on Tuesday declassified two documents showing President Obama's CIA feared in summer 2016 that Hillary Clinton was "stirring up" a false Russia collusion narrative to "vilify" Donald Trump and distract from her own controversies heading into the election.

The memos indicate the CIA first received the information through the monitoring of Russian sources and deemed it credible enough to brief Obama on it in July 2016 and to refer the intelligence to the FBI in September 2016 for possible investigation.

The warnings came as the FBI was just starting its Crossfire Hurricane probe into now-disproven Trump-Russia collusion, aided by the Clinton campaign-funded dossier by Christopher Steele. They are likely to bolster GOP claims the James Comey's FBI ignored clear evidence that the allegations were a political dirty trick and not evidence of a counterintelligence threat.

"Per FBI verbal request, CIA provides the below examples of information the CROSSFIRE HURRICANE fusion cell has gleaned to date," the September 2016 referral from the Agency to the bureau read. "An exchange [redacted] discussing US presidential candidate Hillary Clinton's approval of a plan concerning US presidential candidate Donald Trump and Russian hackers hampering US elections as a means of distracting the public from her use of a private email server."

Two months earlier, then-CIA Director John Brennan briefed Obama, according to handwritten notes written after the briefing.

"We're getting additional insight into Russian activities from [redacted]," Brennan notes read. "CITE alleged approved by Hillary Clinton a proposal from one of her foreign policy advisers to vilify Donald Trump by stirring up a scandal claiming interference by the Russian security service."

Ratcliffe is also exploring declassifying evidence requested to be released by House Intelligence Committee ranking member Devin Nunes (R-Calif.). The evidence includes a referral Nunes made to the CIA inspector general in 2018 about flaws in the U.S. intelligence assessment about Russian interference as well as evidence showing what Christopher Steele's primary sub-source for his dossier told the FBI and what the bureau knew about the sub-source's ties to Russia.

"The documents that are underlying what we now have seen — I've only seen a few of those — they're definitely smoking guns," Nunes told Fox News host Maria Bartiromo on Sunday. "That information definitely needs to be made available to the American public.

"The American public needs to see the three reports that we know about, at least from the Democrats' Russian spy that they hired," he added." So those are additional documents that we need to see."

Facebook said Tuesday that it is banning all QAnon accounts from its platforms, a significant escalation over its previous actions and one of the broadest rules the social media giant has put in place in its history.

Facebook said the change is an update on the policy it created in August that initially only removed accounts related to the QAnon conspiracy theory that discussed violence, which resulted in the termination of 1,500 pages, groups and profiles.

A company spokesperson said the enforcement, which started Tuesday, will “bring to parity what we’ve been doing on other pieces of policy with regard to militarized social movements,” such as militia and terror groups that repeatedly call for violence.

“Starting today, we will remove Facebook Pages, Groups and Instagram accounts for representing QAnon. We’re starting to enforce this updated policy today and are removing content accordingly, but this work will take time and will continue in the coming days and weeks,” Facebook wrote in a press release. “Our Dangerous Organizations Operations team will continue to enforce this policy and proactively detect content for removal instead of relying on user reports.”
