The Accused in this matter is Naveed AKRAM, born 12 August 2001 (the Accused) who is charged with committing a terrorist act, 15 counts of murder and 40 counts of attempted murder, Discharge Firearm etc with intent, Display Prohibited Symbol, Causing explosives to be placed in or near building, conveyance or public place. 2. About 6:50pm on Sunday 14 December 2025, the Accused and his father S.AKRAM, born 10 February 1975 (S.AKRAM) attended the vicinity of Bondi Beach, New South Wales (NSW). The Accused and S.AKRAM used three firearms in their possession to shoot at a large number of people gathered for a Jewish event named 'Chanukah by the Sea 2025' at Archer Park, North Bondi. 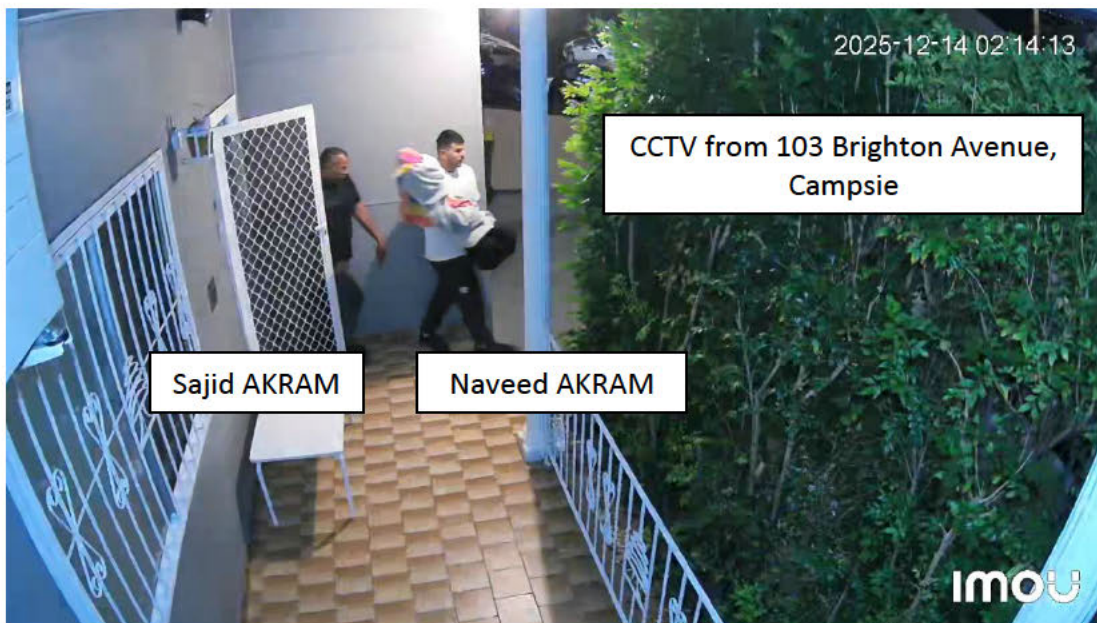

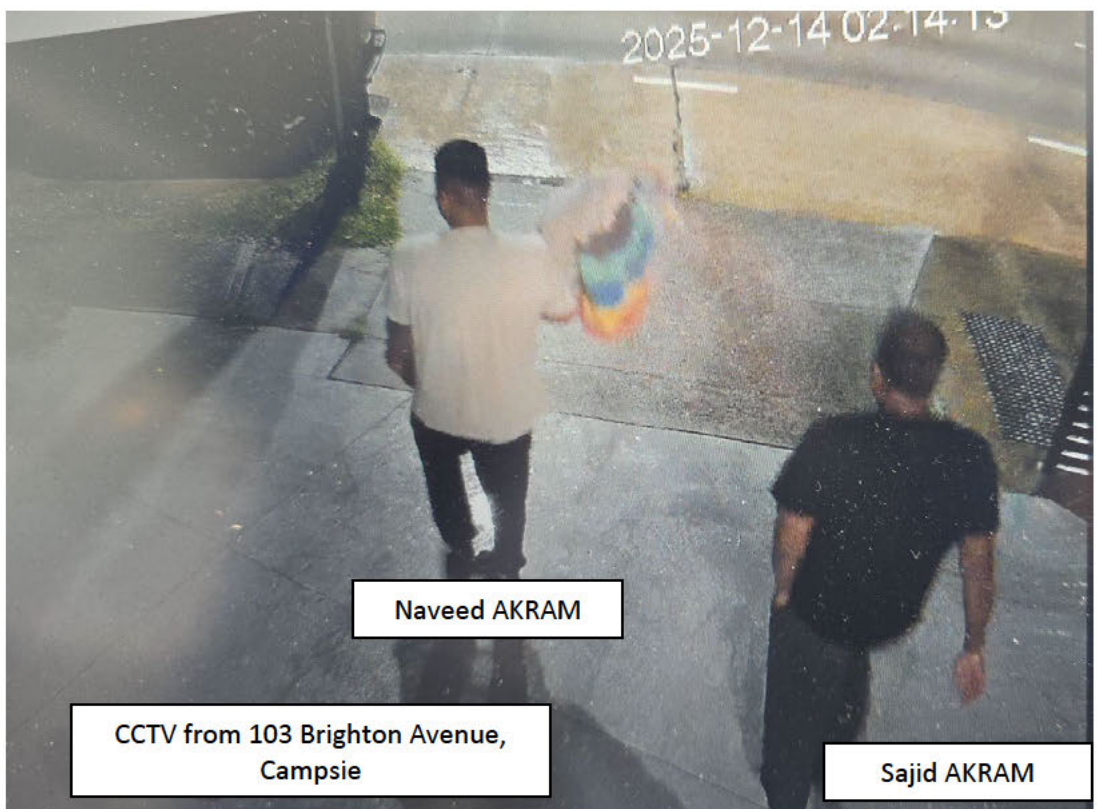
A. EXECUTIVE SUMMARY

1. The Accused in this matter is Naveed AKRAM, born 12 August 2001 (the Accused) who is charged with committing a terrorist act, 15 counts of murder and 41 counts of attempted murder, Discharge Firearm etc with intent, Display Prohibited Symbol, Causing explosives to be placed in or near building, conveyance or public place.
2. About 6:50pm on Sunday 14 December 2025, the Accused and his father S.AKRAM, born 10 February 1975 (S.AKRAM) attended the vicinity of Bondi Beach, New South Wales (NSW). The Accused and S.AKRAM used three firearms in their possession to shoot at a large number of people gathered for a Jewish event named 'Chanukah by the Sea 2025' at Archer Park, North Bondi. Together, the Accused and his father shot and killed 15 people.
3. A further 40 victims were wounded by their gunfire, including two responding NSW Police Officers who attended the scene. S.AKRAM was shot and killed by police during the incident.
4. The incident concluded when the Accused was shot by police and taken into custody.
5. The Accused and his father S.AKRAM, acted in a joint criminal enterprise, aimed at causing a person's death and furthering an extremist political, religious and ideological cause, namely religiously motivated violent extremism aligned with Islamic State.

B. STATEMENT OF FACTS

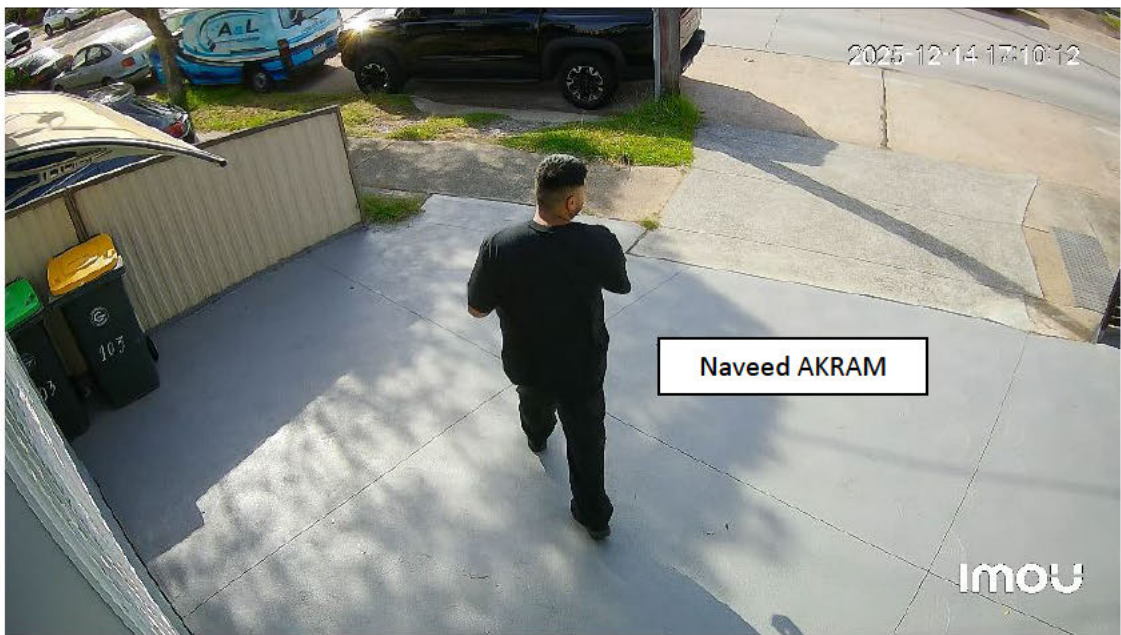
6. On Monday 20 October 2025, the Accused rented a room within a five bedroom house located at 103 Brighton Avenue, Campsie, NSW. This booking was made online through the website "AirBnB" to be occupied between the dates 2 December 2025 and 21 December 2025. The premises has five individually rented rooms within the main house, as well as a self-contained granny flat in the rear yard.
7. About 2:16am on Sunday 14 December 2025, the Accused and his father, S.AKRAM were captured by closed circuit television (CCTV) at the premises, exiting 103 Brighton Avenue, Campsie, NSW. At this time, the Accused and S. AKRAM were observed carrying long and bulky items wrapped in blankets. These items were placed into a 2001 silver Hyundai Elantra with NSW registration CN59DR, parked on Brighton Avenue. This vehicle is registered to the Accused.





8. Police allege the bulky items loaded into the vehicle were two single barrel shotguns, a Beretta rifle, four home-made improvised explosive devices (3 x pipe bombs, 1 x tennis ball bomb, 1 x large IED bomb) and two Islamic State (IS) flags. The Accused and his father, S.AKRAM then returned to the premises.

9. About 5:09pm, the Accused and his father, S.AKRAM were captured by CCTV leaving the residence of 103 Brighton Avenue, Campsie. The Accused and his father entered vehicle CN59DR and drove from Campsie towards Bondi. The Accused is wearing a black tee shirt and black pants, with S.AKRAM wearing a black tee shirt and white pants.



10. About 5:57pm, CCTV captures CN59DR travelling East on Oxford Street, Centennial Park towards Bondi ,NSW.



11. About 5:58pm the same day, CCTV captures vehicle CN59DR on Ocean Street, Woollahra, NSW stopped outside 6 Ocean Street. CN59DR remains at this location until about 6:17pm. During this time, S.AKRAM exits the front passenger seat and remains on the footpath. S.AKRAM then moves the boot of the vehicle where a black Islamic State flag is visible. The Accused then exits from the driver's seat, walks to the rear of the vehicle and looks into the rear seats. The Accused and S.AKRAM enter the vehicle soon after, conduct a U-turn and travel towards Syd Einfeld Drive.



12. About 6:18pm, vehicle CN59DR is captured on CCTV at 3 Bondi Road, Bondi Junction travelling on Syd Einfeld Drive, turning left onto Old South Head Road, Bondi Junction.



13. About 6:25pm, vehicle CN59DR is captured on CCTV at 339 Old South Head Road, North Bondi, driving towards Bondi Beach.



14. Vehicle CN59DR continues to travel through Bondi until it is eventually parked at Campbell Parade, Bondi near a foot bridge overlooking Archer Park at 6.50pm.



15. Upon parking the vehicle, the Accused and S.AKRAM removed the IS flags from the vehicle and placed them on the inside of the front and rear windscreen respectively. In these locations, both IS flags were clearly visible to the public. The IS Flag is a prohibited symbol under section 82.2H of the *Criminal Code* (Cth).
16. The Accused and S.AKRAM proceeded to remove the three firearms from the vehicle, as well as the pipe bombs and tennis ball bomb, and move towards the footbridge. Upon approach to the footbridge, investigators believe the three pipe bombs and tennis ball bomb were thrown towards the crowd of people in Archer Park.
17. It is unclear at this time, whether the Accused or S.AKRAM threw the improvised explosive devices.
18. Preliminary analysis indicates the pipe bombs were made of sealed aluminium piping containing explosive, black powder and steel ball bearings. The pipe bombs did not detonate, however preliminary analysis indicates both items were assessed as viable improvised explosive devices (IEDs).

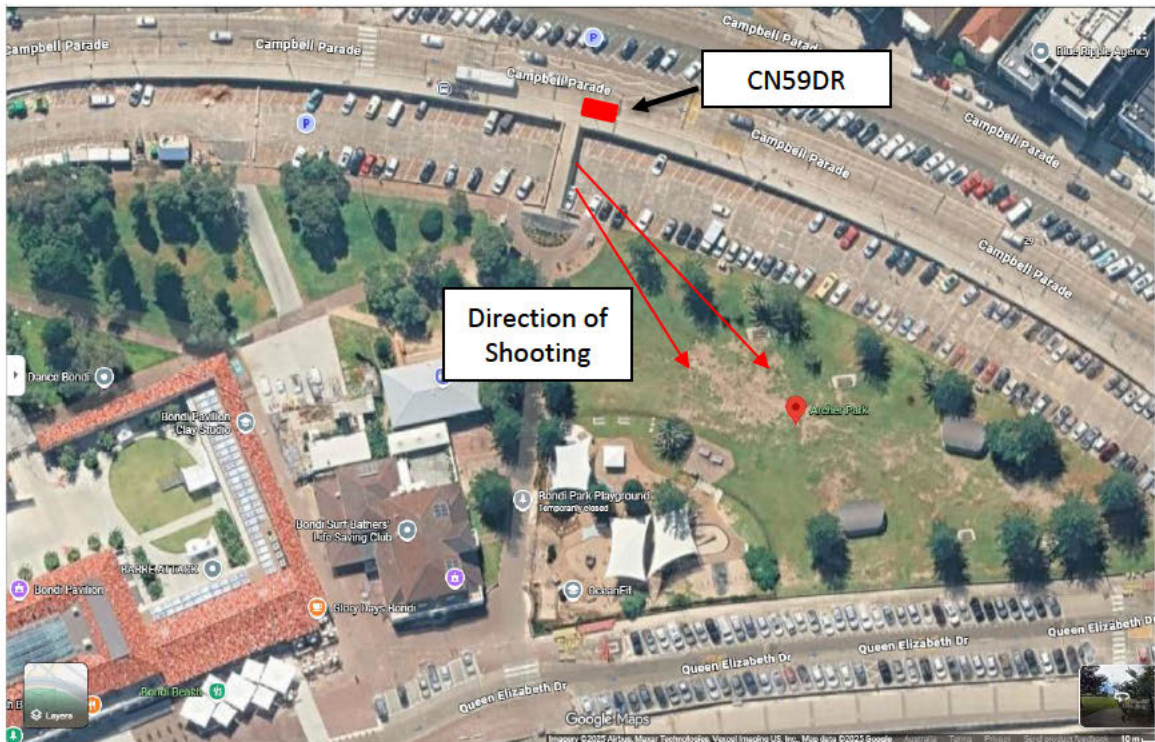


2 x Home-made pipe bombs



19. A short time later, the Accused and S.AKRAM, armed with the three firearms, began shooting towards the crowd gathered within Archer Park. Bondi Beach, NSW, and surrounding area.





20. Rounds fired by the Accused and S.AKRAM killed 14 people at the scene. A 15th victim later died from injuries sustained during the shooting, at a nearby hospital.
21. The Accused and S.AKRAM appeared to be targeting members of the public gathered at the Jewish religious event “Chanukah by the Sea 2025”, held in Archer Park, Bondi NSW at the time of the incident. “Chanukah by the Sea 2025” was a publicly advertised event, scheduled between 5:00pm and 9:00pm on Sunday 14th 2025.
22. A number of New South Wales Police Force members responded to the shooting and returned fire in an effort to stop the killing at Bondi Beach, NSW. CCTV footage captures the Accused and S.AKRAM firing back at police officers. As a result, two police officers were seriously injured, requiring medical attention.
23. During the exchange of fire, S.AKRAM was shot and killed. The Accused was also shot in the abdomen and critically injured. Attending Police arrested the Accused before attempting CPR on S.AKRAM. The Accused was transported to hospital soon after. The Accused is currently receiving medical treatment at a Sydney Hospital under police guard.
24. In total, the Accused and S.AKRAM shot and killed 15 people, namely:

26. Following the arrest, police searched vehicle CN59DR, locating what appeared to be an IED. The device was rendered safe, seized and removed from the scene by NSWPF Rescue and Bomb Squad.



27. Also located in the vehicle were two home-made, painted IS flags appearing to be made with white paint on black fabric. These flags were seized by police.



28. An Apple iPhone was located in the drivers footwell of vehicle CN59DR. The phone belongs to the Accused and was seized by searching police.
29. A further Apple iPhone was located in the centre console of CN59DR, believed to have belonged to S.AKRAM. This phone was also seized by police.
30. About 11:45pm, JCTT NSW were granted a section 3R/3E of the *Crimes Act 1914* (Cth) search warrant for the premises at 26 Brown Road, Bonnyrigg, NSW 2177. This location is the family home of the Accused and S.AKRAM.
31. About 11:50pm, NSWPF Tactical Operations Unit conducted a negotiated surrender at the premises. At this time, three family members of the Accused were removed from the location.
32. During the course of the search, the following items were seized:
 - I) An Apple iPhone 11;
 - II) An Apple iPhone;
 - III) A homemade/wooden firearm;
 - IV) A Long bow with 12 arrows; and
 - V) A copy of the Quran with passages highlighted.
33. The mother of the Accused was spoken to by Police, at which time she stated she believed her son (the Accused) and her husband (S.AKRAM) were away on holiday in Southern NSW. The mother recounted that they had departed together approximately one week ago. The mother recalled that while he was away, the Accused would call her each morning from a payphone nearby at approximately 10.30am and would discuss what he planned to do that that day.

34. On Monday 15 December 2025, members of the Joint Counter Terrorism Team were granted a 3R/3E of the *Crimes Act 1914* 9(Cth) (126/2025) to search the premise 103 Brighton Avenue, Campsie. The Accused and his father, S.AKRAM, were occupying "Room 2" of the premises. The room was locked upon entry. Police forced the lock and entered the room. Investigators located and seized a number of relevant items including, but not limited to:

- i) A firearm scope;
- ii) Ammunition;
- iii) A suspected IED;
- iv) S.AKRAM's NSW drivers licence, bearing licence number 13526049;
- v) S.AKRAM's Hunting Association membership card;
- vi) 3D printed parts for a shotgun speed loader;
- vii) A Rifle - 30-60 Calibre (BX008983);
- viii) A shotgun (serial number 75_h21yt_032798);
- ix) Numerous firearms parts;
- x) Bomb making equipment; and
- xi) Two copies of the Quran (one with an earmarked page).

C. PREPARATION

35. A subsequent review of the Accused's mobile phone identified a number of relevant videos and images which indicated that he and his father, S.AKRAM, adhered to a religiously motivated violent extremist (RMVE) ideology.

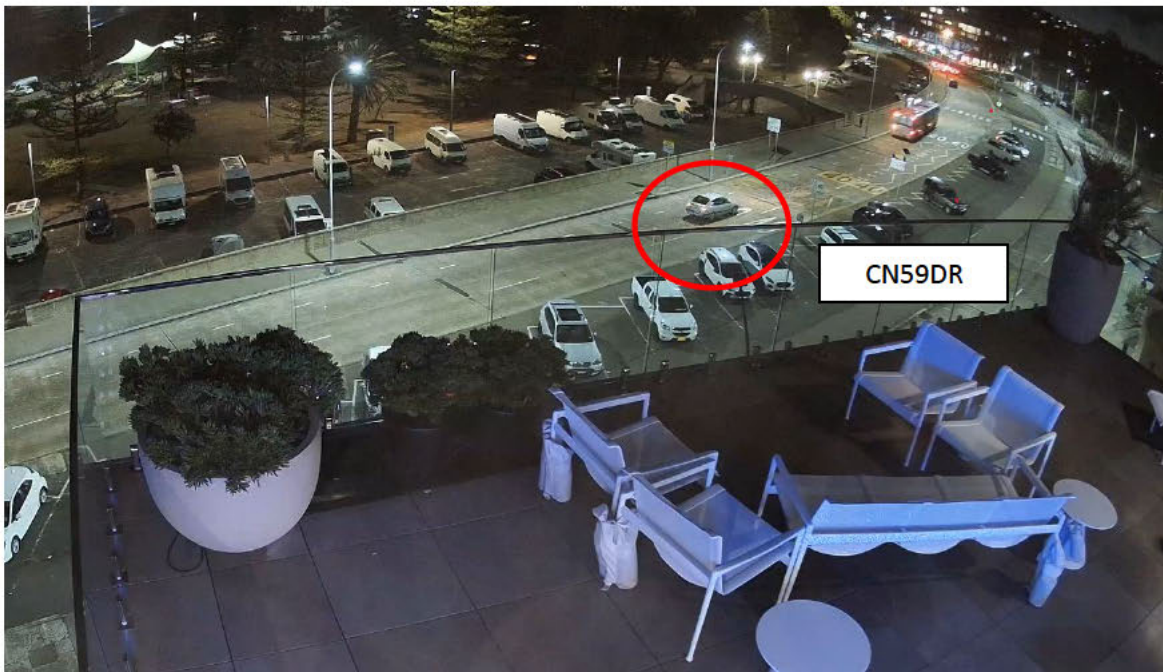
36. A video recorded in late October 2025, depicts the Accused and his father conducting firearms training in a countryside location, suspected to be in NSW. The Accused and his father are seen throughout the video firing shotguns and moving in a tactical manner.





37. Another video file recorded in October 2025, located within the Accused's mobile phone depicts the Accused and S.AKRAM, wearing black tee-shirts, sitting in front of an image of an IS flag. Resting against the wood panelled wall behind the Accused are four long-arm firearms with visible rounds attached to their frames. The Accused is recorded appearing to recite, in Arabic, a passage from the Quran. Following the recitation, both the Accused and S.AKRAM speak in English and make a number of statements regarding their motivation for the 'Bondi attack' and condemning the acts of 'Zionists'.
38. In this video, the Accused and S.AKRAM recite their political and religious views and appear to summarise their justification for the Bondi terrorist attack.
39. On 12 December 2025, between 21:20pm and 22:00pm, CCTV from the vicinity of Campbell Parade, Bondi, has identified two males believed to be the Accused and his father, S.AKRAM travelling to the carpark near Archer Park, Bondi Beach within vehicle CN59DR.

40. Vehicle CN59DR is identified entering the carpark at 21:31pm



41. The Accused and his father, S.AKRAM, are seen to exit the vehicle and walk along the footbridge, being the same position where they attended two days later and shot at members of the public. Police allege that this is evidence of reconnaissance and planning of a terrorist act.



D. SUMMARY

42. Police allege that the Accused and his father, S.AKRAM, adhere to a religiously motivated extremist ideology linked to Islamic State. This is demonstrated by their videoed speech and use of Islamic State flags during the attack. There is evidence that the Accused and his father, S.AKRAM, meticulously planned this terrorist attack for many months through actions including:
- i) Making an ISIS inspired video;
 - ii) Making of ISIS flags;
 - iii) Firearms training;
 - iv) Making of pipe bombs and improvised explosive devices;
 - v) Booking of accommodation to act as a staging post; and
 - vi) Transportation of firearms and ammunition for the attack.

E. ARREST

43. At 9:55am on 16 December 2025, JCTT Investigators attended to the Accused in his hospital bed at a Sydney Hospital and placed him under arrest for “shooting and killing a number of people on Sunday at Bondi beach”. The Accused was cautioned by investigators and informed that he is in Police custody whilst in hospital. The Accused was explained his rights as a person in custody under Part 9 of LEPR. During this process the Accused requested to speak with a lawyer. The Accused was advised by investigators that a lawyer will be arranged during the custody process.
44. At 10:40am, the Accused was informed of his legal rights and custodial provisions under Commonwealth legislation and issued with Part 1C Caution.
45. About 15:00pm, whilst JCTT investigators were providing the Accused with an update about their enquiries with Legal Aid, the Accused appeared to not have understood or remembered earlier conversation with Police. The Accused was again informed that he was under arrest for the shooting incident in Bondi and that Police are investigating terrorism offences. The Accused was again cautioned by Police, issued with Part 1C Caution and had his rights re-explained under Part 9 of LEPR by the Custody Manager.
46. About 08:00am on 17 December 2025, JCTT investigators attended to the Accused at a Sydney Hospital and provided him with a NSW Police issued mobile phone, which he used to communicate with his legal representative Mr BUCKMAN. On legal advice, the Accused declined to be interviewed by Police and consented to a forensic procedure.

F. ANTECEDENTS

47. The Accused a 24-year-old male and was 24 years of age at the time of the offending.
48. The Accused is an Australian citizen who resides in his family home in Bonnyrigg, NSW with his immediate family.
49. The Accused has no known dependents and strong ties to the Australian community.
50. The Accused has no known disabilities and is currently in hospital receiving advanced medical treatment due to injuries sustained during the incident.
