### Davis: CIA Director Gina Haspel Is Blocking Declassification Of Remaining Russigate Documents

CIA Director Gina Haspel is personally blocking the declassification of documents detailing corruption at the highest levels of the intelligence community during the 2016 election, according to The Federalist cofounder Sean Davis.

While new information about wrongdoing at the FBI has recently been declassified, including recent revelations about Hillary Clinton campaign's collusion with Russia, Davis reported on "Tucker Carlson Tonight" Wednesday that Haspel herself is standing in the way of the declassification of other relevant documents.

"I'm told that it is Gina Haspel personally who is blocking continued declassification of these documents that will show the American people the truth of what actually happened," Davis said.

Notably, Haspel was previously the London CIA station chief under former CIA director John Brennan during the 2016 election. "Recall it was London where Christopher Steele was doing all this work," Davis said, noting Haspel was the "main link" between Washington and London at the time. Haspel was hand-picked by former CIA director John Brennan to run the CIA's operations in London, where she served as the spy agency's bureau chief from 2014 through early 2017.

ROME — Secretary of State Mike Pompeo recently published a sharp letter excoriating the Vatican's plans to renew an agreement with the Chinese government on Church operations in China. He promoted the article in a tweet, concluding, "The Vatican endangers its moral authority, should it renew the deal."

An indignant Vatican took the article more as a calculated affront than a diplomatic gesture. The friction broke into the open on Wednesday as Mr. Pompeo arrived in Rome and met with prelates and others who are hostile to Pope Francis, while the Vatican denied him a meeting with the pontiff and rebuffed his efforts to derail the deal with China.

"Pompeo asked to meet" the pope, who turned him down because Francis had "clearly said that he does not receive political figures ahead of the elections," Cardinal Pietro Parolin, who, as secretary of state, is the Vatican's second-ranking official, told reporters.

But to some observers on both sides of the tensions between the Roman Catholic Church and the Trump administration, Mr. Pompeo's visit is as much about the coming presidential election as about China policy. Mr. Pompeo dismissed that suggestion as absurd, but intended or not, his trip signals that President Trump is on the side of those conservative American Catholics who worry about the church's direction under Francis and think he is soft on China.

Francis and Mr. Trump, who have exchanged sharp words in the past, present starkly different visions on issues ranging from the environment to immigration to the threat of populism. In appealing to the Vatican's support for religious freedom as a reason to drop its China agreement, Mr. Pompeo seemed to seek common ground, but in a way that upset the pope's chief allies and delighted his chief critics.

Cardinal Parolin said Mr. Pompeo's article had caused "surprise" at the Vatican, because this visit to Rome by the secretary and the meetings with high officials at the Holy See had already been in the works and would have been a "more opportune" forum for airing grievances. He added that Mr. Pompeo's choice to publish in First Things, a conservative Christian magazine that has called Francis a failure as Pope, also mattered.

### United States Obtains Final Judgement and Permanent Injunction Against Edward Snowden

On Sept. 29, 2020, the U.S. District Court for the Eastern District of Virginia entered a final judgement and permanent injunction against Edward Snowden, a former employee of the Central Intelligence Agency (CIA) and contractor for the National Security Agency (NSA).

In September 2019, the United States filed a lawsuit against Snowden, who published a book entitled *Permanent Record* in violation of the non-disclosure agreements he signed with both CIA and NSA. The lawsuit alleged that Snowden published his book without submitting it to the agencies for pre-publication review, in violation of his express obligations under the agreements he signed. Additionally, the lawsuit alleges that Snowden has given public speeches on intelligence-related matters, also in violation of his non-disclosure agreements.

The United States' lawsuit did not seek to stop or restrict the publication or distribution of *Permanent Record*. Rather, under well-established Supreme Court precedent, *Snepp v. United States*, the government sought to recover all proceeds earned by Snowden because of his failure to submit his publication for pre-publication review in violation of his alleged contractual and fiduciary obligations.

In December 2019, the U.S. District Court for the Eastern District of Virginia, found in favor of the United States in the suit against Snowden on the issue of liability and held that Snowden breached his contractual and fiduciary obligations to the CIA and NSA by publishing *Permanent Record* and giving prepared remarks within the scope of his pre-publication review obligations, but reserved judgment on the scope of these violations or the remedies due to the government. On Tuesday, the court entered judgment in the government's favor in an amount exceeding \$5.2 million and imposed a constructive trust for the benefit of the United States over those sums and any further monies, royalties, or other financial advantages derived by Snowden from *Permanent Record* and 56 specific speeches.

"Edward Snowden violated his legal obligations to the United States, and therefore, his unlawful financial gains must be relinquished to the government," said Deputy Attorney General Jeffrey A. Rosen. "As this case demonstrates, the Department of Justice will not overlook the wrongful actions of those who seek to betray the trust reposed in them and to personally profit from their access to classified national security information."

"Intelligence information should protect our nation, not provide personal profit," said G. Zachary Terwilliger, U.S. Attorney for the Eastern District of Virginia. "This judgment will ensure that Edward Snowden receives no monetary benefits from breaching the trust placed in him."

"We will pursue those who take advantage of sensitive positions in government to profit from the classified information learned during their government service," said Jeffrey Bossert Clark, Acting Assistant Attorney General of the Civil Division.

This lawsuit is separate from the criminal charges brought against Snowden for his alleged disclosures of classified information. This lawsuit is a civil action, and based solely on Snowden's failure to comply with the clear pre-publication review obligations included in his signed non-disclosure agreements.

### Trump Declares National Emergency Backing Domestic Mining, Will Reduce Reliance on China for Critical Minerals

President Donald Trump on Sept. 30 signed an executive order that seeks to ramp up domestic production of critical minerals such as rare earth elements to support mining jobs in the United States, in a bid to reduce the nation's reliance on Beijing.

China is currently the top global producer of the specialized minerals, used to build electronics, military weapons, and other high-tech equipment. Last year, **80** percent of rare earths imported by the United States came directly from China.

The president's executive order declares a national emergency in the U.S. mining industry and asks the Department of the Interior to look into implementing the Defense Production Act to fund mineral processing "that protects our national security."

In a release, the White House said the order will slash unnecessary delays in permitting actions, providing Americans with job opportunities, and improving economic and national security.

"We will put our miners back to work," Trump said.

Federal agencies will also be authorized to probe and work to reduce reliance on other nations for imports of minerals.

"The President will continue to protect our domestic supply chains for critical minerals from predatory Chinese action," a White House statement said.

Rare earths are an obscure group of 17 minerals, and there are no known

"With this week's repatriations, the United States has brought back every American supporter of ISIS known to be held by the Syrian Democratic Forces against whom we have charges," said John C. Demers, Assistant Attorney General for National Security. "The Department of Justice has worked tirelessly over the years to prevent individuals from leaving America to fight for ISIS and other terrorist groups in Syria and to investigate, repatriate and charge people who willingly left to support these organizations. This was our moral responsibility to the American people and to the people of the countries to which these terrorists traveled. The Department has also supported the efforts of other responsible nations to do the same, including by sharing evidence and know-how. We will continue to do so for any country that takes responsibility for their citizens who left to take up arms in support of ISIS's reign of hate and intolerance."

"Preventing terrorism remains the FBI's top priority. Through the hard work and dedication of countless men and women across the FBI and the U.S. government, nearly a dozen citizens have been repatriated from Iraq and Syria over the past several years to face the American justice system," said John Brown, FBI Executive Assistant Director for National Security. "This announcement should serve as a warning to those who travel, or attempt to travel, to join and fight with ISIS. We remain vigilant in our efforts to prevent terrorism as well as hold terrorists, and those who provide support to terrorist organizations, accountable for their actions. We will continue to work closely with our U.S. government and international partners to present a united front against global terrorism."

"The United States continues to lead by example by working with the Syrian Democratic Forces to repatriate American citizens accused of supporting ISIS and, where appropriate, prosecuting their alleged crimes in American courts," said Ambassador Nathan Sales, State Department Coordinator for Counterterrorism. "We call on other nations, particularly in Western Europe, to take responsibility for their citizens, and we thank the FBI and the Department of Justice for their continued commitment to keeping alleged terrorists off of the battlefield."

## Companies may be punished for paying ransoms to sanctioned hackers - U.S. Treasury

WASHINGTON (Reuters) - Facilitating ransomware payments to sanctioned hackers may be illegal, the U.S. Treasury said on Thursday, signaling a crackdown on the fast-growing market for consultants who help organizations pay off cybercriminals.

In a pair of advisories, the Treasury's Office of Foreign Assets Control and its Financial Crimes Enforcement Network warned that facilitators could be prosecuted even if they or the victims did not know that the hackers demanding the ransom were subject to U.S. sanctions.

Ransomware works by encrypting computers, holding a company's data hostage until a payment is made. Organizations have often ponied up ransoms to liberate their data.

"It is a game changer," said Alon Gal, chief technology officer of Hudson Rock, which works to head off ransomware attacks before they happen.

Before, companies could decide whether or not to pay cybercriminals off, he said. Now that those decisions are being brought under government oversight "we are going to see a much tougher handling of these incidents."

The Enforcement Network's advisory also warned that cybersecurity firms may need to register as money services businesses if they help make ransomware payments. That would impose a new reporting requirement on a previously littleregulated corner of the cybersecurity industry.
