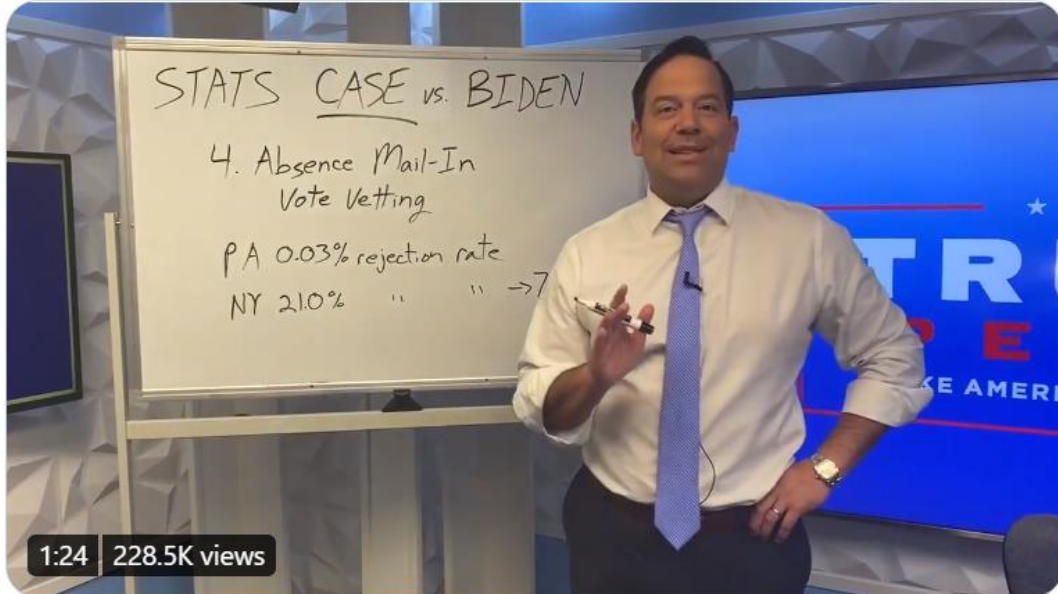

## 6.2 Programming Memory Cards and Security Keys and Cards

The ImageCast<sup>®</sup> ballot counting devices perform operations based on a set of election files that have been produced by Election Event Designer, as created in Section 7.1. These election files have to be copied to Compact Flash memory cards. Each ImageCast<sup>®</sup> device requires two memory cards for successful operation.

In addition to memory cards, you must also program iButton Security Keys. These keys are used for the authentication and authorization of the tabulator by administrative users. These keys hold the cryptographic key parameters that prevent your Election Project from being tampered with.

### 6.2.1 Programming Memory Cards

Prior to programming your memory cards, ensure that you have a USB Compact Flash card reader connected to your EMS workstation and two Compact Flash memory cards. Dismiss any autorun dialogs that may appear once you connect your Compact Flash card reader into your EMS workstation.

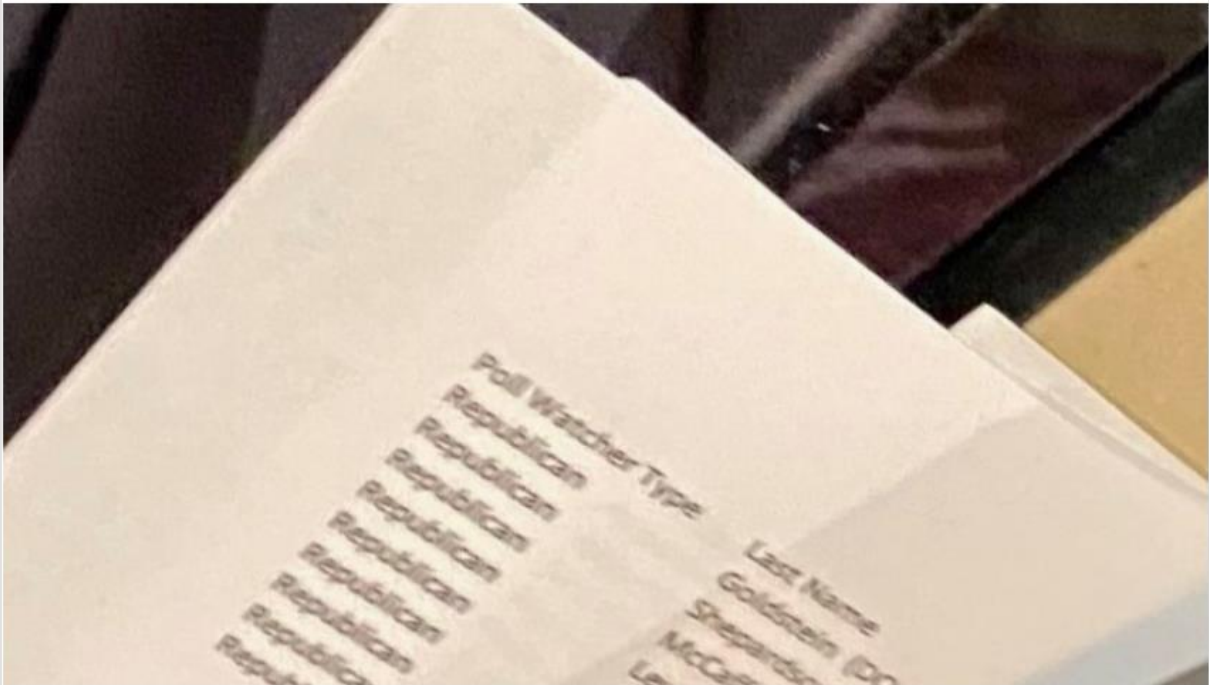
