Michigan Law School in '81. After graduating from the University of Michigan Law School, she went to work for Chicago's first black mayor, Harold Washington. His election had many 60's radicals attributed to it. After Washington's death in 1987, she stayed on under his successor, Richard Daley.

She and her pal Susan Sher recruited Michelle Robinson, then engaged to Barack Obama, and quickly melded her into their lives.

Before Obama's Administration, Jarrett served as a Director of corporate/not for profit boards, including Chairman of the University of Chicago Med Center Board of Trustees. She was Director of the Local Initiative Support Corporation, The Joyce Foundation, and a Trustee of the Museum of Science and Industry. A former Deputy Corporate Counsel for Finance/Development under Harold Washington, Jarrett also continued to work in the mayor's office into the 90's. In 1991, while Deputy Chief of Staff for Mayor Richard Daley, Jarrett hired Michelle Robinson, then engaged to Barack Obama and she was assigned to finance department.

Valerie Jarrett ran the finances for Barack Obama's 2004 Senate bid and served as treasurer of Obama's HOPEFUND. Marilyn Katz worked with Students for a Democratic Society. She is a personal friend of Jarrett's. Remember her for later. Part 3: Importance of \$100M Mark

This is a general limit of funding and appropriation that does not need congressional approval.

I don't have a hard link to the specific parts of US Code, but two specific House resolutions point to this limit - both suspiciously worked on in 2015 as a way to bring more accountability.

HR 427 (<https://www.congress.gov/bill/114th-congress/house-bill/427>)

Why this is highly suspicious and probably illegal. \$100M is a limit that needs congressional approval, but splitting the larger transaction into smaller ones that escape scrutiny is an illegal act for a private company under Sarbanes-Oxley and other Generally Accepted Accounting Principles. Unsure if it's illegal for the gov't, however it's very suspicious and unethical.

That's now coming to light.

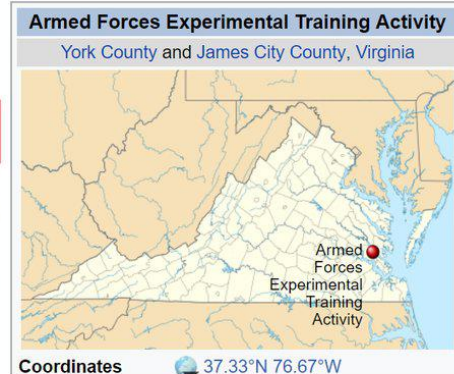

Camp Peary is an approximately 9,000 acre U.S. military reservation in York County near Williamsburg, Virginia. Officially referred to as an **Armed Forces Experimental Training Activity (AFETA)** under the authority of the Department of Defense, Camp Peary hosts a covert CIA training facility known as "The Farm", which is used to train officers of the CIA's Directorate of Operations, as well as those of the DIA's Defense Clandestine Service,^[1] among other intelligence entities. Camp Peary has a sister facility, "The Point", located in Hertford, North Carolina.

Porto Bello, the historic hunting lodge of Lord Dunmore, last royal governor of Virginia, is listed on the National Register of Historic Places and is located on the grounds of Camp Peary.

Special Prosecutor Tapped by Sessions to Investigate FISA Abuses HAS NOT Interviewed Bruce Ohr

In March, Attorney General Jeff Sessions announced he would not be appointing a second special counsel to investigate crimes committed by Obama's FBI and DOJ.

Bruce Ohr arrived at Capitol Hill Tuesday morning for a closed-door grilling from House Oversight and House Judiciary members over his contacts with dossier author Christopher Steele.

GOP lawmakers said Tuesday afternoon that Bruce Ohr was being cooperative and answering questions at the closed-door deposition.

Bruce Ohr, former FBI lawyer Lisa Page and Fusion GPS co-founder Glenn Simpson may be called back to testify together to iron out the discrepancies in their testimonies.

What exactly is Mueller and Huber doing if they are not questioning key players like Bruce Ohr??

Mueller's investigation into Russian "collusion" appears to be designed not to protect the country but to protect his former FBI/DOJ regime and their political espionage crimes, says Sperry.

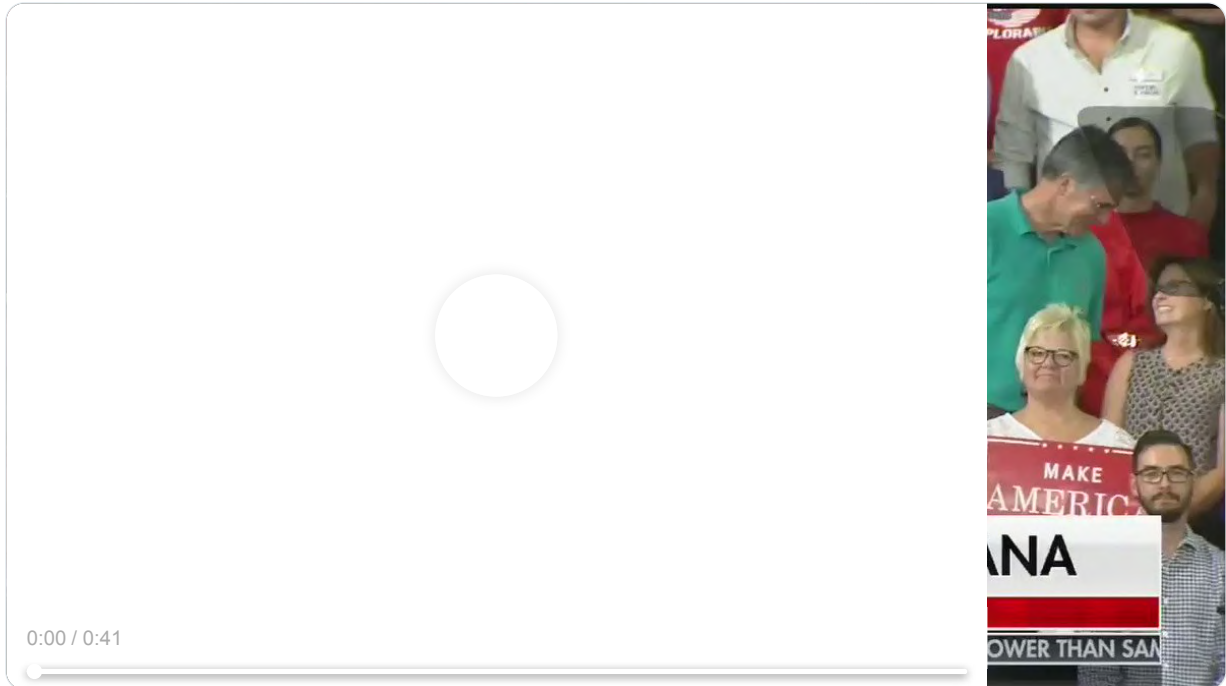

Dear Chairman Nunes:

I write in response to your letter of February 7, 2018, in which you request that the Foreign Intelligence Surveillance Court confirm whether “transcripts of relevant FISC hearings associated with” matters described in the letter exist and, if so, provide copies to the Committee. As you know, any such transcripts would be classified. It may also be helpful for me to observe that, in a typical process of considering an application, we make no systematic record of questions we ask or responses the government gives.

The Court appreciates the interest of the House Intelligence Committee in its operations and public confidence therein. Before 2018, the Court had never received a request from Congress for documents related to any specific FISA application. Thus, your requests – and others I have recently received from Congress – present novel and significant questions. The considerations involve not only prerogatives of the Legislative Branch, but also interests of the Executive Branch, including its responsibility for national security and its need to maintain the integrity of any ongoing law enforcement investigations.

While this analysis is underway, you may note that the Department of Justice possesses (or can easily obtain) the same responsive information the Court might possess, and because of separation of powers considerations, is better positioned than the Court to respond quickly. (We have previously made clear to the Department, both formally and informally, that we do not object to any decision by the Executive Branch to convey to Congress any such information.)

FISA Title I and III provisions relate to the conduct of electronic surveillance and physical searches for foreign intelligence purposes of persons, facilities, or property **inside** the United States.

- FISA Title I provides for **electronic surveillance** of persons within the United States.
- FISA Title III provides for **physical searches** of premises or property within the United States.

FISA Title I and Title III surveillance require there be probable cause to believe **the proposed target is a foreign power or an agent of a foreign power** and that the facility (can be a phone number) or place is – or is about to be – used by that target.

FISA Title I and III surveillance require formal approval from the Foreign Intelligence Surveillance Court (FISC) – also known as the FISA Court.

Carter Page, a U.S. citizen, was surveilled under FISA Title I. The FBI used the Steel Dossier to portray Page as “an agent of a foreign power” – specifically Russia – to the FISA Court.

The FBI obtained one initial FISA warrant on Carter Page and three subsequent renewals from the FISA Court.

The **House Memo** specifically noted that Page’s FISA order was not under Title VII of the **Foreign Intelligence Surveillance Act** – which is how we first knew Page had been surveilled under FISA Title I.
