I'll begin with a letter from a missionary to France who asked me to share this with the [#Qanon](#) team.

LETTER TO Q A word of Thanks:

I am very grateful for the extraordinary work of the Q team – and the commentaries explaining the posts – for personal reasons: I came to France as a missionary over 30 years ago.

I took French nationality got a job as a State teacher, got involved in (right-wing politics). There was a write-up about me in the early 2000s on the Internet as being the national secretary of a right-wing political party. This obviously was nonsense: I wasn't that high up, I was just an honorary member. The person who was campaigning to be President liked me and had me accompany him with a small group of people when he campaigned in my region. It sort of went viral at least in the national education system.

In Reims, a town of a quarter of a million I couldn't walk into a Post Office or most other places without being ill-treated or scomed. The harassment and, finally persecution in the school where I worked got to the point where I feared for my sanity and sometimes for my life. I spare you the details. This went on for decades. I moved to a country town in 2016 but it started again, worse. Finally, I officially retired end of March 2018 and got a job as an independent realtor.

This person (or group) Q has brought so much healing to my life over the past few weeks.

The hardest thing to bear in the persecution was that Christian friends, even Pastors, would not believe me and treated me as if I was mad (as in paranoid.) And yet the way teachers and parent associations are manipulated - Saul Alinsky style - is clearly outlined in many articles on the Internet:

It is certain that anyone involved in psychological warfare or indeed having faced the extreme left-wing would have no difficulty in believing me. I imagined talking to the Q character, let's say General Flynn for argument. It seemed so real I started to freak out just trying to talk to someone about my professional life of the last 20 years. I was embarrassed – afraid I was going to hyperventilate or sob and so I stopped. Then I realized how much I was really still traumatized about it all as God had already told me.

I am healing as I watch the info on Qpub which ranges from hair-raising "we are watching you / do you feel safe..." to hilarious: "the police are now investigating..." So THANK YOU Q Anon whoever you are. I hope to meet you one day (whoever was doing the most posts) and thank you personally.

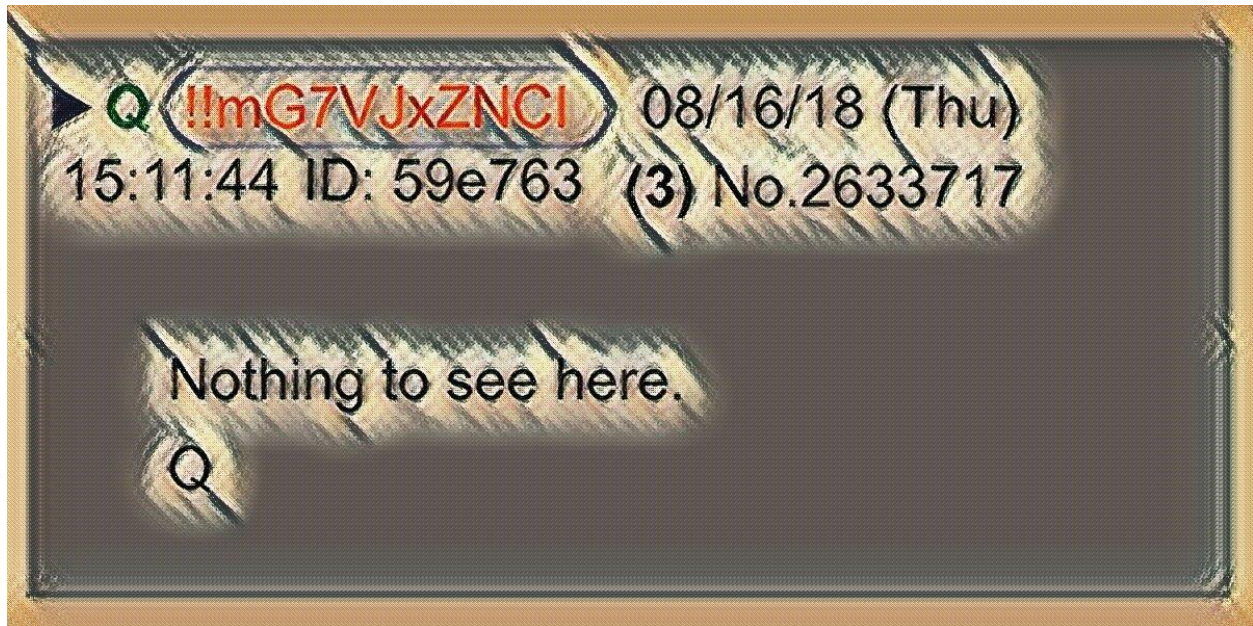

The U.S. government has been criticized for allowing Pakistan to channel a disproportionate amount of its funding to the controversial Hekmatyar,^[55] who Pakistani officials believed was "their man".^[56] Hekmatyar has been criticized for killing other *mujahideen* and attacking civilian populations, including shelling Kabul with American-supplied weapons, causing 2,000 casualties. Hekmatyar was said to be friendly with Osama bin Laden, founder of al-Qaeda, who was running an operation for assisting "Afghan Arab" volunteers fighting in Afghanistan, called *Maktab al-Khadamat*. Alarmed by his behavior, Pakistan leader General Zia warned Hekmatyar, "It was Pakistan that made him an Afghan leader and it is Pakistan who can equally destroy him if he continues to misbehave."^[57]

The CIA and State Department have been criticized for their direct relationship with Hekmatyar, beyond ISI contact,^{[37][38]} in spite of his being one of the leading heroin smugglers in the region.^[58]

In the late 1980s, Pakistani prime minister Benazir Bhutto, concerned about the growing strength of the Islamist movement, told President George H. W. Bush, "You are creating a Frankenstein."^[59]



Critics assert that funding the mujahideen played a role in causing the September 11 attacks.

However Sir Martin Ewans noted that the Afghan Arabs "benefited indirectly from the CIA's funding, through the ISI and resistance organizations,"^[62] and that "it has been reckoned that as many as 35,000 'Arab-Afghans' may have received military training in Pakistan at an estimated cost of \$800 million in the years up to and including 1988."^[63]

Some of the CIA's greatest Afghan beneficiaries were Arabist commanders such as

Haqqani and Hekmatyar who were key allies of bin Laden over many years.^{[64][65]}

Haqqani—one of bin Laden's closest associates in the 1980s—received direct cash payments from CIA agents, without the mediation of the ISI. This independent source of funding gave Haqqani disproportionate influence over the mujahideen.^[44] Haqqani and his network played an important role in the formation and growth of al Qaeda, with Jalaluddin Haqqani allowing bin Laden to train mujahideen volunteers in Haqqani territory and build extensive infrastructure there.^[66]

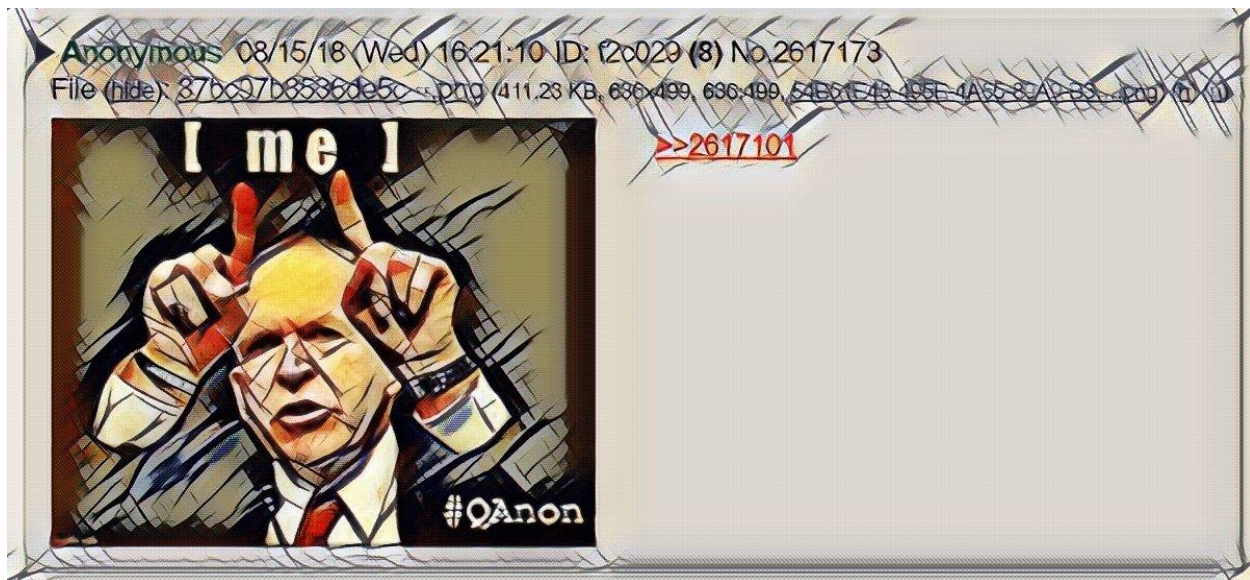
Here are the compiled lists of Asian American and Muslim American candidates for top Administration jobs, sub-cabinet jobs, and outside boards/agencies/policy committees. A couple things to note about the list of Muslim American candidates:

1) In the candidates for top jobs, I excluded those with some Arab American background but who are not Muslim (e.g., George Mitchell). Many Lebanese Americans, for example, are Christian. In the last list (of outside boards/commissions), most who are listed appear to be Muslim American, except that a handful (where noted) may be Arab American but of uncertain religion (esp. Christian).

2) There is only one candidate I thought was a viable one for a Secretary-level job among the Muslim Americans. That said, on both lists, there are some very senior people listed in the last category (for outside boards/commissions) who conceivably could be considered for top jobs. The very senior people I put on the last list tended not to be terribly involved in politics or policy, or in the case of some Asian Americans, had already served in the Clinton and even Carter Administrations and so I

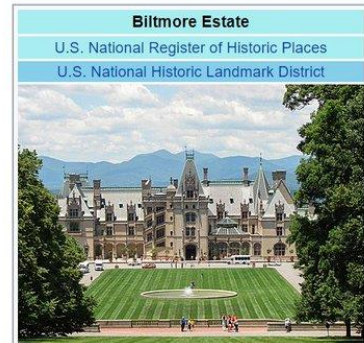

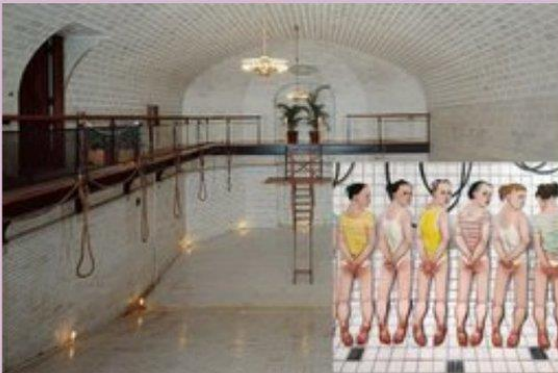
