

Senate report slams Bidens for conflicts of interest, flags possible criminal activity

Suspicious Activity Reports flagged millions of dollars in transactions from the Ukrainian gas company Burisma Holdings, a Russian oligarch named Yelena Baturina, and Chinese businessmen with ties to Beijing's communist government

"The Treasury records acquired by the Chairmen show potential criminal activity relating to transactions among and between Hunter Biden, his family, and his associates with Ukrainian, Russian, Kazakh and Chinese nationals," the 87-page report disclosed,

The report, citing U.S. government records, also raised concerns about possible ties to sex and human trafficking rings. "Hunter Biden paid nonresident women who were nationals of Russia or other Eastern European countries and who appear to be linked to an Eastern European prostitution or human trafficking ring," the report said.

An attorney for Hunter Biden has yet to respond to a emailed request for comment.

Senate Homeland Security and Governmental Affairs Committee Chairman Ron Johnson told Just the News Wednesday morning that the sheer volume of suspicious activity in Hunter Biden's foreign business dealings left the Vice President vulnerable to illicit influence or extortion.

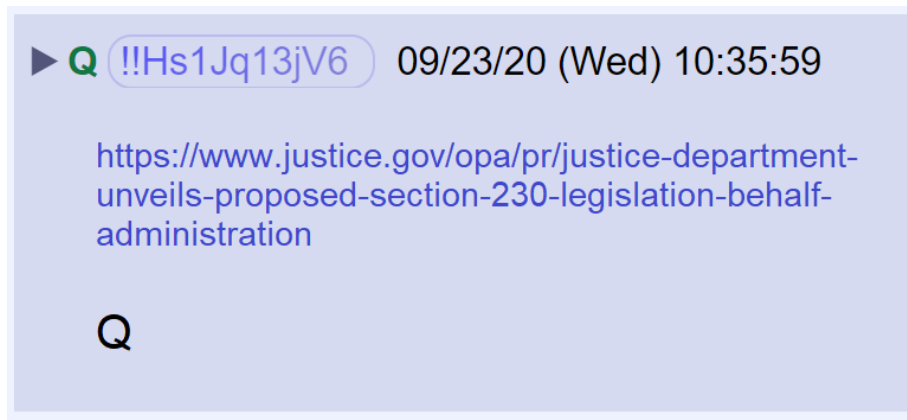

The Justice Department Unveils Proposed Section 230 Legislation on Behalf of the Administration

Today, on behalf of the Trump Administration, the Department of Justice sent draft legislation to Congress to reform Section 230 of the Communications Decency Act. The draft legislative text implements reforms that the Department of Justice deemed necessary in its [June Recommendations](#) and follows a yearlong review of the outdated statute. The legislation also executes President Trump's directive from the Executive Order on Preventing Online Censorship.

"For too long Section 230 has provided a shield for online platforms to operate with impunity," said Attorney General William P. Barr. "Ensuring that the internet is a safe, but also vibrant, open and competitive environment is vitally important to America. We therefore urge Congress to make these necessary reforms to Section 230 and begin to hold online platforms accountable both when they unlawfully censor speech and when they knowingly facilitate criminal activity online."

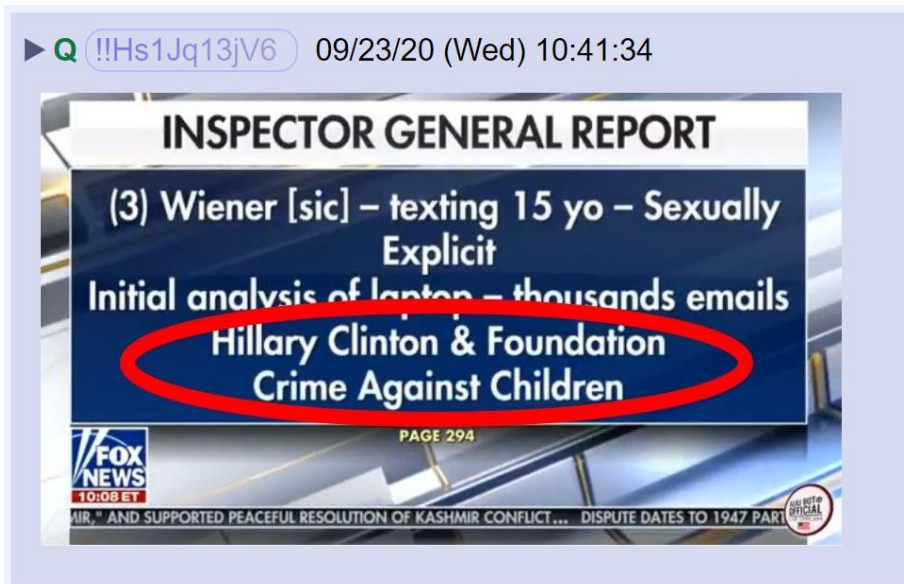
"The Department's proposal is an important step in reforming Section 230 to further its original goal: providing liability protection to encourage good behavior online," said Deputy Attorney General Jeffrey A. Rosen. "The proposal makes clear that, when interactive computer services willfully distribute illegal material or moderate content in bad faith, Section 230 should not shield them from the consequences of their actions."

The Department of Justice is grateful to all the experts, victims' groups, academics, businesses, and other stakeholders that have and continue to engage closely with the department during this process. The draft legislation reflects important and helpful feedback received thus far. The department is also grateful to our colleagues in Congress for their support on Section 230 reform and looks forward to continued engagement moving forward.

The Department of Justice's draft legislation focuses on two areas of reform, both of which are, at minimum, necessary to recalibrate the outdated immunity of Section 230.

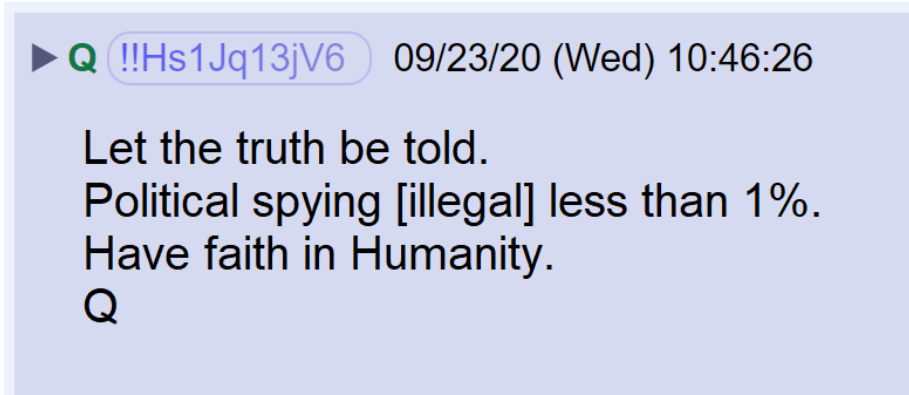

New York Post excerpt:

The report says that Hunter Biden “has sent funds to non-resident alien women in the United States who are citizens of Russia and Ukraine and who have subsequently wired funds they have received from Hunter Biden to individuals located in Russia and Ukraine.”

“The records note that some of these transactions are linked to what ‘appears to be an Eastern European prostitution or human trafficking ring.’”

The allegations are found in a footnote to a section of the report that details potential “criminal concerns and extortion threats” involving Hunter Biden and other members of the Biden family.

The report also cites “extensive public reporting concerning Hunter Biden’s alleged involvement with prostitution services.”

“Records on file with the Committees do not directly confirm or refute these individual reports,” the report says. However, they do confirm that Hunter Biden sent thousands of dollars to individuals who have either:

- 1) been involved in transactions consistent with possible human trafficking;
- 2) an association with the adult entertainment industry; or
- 3) potential association with prostitution.”

Dear Hillary,

A serious situation has arisen in Albania which needs urgent attention at senior levels of the US government. You may know that an opposition demonstration in Tirana on Friday resulted in the deaths of three people and the destruction of property. There are serious concerns about further unrest connected to a counter-demonstration to be organized by the governing party on Wednesday and a follow-up event by the opposition two days later to memorialize the victims. The prospect of tens of thousands of people entering the streets in an already inflamed political environment bodes ill for the return of public order and the country's fragile democratic process.

I believe two things need to be done urgently:

1. Bring the full weight of the international community to bear on Prime Minister Berisha and opposition leader Edi Rama to forestall further public demonstrations and to tone down public pronouncements.
2. Appoint a senior European official as a mediator.

While I am concerned about the rhetoric being used by both sides, I am particularly worried about the actions of the Prime Minister. There is videotape of National Guard members firing on demonstrators from the roof of the Prime

Ministry. The Prosecutor (appointed by the Democratic Party) has issued arrest warrants for the individuals in question. The Prime Minister had previously accused the opposition of intentionally murdering these activists as a provocation.

After the tape came out deputies from his party accused the Prosecutor of planning a coup d'etat in collaboration with the opposition, a charge Mr. Berisha repeated today. No arrests have been made as of this writing.

The demonstration resulted from opposition protests over the conduct of parliamentary elections in 2009. The political environment has deteriorated ever since and is now approaching levels of 1997, when similar issues caused the country to slide into anarchy and violence. There are signs that Edi Rama's control of his own people is slipping, which may lead to further violence.

The US and the EU must work in complete harmony over this, but given Albania's European aspirations the EU must take the lead. That is why I suggest appointing a mediator such as Carl Bildt, Martti Ahtisaari or Miroslav Lajcak, all of whom have strong connections to the Balkans.

My foundation in Tirana is monitoring the situation closely and can provide independent analysis of the crisis.

WASHINGTON -- At a private meeting on Tuesday afternoon, George Soros, a longtime supporter of progressive causes, voiced blunt criticism of the Obama administration, going so far as to suggest that Democratic donors direct their support somewhere

other than the president.

The Hungarian-American financier was speaking to a small side gathering of donors who had convened in Washington D.C. for the annual gathering of the Democracy Alliance -- a formal community of well-funded, progressive-minded individuals and activists.

According to multiple sources with knowledge of his remarks, Soros told those in attendance that he is "used to fighting losing

battles but doesn't like to lose without fighting."

"We have just lost this election, we need to draw a line," he said, according to several Democratic sources. "And if this president can't do what we need, it is time to start looking somewhere else."

Michael Vachon, an adviser to Soros, did not dispute the comment, though he stressed that there was no transcript of a private gathering to check. Vachon also clarified that the longtime progressive giver was not referring to a primary challenge to the

president.

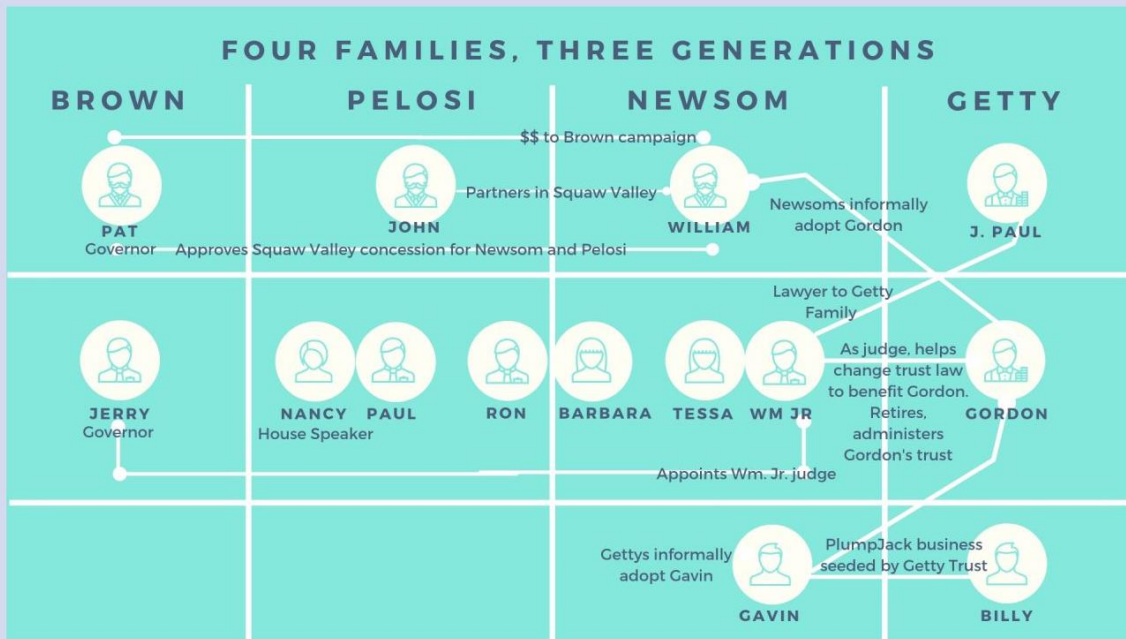
"Mr. Soros fully supports the president as the leader of the Democratic Party," said Vachon. "He was not suggesting that we seek another candidate for 2012. His comments were made in a private, informal conversation that was about the need for

Louville Kentucky streets are closed and the city remains under a 9 pm curfew after Kentucky's Attorney General announced that only one of the three police officers involved in the Breonna Taylor case will face charges.

Brett Hankison was indicted Wednesday on three counts of first-degree wanton endangerment, as a grand jury determined he place the lives of Taylor's neighbors at risk when he fired through a window into her apartment the night she was killed.

The other two officers who fired their weapons that night, will not be charged.

A 9 pm curfew is in effect through Friday.
