

House Speaker Nancy Pelosi on Monday blasted Facebook executives and employees as "totally disreputable" over the prevalence of posts touting the right-wing conspiracy-theory movement QAnon.

Pelosi made the comments in an interview with Kara Swisher on the first episode of "Sway," Swisher's new podcast with The New York Times.

In the interview, Swisher brought up QAnon, the far-right conspiracy-theory movement popular among some of President Donald Trump's supporters that claims a group of society's elite, including leaders in the Democratic party, are conspiring to commit a variety of heinous crimes such as child sex trafficking.

While QAnon is said to have originated on the anonymous online

Although Defense Secretary Esper has not given the official order yet, the Pentagon is making plans to decrease troop level to zero by May of 2021.

Official: Pentagon has started 'prudent planning' for full Afghanistan withdrawal by May

The Pentagon has started planning to have zero U.S. troops in Afghanistan by spring, though orders have not yet been issued for a full withdrawal, a Defense Department official said Tuesday.

"I'd like to make it clear that [Defense Secretary Mark Esper] has not issued orders to reduce military personnel below this 4,000 to 5,000 level in Afghanistan, although we are conducting prudent planning to withdraw to zero service members by May 2021 if conditions warrant, per the U.S.-Taliban agreement," David Helvey, the official performing the duties of assistant secretary of Defense for Indo-Pacific security affairs, told the House Oversight and Reform Subcommittee on National Security at a hearing.

Facebook has announced a plan to restrict the spread of messages on its platform if the November election causes civil unrest.

Facebook vows to restrict users if US election descends into chaos

Facebook has said it will take aggressive and exceptional measures to "restrict the circulation of content" on its platform if November's presidential election descends into chaos or violent civic unrest.

In an interview with the Financial Times, Nick Clegg, the company's head of global affairs, said it had drawn up plans for how to handle a range of outcomes, including widespread civic unrest or "the political dilemmas" of having in-person votes counted more rapidly than mail-in ballots, which will play a larger role in this election due to the coronavirus pandemic.

"There are some break-glass options available to us if there really is an extremely chaotic and, worse still, violent set of circumstances," Mr Clegg said, though he stopped short of elaborating further on what measures were on the table.

The proposed actions, which would probably go further than any previously taken by a US platform, come as the social media group is under increasing pressure to lay out how it plans to combat election-related misinformation, voter suppression and the incitement of violence on the November 3 election day and during the post-election period.
