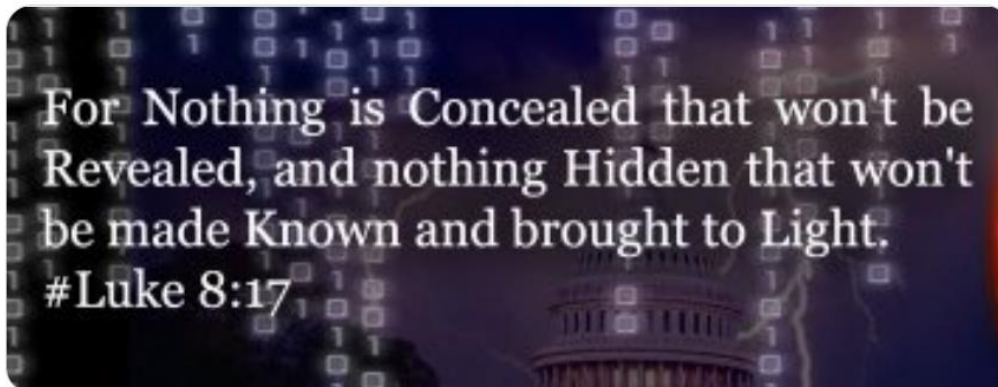

**B**oth of the White House assistant press secretaries, Chad Gilmartin and Karoline Leavitt, tested positive for COVID-19 over the weekend, according to a Reuters report published Monday.

That brings the total count of cases within Donald Trump's administration, including the president himself, to seven.

White House press secretary Kayleigh McEnany announced on Monday that she had tested positive for the virus.

Among those who have tested positive are Kayleigh MacEnany, Mike Lee, Ron Johnson, Ronna McDaniel, Kellyanne Conway, and Chris Christie.

## Intel Sources: CIA Director Gina Haspel Banking On Trump Loss To Keep Russiagate Documents Hidden

*Haspel is hoping Trump loses his re-election bid so she can run out the clock on Russiagate document declassifications, multiple intelligence community officials told The Federalist.*

Central Intelligence Agency (CIA) Director Gina Haspel is personally blocking the declassification and release of key Russiagate documents in the hopes that President Donald Trump will lose his re-election bid, multiple senior U.S. officials told The Federalist. The officials said Haspel, who served under former CIA Director John Brennan as the spy agency's station chief in London in 2016 and 2017, is concerned that the declassification and release of documents detailing what the CIA was doing during the 2016 election and the 2017 transition could embarrass the CIA and potentially even implicate Haspel herself.

"Haspel and [FBI Director Christopher] Wray both want Trump to lose, because it's the only chance they have of keeping their jobs," one senior intelligence official told The Federalist. "They're banking on Biden winning and keeping them where they are."

"It's far more important for Haspel to block any embarrassment of herself or her agency than to have full transparency and accountability," another senior intelligence official told The Federalist. "She's just hoping she can get past the election so the documents will never come out."

"This is not a source protection issue, it's an embarrassment issue," the intelligence official added.

Officials also accused Haspel of repeatedly lying to the White House about the status of documents that are in the pipeline for declassification and release. These officials said that Haspel has consistently provided baseless excuses for her failure to produce certain documents, falsely claiming that she can't physically locate documents, or that her agency doesn't technically own them and therefore cannot release them.

"Haspel has repeatedly lied to the president about the status of documents to be declassified," one intelligence community source said. "She will claim they don't know where they are, or which agency technically owns them, and then we'll find out she had them the entire time and just didn't want them to see the light of day."

Cardinal Giovanni Becciu is accused of using €700,000 of Vatican money to bribe witnesses to get a conviction against his rival, Cardinal George Pell.

Pell served as finance minister at the Vatican, where tried to clean up the Vatican Bank's money laundering operation. In 2017, he was convicted in Australia of sex crimes and began serving his sentence but a year later, Australia's highest court overturned his conviction.

Becciu is suspected of wiring the cash to recipients in Australia who helped to ensure hostile testimony in the trial. ## Sacked cardinal 'used Vatican funds to bribe witnesses in Pell trial'

A senior Catholic cardinal has been accused of using €700,000 (\$1.14m) of Vatican funds to bribe witnesses to secure a sex abuse conviction against a rival.

Italian media have reported that Cardinal Giovanni Angelo Becciu, 72, is suspected of wiring the cash to recipients in Australia who helped to ensure hostile testimony in the abuse trial of Cardinal George Pell, who was accused of molesting choir boys in Melbourne in the 1990s.

The scandal cast a shadow yesterday over the publication of a key Vatican document calling for a more caring and sharing society and denouncing the evils of war.

Before he returned to Australia in 2017 where he was tried, jailed and acquitted on appeal, [Cardinal Pell](#), 79, served as finance minister at the Vatican, where his attempts to clean up opaque accounting were opposed by Cardinal Becciu.

Quoting leaked documents, the Italian newspapers La Repubblica and Corriere della Sera reported at the weekend that Vatican investigators suspect that [Cardinal Becciu](#) hoped to use the money to definitively derail Cardinal Pell's transparency program, which threatened to expose Cardinal Becciu's allegedly corrupt management of Vatican cash.

Cardinal Becciu issued a strongly worded denial of the reports, stating: "I categorically deny interfering in any way in the trial of Cardinal Pell."
