- Curating a list of organizations that specialize in supporting victims and aid for emergency services such as legal and financial assistance
- Developing greater levels of support internally for employees in need and for their client partners

According to The Institute for Urban Policy Research At The University of Texas at Dallas, in 2015 an average of 630 callers to Dallas shelters each month are denied service due to a lack of space. The mission at Families to Freedom is to provide survivors of domestic violence free long-distance transportation to reunite with family or get to shelter far away. The organization is working with ten area shelters, hospitals, and various police departments.
