Adam Schiff claims Hunter Biden email stories come 'from the Kremlin'

'We know that this whole smear on Joe Biden comes from the Kremlin.'

House Intelligence Committee Chairman [Adam Schiff](#) on Friday described revelations from a slew of emails in a laptop allegedly belonging to [Hunter Biden](#) as being part of a smear coming "from the Kremlin" -- amid claims the revelations are part of a Russian disinformation campaign.

"We know that this whole smear on Joe Biden comes from the Kremlin," Schiff said on [CNN](#). "That's been clear for well over a year now that they've been pushing this false narrative about this vice president and his son."

The California Democrat was responding to questions about the [origins of emails](#), found on a laptop purported to belong to the son of Democratic nominee Joe Biden, and first reported by the New York Post.

Those emails reveal that Hunter Biden purportedly introduced his father to a top executive at Ukrainian energy company Burisma Holdings in 2015, while another appears to reportedly outline a payout for Biden as part of a deal with a [Chinese](#) energy firm.

While Fox News has not independently verified the Post's reporting, [Fox has spoken to one of the people](#) who was copied on the email about the Chinese energy firm, who confirmed its authenticity.

Biden went around bragging that he stopped the prosecution so if you can look into it... It sounds horrible to me."

Technology once used to combat ISIS propaganda is enlisted by Democratic group to counter Trump's coronavirus messaging

A new Democratic-aligned political action committee advised by retired Army Gen. Stanley McChrystal, the former head of U.S. forces in Afghanistan, is planning to deploy technology originally developed to counter Islamic State propaganda in service of a domestic political goal — to combat online efforts to promote President Trump's handling of the [coronavirus](#) pandemic.

The group, Defeat Disinfo, will use artificial intelligence and network analysis to map discussion of the president's claims on social media. It will seek to intervene by identifying the most popular counter-narratives and boosting them through a network of more than 3.4 million influencers across the country — in some cases paying users with large followings to take sides against the president.

The initiative reflects fears within the Democratic Party that Trump's unwavering digital army may help sustain him through the pandemic, as it has through past controversies, even as the economy craters, tens of thousands have died, and Trump suffers in the polls.

Hunter Biden also had business dealings in Kazakhstan: report

Hunter Biden is facing fresh questions over business dealing in yet another nation — Kazakhstan.

Between 2012 and 2014 — when his father Joe Biden served as Vice President — Hunter Biden worked as a go-between to Kenes Rakishev, a Kazakh oligarch with close ties to the country's longtime kleptocratic leader Nursultan Nazarbayev, [The Daily Mail reported](#).

The British tabloid said they obtained emails from “anti-corruption campaigners” in Kazakhstan showing Hunter making contact with Rakishev and attempting to facilitate investment for his cash in New York, Washington DC and a Nevada mining company.

Through his connections, emails show Hunter Biden successfully engineered a \$1 million investment from Rakishev to filmmaker Alexandra Forbes Kerry — the daughter of ex-Sen. and former Democratic presidential nominee John Kerry, the report said.

The Text and History of the Foreign Emoluments Clause



America’s Founders believed that corruption and foreign influence were among the gravest threats to our nation. As a result, they included in our Constitution the **Foreign Emoluments Clause**. Written in sweeping and unqualified language, the Clause was designed to prevent these two evils from affecting the federal government. This document explores the text and history of the Clause, providing statements from the Founders themselves and the Department of Justice’s Office of Legal Counsel, which among other things provides “legal advice to the Executive Branch on all constitutional questions.”¹

Text of the Foreign Emoluments Clause, U.S. Const. art. I, § 9, cl. 8.

“No Person holding any Office of Profit or Trust under [the United States], shall, without the Consent of the Congress, accept of any present, Emolument, Office, or Title, of any kind whatever, from any King, Prince, or foreign State.”

The Founders Feared a Corrupt Government

Because the Founders believed that corruption was one of the gravest threats to our nation, they viewed anti-corruption measures as essential to preserving an enduring democracy.

- Reflecting common sentiment at the Constitutional Convention, George Mason warned his fellow delegates that “if we do not provide against corruption, our government will soon be at an end.”² Thus, in drafting the Constitution, the Founders sought to ensure that “corruption was more effectually guarded against, in the manner this government was constituted, than in any other that had ever been formed.”³ Alexander Hamilton explained that “[n]othing was more to be desired than that every practicable obstacle should be opposed to cabal, intrigue, and corruption.”⁴
- According to James Madison’s notes of the Convention, fifteen delegates used the word “corruption” more than fifty times,⁵ and corruption was a topic of discussion on almost a quarter of the days that the Convention was in session.⁶

The Founders wanted to ensure that in the United States, unlike in Europe, the nation’s leaders would be dependent on the people alone—not on those offering financial benefits—and would be motivated solely by the national interest, not their own personal interests.

- To promote that goal, the Founders included in the nation’s new charter a number of safeguards against corruption. These safeguards took the form of “procedural devices and organizational arrangements” meant to ward off “dependency, cabals, patronage, unwarranted influence, and bribery.”⁷

Source on alleged Hunter Biden email chain verifies message about Chinese investment firm

Sources have told Fox News that 'the big guy' is a reference to the former vice president.

One of the people on an explosive email thread allegedly involving Hunter Biden has corroborated the veracity of the messages, which appear to outline a payout for [former Vice President Joe Biden](#) as part of a deal with a [Chinese](#) energy firm.

One email, dated May 13, 2017, and obtained by Fox News, includes a discussion of "remuneration packages" for six people in a business deal with a Chinese energy firm. The email appeared to identify Hunter Biden as "Chair / Vice Chair depending on agreement with CEFC," in an apparent reference to now-bankrupt CEFC China Energy Co.

The email includes a note that "Hunter has some office expectations he will elaborate." A proposed equity split references "20" for "H" and "10 held by H for the big guy?" with no further details. Fox News spoke to one of the people who was copied on the email, who confirmed its authenticity.

Sources told Fox News that "the big guy" is a reference to the former vice president. The New York Post initially published the emails and other controversial messages that Fox News has also obtained.

The Bidens' relationship with Ukraine came under special attention last year as House Democrats pursued an impeachment inquiry surrounding President Trump's now-infamous July 25 call with Ukraine's president. In it, Trump asked President Volodymyr Zelensky to investigate the former vice president, who was suspected of abusing his authority to pressure the government into firing its top prosecutor.

Another email from May of 2014 shows Vadym Pozharskyi, an adviser to Burisma's board, allegedly shows him asking for the younger Biden's advice on how to stop "politically motivated actions."

Court reinstates fraud conviction for Hunter Biden business partner

Devon Archer was convicted of defrauding the Oglala Sioux Indian tribe out of bond-sale proceeds.

A federal appeals court reinstated the fraud conviction of Hunter Biden's former business partner on Wednesday, reversing a lower court judge who had granted his request for a retrial.

Hunter Biden was not implicated in the scheme, which defrauded the Oglala Sioux Indian tribe out of the proceeds of bond sales. But the scheme was committed under the auspices of a broader business venture in which Hunter Biden was involved, and the perpetrators invoked his name to bolster their legitimacy, according to testimony and a consultant's slide presentation presented at trial. A lawyer for Hunter Biden [has said](#) his name was invoked without his knowledge and that he cut ties with the perpetrators when he learned of their misconduct.

Devon Archer, whose conviction was reinstated by Wednesday's ruling, had partnered with Hunter Biden in Rosemont Seneca, a Washington-based investment firm. Starting in 2014, the pair served together on the board of Burisma, a Ukrainian natural gas company accused of corruption, at the same time that his father oversaw U.S. policy towards Ukraine. Hunter Biden has called his decision to take the board seat "a mistake," while Joe Biden has defended the decision, saying, "my son did nothing wrong."

A lawyer for Archer, Matthew Schwartz, decried the ruling by the Second Circuit Court of Appeals. "As the experienced federal judge who presided over Mr. Archer's month-long trial determined, he 'lacked the requisite intent and is thus innocent of the crimes charged,'" Schwartz said. "Today's ruling, which second-guesses that judge's decision without having sat through the evidence and listened to the witnesses, is beyond disappointing."

Archer was convicted in June 2018 of securities fraud and conspiracy to commit securities fraud, but five months later, trial Judge Ronnie Abrams of the Southern District of New York [overturned](#) the conviction.

WASHINGTON (AP) — A federal judge who is married to a new member of Robert Mueller's investigative team has stepped aside from lawsuits involving President Donald Trump and his business empire, court records show.

Greg Andres, a New York lawyer and former Justice Department prosecutor who specialized in foreign bribery and fraud, has joined the team of lawyers investigating potential coordination between Russia and the Trump campaign, a spokesman for the group said Wednesday.

Andres is married to Ronnie Abrams, a federal judge in Manhattan, who presided over lawsuits that accused Trump of violating the Constitution's emoluments clause by letting his businesses accept money from foreign governments. One of the cases was brought by Citizens for Responsibility and Ethics in Washington, a legal nonprofit group that advocates for good government, and another was brought by New York attorney William Weinstein.

Court entries from last month show that cases have been reassigned to another judge, George Daniels. No reason was given and a call to Abrams' chambers was referred to a spokesman for the court, who confirmed that Abrams had recused herself from the CREW matter under a section of the U.S. code that deals with judicial procedure.

- Greg Andres started on Tuesday, becoming the 16th lawyer on the team, said Josh Stueve, a spokesman for the special counsel.

Most recently a white-collar criminal defense lawyer with New York law firm Davis Polk & Wardwell, Andres, 50, served at the Justice Department from 2010 to 2012. He was deputy assistant attorney general in the criminal division, where he oversaw the fraud unit and managed the program that targeted illegal foreign bribery.

Mueller, who was appointed special counsel in May, is looking into possible collusion between the Trump campaign and Russia during the election, among other matters. Congressional committees are also investigating the matter.

That Mueller continues to expand his team means the probe is not going to end anytime soon, said Robert Ray, who succeeded Kenneth Starr as independent counsel for the Whitewater investigation during the Clinton administration.

A new cast of characters emerged at [Wednesday's impeachment hearings](#) — including Alexandra Chalupa, a former Democratic National Committee contractor and staffer who dug for dirt on the Trump campaign with help from Ukrainian officials.

Chalupa, a Ukrainian American who calls herself a “human rights lobbyist,” made a cameo minutes into the opening statement of House Intelligence Committee ranking member Rep. Devin Nunes (R-Calif.) in which he railed against the Democrats’ [secretive impeachment process](#).

“Violating their own guidelines, Democrats repeatedly redacted from transcripts the name of Alexandra Chalupa, a contractor for the Democratic National Committee who worked with Ukrainian officials to collect dirt on the Trump campaign which she provided to the DNC and the Hillary Clinton campaign,” Nunes said.

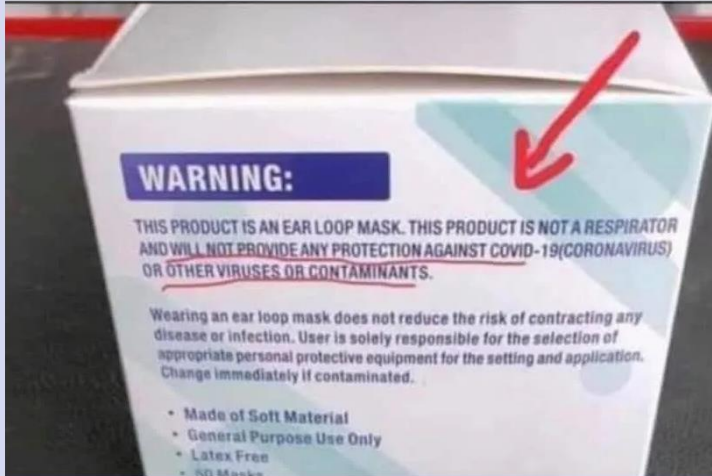
Chalupa is the founder of a Washington political consulting firm and is co-chair of the DNC’s Ethnic Council, which reaches out to diaspora groups around the country to increase voter turnout, [according to her LinkedIn](#).

But her most important role to date appears to be her [investigation into Paul Manafort](#), President Trump’s former campaign manager, and his ties with Russia — which she conducted with the help of Ukrainian officials.

The investigation provoked a firestorm in 2017 and prominent Republicans such as Sen. Chuck Grassley [publicly accused Chalupa](#) of working with Ukraine, the DNC and the Clinton campaign to undermine Trump’s candidacy.

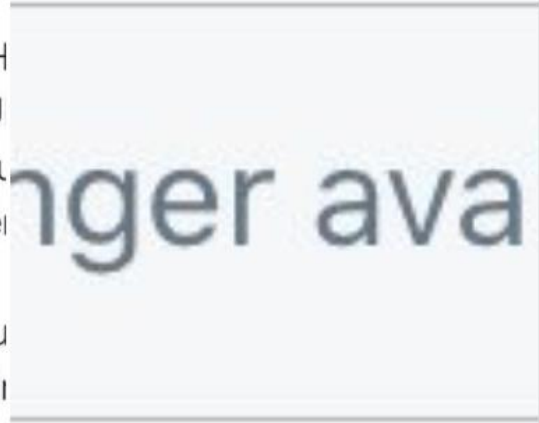

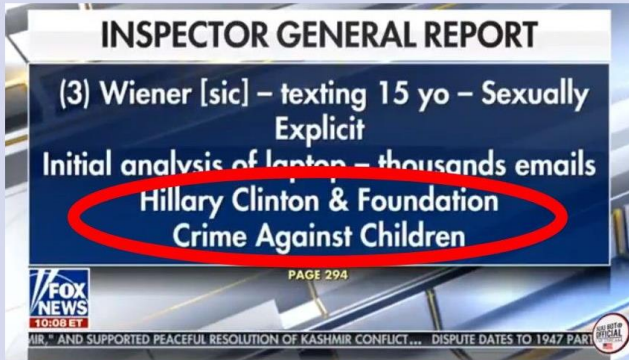

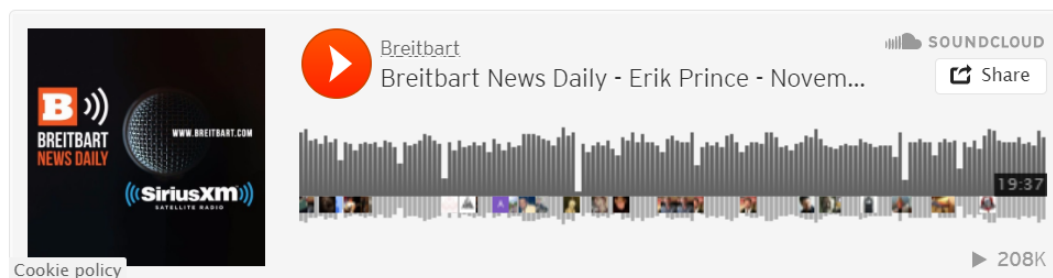

But report also said it could not confirm allegations

Among the deluge of explosive claims tucked [inside the new Senate Republican report about Hunter Biden’s business dealings](#) is the allegation that the Democratic presidential nominee’s son has a history of paying Russian or Eastern European women linked to sex trafficking.

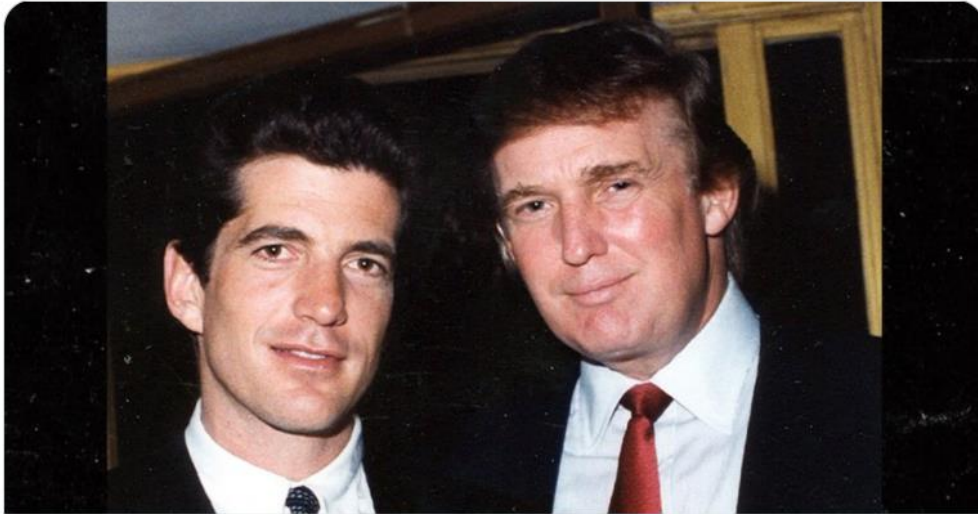

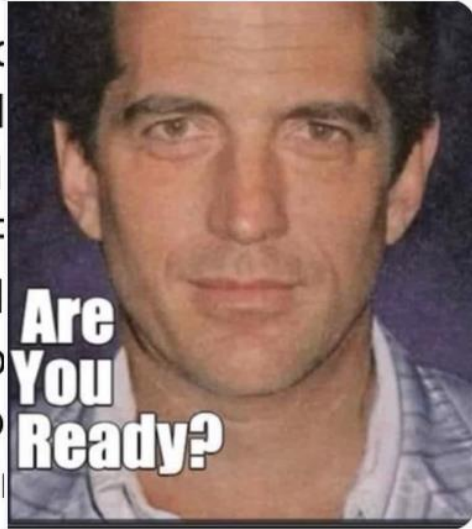
